SUMMARY

The Rotorcraft Dynamics Division, Aeroflightdynamics Directorate, U.S. Army Aviation Research and Technology Activity has developed the General Rotorcraft Aeromechanical Stability Program (GRASP) to perform calculations that will assess the stability of rotorcraft in hovering flight and ground contact conditions. The program is designed to be a state-of-the-art, hybrid, finite-element/multibody code that can be applied to all existing and future helicopter configurations. While GRASP was specifically designed to solve rotorcraft stability problems, its innovative structure and formulation allow for applications to a wide range of structures. This manual describes the preparation of the input file required by Version 1.03 of GRASP, the procedures used to invoke GRASP on the NASA Ames Research Center Cray X-MP 48 computer, and the interpretation of the output produced by GRASP. The parameters used by the input file are defined, and summaries of the input file and the job control language are included.

1. INTRODUCTION

The General Rotorcraft Aeromechanical Stability Program (GRASP) is a collection of computer programs designed to assess the stability of rotorcraft in hovering flight or ground contact. To make use of the features provided by GRASP, a user must be able to prepare a definition of the problem to be solved, execute the program, and interpret the output from the program.

The first step in using GRASP is the transformation of the problem to be solved from analytical terms into a format which the program can accept. Section 2 defines the formats of the files which must be provided to GRASP. These files specify the models and the solutions desired.

The second step is the execution of the GRASP programs. Section 3 defines the procedures for invoking GRASP.

The third step is the interpretation of the results in the format presented by GRASP in terms of the analytical problem. Section 4 describes the formats of the steady-state and eigensolution results.

2. PREPARING INPUT

This section describes the formats of the files which must be input to GRASP. These files specify the models and the solutions desired.

2.1. User Data

User Data is a hierarchically ordered collection of records (i.e., card images) consisting of up to 80 characters each. Blank characters may be placed before, be freely interspersed with, or may follow the characters defining any record. Every record begins with a keyword (or keywords since blanks are not relevant) that identifies the record. If the record contains data, an equals delimiter "=" follows the keyword, and the data are entered thereafter. In some cases, a semicolon terminator ";" must follow the data. On any line of the file, all characters following an exclamation point "!" are ignored. This feature may be used to insert comments in the input stream. Comments may not, however, be inserted in the middle of a record.

The data specified in a record may consist of one or more integer, real, or character constants, each separated from the next by a comma delimiter, ",". An integer constant consists of an optional sign (either a minus sign "-", or a plus sign "+") followed by one or more of the integers (0,...,9). A real constant consists of an integer constant subfield, an optional fraction subfield and an optional exponent. The fraction subfield consists of a decimal point "." followed by zero or more integers. The exponent consists of an optional exponent character "D" or "E", an optional sign (however, the sign is mandatory if the exponent character is omitted) and one to three integers. A character constant consists of any collection of characters of less than or equal to the specified length, delimited by apostrophes, "' " (blanks are relevant in the case of a character constant).

The overall hierarchical structure of the User Data file is outlined in Appendix A. The detailed requirements and meanings of each of the records are described below. The first record must be the key word:

BEGIN DATA

and the last record must be the key word:

END DATA

Three sets of records: "Configuration Data", "Control Data", and "Analysis Data" may appear in arbitrary order between the first and last records. These record sets are discussed in sections 2.1.1, 2.1.2, and 2.1.3, respectively.

2.1.1. Configuration Data

"Configuration Data" consists of no data or the following set of records:

The diagnostics level defines the level of error information to be printed. A diagnostics level of 1 prints warning and error messages. A level of 2 suppresses warning messages. A level of 0 dumps status information and the information manager tables, and prints error messages upon abnormal termination. The page length defines the number of lines to be printed on each page of output, while the page width defines the number of characters to be printed on each line. The run title is the title that will be placed on the opening and closing banner pages as well as at the top of each page of output. These records may appear in arbitrary order within the record set.

2.1.2. Control Data

“Control Data” controls the execution of GRASP and consists of the following ordered set of records:

The case definition consists of the case identifier, the case title, the number of directives, and a set of directives. The case identifier points to a BEGIN CASE DATA entry under “Data for Cases” (section 2.1.3). The case title defines the title that is placed in a message at the beginning and end of the case, and at the top of each page of output for that case. If the case title is defaulted, GRASP will print blank spaces.

“Directives” consists of the specified number of any of the following directives in the order in which they are to be executed:

The solve steady-state parameters include the model identifier MDLID, the steady-state problem parameters identifier SSPPAR, the name of the system model information structure MDLNAM, the name of the steady-state problem deformations information structure SSPDEF, the name of the steady-state problem residuals information structure SSPRSD, and the name of the steady-state problem solution information structure SSPSLN. The model identifier points to a BEGIN MODEL DEFINITION entry under "Model Definition" (section 2.1.3.2). The steady-state problem parameters identifier points to a BEGIN ZXSSQ DEFINITION entry under "Steady-state Problem Parameters" (section 2.1.3.1.1).

If the name of the system model is specified to be other than the default name, the system model will be printed immediately after the model building is complete. The system model is always automatically released when it is no longer needed by the directive. If the names of the steady-state problem deformations and residuals are not defined to be other than the default name, they are also released when they are no longer needed by the directive. If the name of the steady-state problem solution is not defined, it is automatically printed out, then released at the end of the directive. If the name is defined, it is neither printed nor released.

The solve asymmetric eigenproblem parameters include the model identifier MDLID, the asymmetric eigenproblem parameters identifier AEPPAR, the name of the system model information structure MDLNAM, the name of the reference deformations information structure REFDEF, the name of the reference residuals information structure REFRSD, the name of the asymmetric eigenproblem mass, damping, and stiffness matrices information structure AEPMTX, the name of the asymmetric eigenproblem intermediate solution information structure AEPISL, and the name of the asymmetric eigenproblem solution information structure AEPSLN. The model identifier points to a BEGIN MODEL DEFINITION entry under "Model Definition" (section 2.1.3.2). The asymmetric eigenproblem parameters identifier points to a BEGIN COMPLEX EIGEN DEFINITION entry under "Asymmetric Eigenproblem Parameters" (section 2.1.3.1.2). If the name of the system model is specified to be other than the default name, the system model will automatically be printed after the model is built.

If the name of the system model is specified to be other than the default name, the system model will be printed immediately after the model building is complete. The system model

is always automatically released when it is no longer needed by the directive. The names of the reference deformations and residuals correspond to the SSPDEF and SSPRSD entries for a SOLVE STEADY-STATE directive. If either of these names are not defined, this directive will not work. If the name of the asymmetric eigenproblem matrices is specified to be other than the default name, the matrices will be printed immediately after their assembly is complete. The matrices are also always automatically released when they are no longer needed by the directive. If the name of the asymmetric eigenproblem intermediate solution is not defined to be other than the default name, it is released when it is no longer needed by the directive. If the name of the asymmetric eigenproblem solution is not defined, it is automatically printed out, then released at the end of the directive. If the name is defined, it is neither printed nor released.

PRINT DATA SET

The only parameter for this directive is the name of the information structure to be printed, DSNAME.

RELEASE DATA SET

The only parameter for this directive is the name of the information structure to be released, DSNAME.

Note that the parameters may appear in arbitrary order on the same line as the directive, or on subsequent lines. For each directive, a semicolon must be used after the last parameter to terminate that directive. All information structure names must contain only alphabetic (A - Z) and numeric (0 - 9) characters. The use of the dollar sign is reserved for default names. Information structures whose names have been defaulted through the directive parameters may not be printed, saved, or released.

2.1.3. Analysis Data

“Analysis Data” consists of one or more of the following ordered sets of records:

"Solution Parameter Definitions" is the collection of information defining the conditions under which the selected solution methods are to be used. "Solution Parameter Definitions" consists of no data of the following ordered set of records:

"Steady-state Problem Parameters" is the collection of information that defines the parameters used in the steady-state equation solver (ZXSSQ), and consists of no data or the following ordered set of records:

The ZXSSQ identifier corresponds to either the ZXPID entry under "Aeroelastic Beam Definitions" (section 2.1.3.3.2a) or the SSPPAR entry for the SOLVE STEADY-STATE directive under "Control Data" (section 2.1.2). The definition consists of the convergence criterion for the number

of significant digits NSIG, the epsilon convergence criterion EPS, the delta convergence criterion DELTA, the maximum number of function evaluations MAXFN, the input options parameter IOPT, and the input parameters PARM. These records may appear in arbitrary order within the record set.

The number of significant digits convergence criterion is satisfied if, on two consecutive iterations, every component of the state vector agrees with the previous iteration to the specified number of digits. The epsilon criterion is satisfied if, on two consecutive iterations, the difference between the sum of the squares of the residuals from the two iterations is less than the specified value. The delta criterion is satisfied if the Euclidean norm of the gradient of the state vector is less than or equal to the specified value. Both epsilon and delta must be positive, real numbers. The maximum number of function evaluations defines an upper limit to the number of times that ZXSSQ may call the function evaluation routine. If the maximum number of function evaluations is set to zero, the program will not iterate to a solution. Instead, it will simply perform one function evaluation in order to calculate the residuals corresponding to the initial values of the state vector. If the input options parameter equals 0, Brown's algorithm without steepest descent will be used to find the minimum. If it equals 1, steepest descent and the default values for the input parameters will be used, while a value of 2 allows the user to select the parameters. The first input parameter is the initial value of the Marquardt parameter used to scale the diagonal of the transpose of the Jacobian (default = 0.01). The other three are the scaling factor used to modify the Marquardt parameter (default = 2.0), the upper bound for the Marquardt parameter (default = 120.0), and the value of the norm of the gradient of the sum of the squares of the residuals that determines when central rather than forward differencing is used to calculate the Jacobian (default = 0.1).

2.1.3.1.2. Asymmetric Eigenproblem Parameters .

"Asymmetric Eigenproblem Parameters" is the collection of information that defines the parameters used in the complex eigenvalue/eigenvector solution, and consists of no data or the following ordered set of records:

The complex eigenproblem parameters identifier corresponds to the AEPPAR entry for the SOLVE ASYMMETRIC EIGEN-PROBLEM directive under "Control Data" (section 2.1.2). The definition consists of the number of eigenvalues to be calculated NVAL, the number of eigenvectors

to be calculated NVEC, and the calculate performance index flag CALPRI. These records may appear in arbitrary order within the record set.

2.1.3.2. Model Identifier Definitions

“Model Identifier Definitions” is the collection of information defining the field and system organization identifiers for each model to be analyzed. “Model Identifier Definitions” consists of no data or the following ordered set of records:

The model identifier corresponds to one of the MDLID entries defined under the directives in “Control Data” (section 2.1.2). The identifiers for air density, gravity, and inertial motion point to the BEGIN AIR DENSITY DEFINITION, BEGIN GRAVITY DEFINITION, and BEGIN INERTIAL MOTION DEFINITION entries respectively, under “Field Parameters” (section 2.1.3.3.4); while the identifier for system organization points to the BEGIN SYSTEM DEFINITION entry under “System Organization” (section 2.1.3.3.1a). These records may appear in arbitrary order within this record set.

2.1.3.3. Model Parameter Definitions

“Model Parameter Definitions” is the collection of information defining all of the parameters that are needed to completely describe every model that will be analyzed. “Model Parameter Definitions” consists of no data or the following ordered set of records:

The definition of a subsystem consists of the parent subsystem name PSSNAM, the subsystem name SBSNAM which is the name of this subsystem, the subsystem type SBSTYP, the subsystem identifier SBSID, and the subsystem constraint set identifier CNSSID. These records may appear in arbitrary order within a record set.

The parent subsystem name refers to the SBSNAM entry in the definition of the parent subsystem. For the first subsystem in a system definition, the parent subsystem name may be defined as PSSNAM = ' ', since the name of the parent of the first subsystem is automatically defined to be the same as the MDLNAM entry from the directive associated with that model (section 2.1.2). The subsystem type identifies the type of subsystem being defined. If SBSTYP = 'AEBEAM', the subsystem identifier points to the BEGIN AE BEAM DEFINITION entry under "Aeroelastic Beam Definitions" (section 2.1.3.3.2a). If SBSTYP = 'AIRMAS', the subsystem identifier points to the BEGIN AIR MASS DEFINITION entry under "Air Mass Definitions" (section 2.1.3.3.2h). If SBSTYP = 'RBMASS', the subsystem identifier points to the BEGIN RB MASS DEFINITION entry under "Rigid-body Mass Definitions" (section 2.1.3.3.2j). If SBSTYP = 'SYSTEM', the subsystem identifier points to a BEGIN SS NODE DEFINITION SET entry under "Node Definitions for Subsystem" (section 2.1.3.3.1b) and to an ANDNAM entry under "Definition of Air Node i" (section 2.1.3.3.1c). The constraint set identifier points to a BEGIN SUB-SYSTEM CONSTRAINT SET entry under "Subsystem Constraint Sets" (section 2.1.3.3.1d).

If the subsystem identifier is defaulted, GRASP will construct its system model assuming that there are no structural nodes or air nodes defined for the subsystem. This default is only valid for system-type subsystems.

2.2. User Input File

The records which are specified in User Input override those parameters defined under "Configuration Data" (section 2.1.1) in User Data. Typically, User Input is placed at the end of the user's runstream (section 3), while User Data is a separate input file. The user can thus use User Input to change the format of the output (e.g., page width and length), the title of the run, or the level of error information to be printed in one run, without having to change the definitions in User Data.

The first record in User Input must be the keyword:

The page length defines the number of lines to be printed on each page of output, while the page width defines the number of characters to be printed on each line. The run title is the title that will be placed on the opening and closing banner pages as well as at the top of each page of output. If any single record is omitted, GRASP will use the default value specified

in User Data (section 2.1.1). If the User Input file is omitted completely, all of the values will be defaulted.

3. RUNNING GRASP

Solving problems using GRASP is accomplished by running two programs. First, the Build GRASP Input (BLDINP) program is run to convert a user-defined User Data file into the computer-oriented Input Data file. Then the GRASP program is run to produce the solutions to the problems specified by the user. The Input Data file must be the same in both programs and must not exist prior to its creation in BLDINP or be modified between its creation in BLDINP and its use in GRASP.

The procedures for invoking BLDINP and GRASP are installation dependent. The information supplied in this subsection applies specifically to the environment at the Aeroflightdynamics Directorate, which is collocated with the NASA Ames Research Center. In this environment, BLDINP, GRASP, and the associated libraries are resident on a Cray X-MP 48 computer operating under COS 1.14, which communicates with the Aeroflightdynamics Directorate VAX 11-785. A sample runstream for sequentially executing BLDINP and GRASP is included in Appendix C.

3.1. Invoking Build GRASP Input

The first step in invoking BLDINP is to gain access to the subroutines that are needed to run the program. The subroutines are resident in Cray libraries named BINPLIB (BLDINP main program and subroutines), ERRMLIB (Error Manager), INFMLIB (Information Manager), and UTILLIB (Utilities). The COS commands required to access these libraries are:

ACCESS,DN=INFMLIB,PDN=INFMLIB,ID=GRASPLIB.  
ACCESS,DN=UTILLIB,PDN=UTILLIB,ID=GRASPLIB.
```

Next, the User Data file, which is stored on a remote VAX, must be obtained and, if desired, copied onto the output file. If User Data is copied, it must also be rewound. The COS commands required to get the file, then copy and rewind it are:

```
FETCH,DN=USRDAT,TEXT='$DISK filename.DAT'.  
COPYS,I=USRDAT,O=$OUT.  
REWIND,DN=USRDAT.
```

where filename.DAT is the complete VAX file specification with a .DAT extension.

After getting User Data, the FORTRAN units must be assigned. The file numbers and names used in BLDINP are:

<u>BLDINP File Name</u>	<u>Unit Number</u>	<u>Cray File Name</u>
User Data	1	USRDAT
Input Data	2	INPDAT
User Input	5	INPUT
User Output	6	RESULT

Since User Data (section 2.1) is provided as an external file, it must be assigned a unit number and name, as follows:

```
ASSIGN,DN=USRDAT,A=FT01.
```

Input Data is a mass storage file created by BLDINP for use by GRASP. Because it is a mass storage file, it must not be assigned in the runstream. User Input (section 2.2) is data that are included at the end of the COS commands. Since the Cray defaults the unit number and file name to those desired, it is not necessary to assign them in the runstream. User Output is the file to which the program writes using FORTRAN write statements. It includes any results and all warning and error information and is assigned as follows:

```
ASSIGN,DN=RESULT,A=FT06.
```

Having taken care of all of the preliminaries, BLDINP is ready to be run. The COS loader command identifies the data set containing program to be run and the data sets containing the libraries from which unsatisfied externals may be loaded.

```
LDR,DN=BINPLIB,LIB=INFMLIB:ERRMLIB:UTILLIB,  
MAP=FULL,L=MAPFILE.
```

In this loader command, a full load map is created. The map may be useful if the program aborts, and need not be kept if the program terminates normally.

After the program has run, the program output must be returned to the user. For normal termination of the program, only the results and the logfile are needed. The following COS commands release User Data and the load map (they are no longer needed), rewind the results file and copy it into the logfile, and dispose that file back to the remote VAX.

```
RELEASE,DN=USRDAT.  
RELEASE,DN=MAPFILE.  
REWIND,DN=RESULT.  
COPYF,I=RESULT,O=$OUT.  
DISPOSE,DN=$OUT,DEFER,TEXT='$DISK filename.OUT'.
```

Should the program abort, it is often convenient to print out the results, log file, and map separately. The following COS commands perform this function:

```
EXIT.  
REWIND,DN=RESULT.  
DISPOSE,WAIT,DN=RESULT,TEXT='$DISK filename.RSL'.  
REWIND,DN=MAPFILE.  
DISPOSE,DEFER,DN=$OUT,TEXT='$DISK filename.LOG'.  
DISPOSE,WAIT,DN=MAPFILE,TEXT='$DISK filename.MAP'.
```

Note that the EXIT command serves two purposes. If the program terminates normally, the operating system reads the command and terminates the job without performing the commands that come after it. If the program aborts, the operating system skips everything between the abort and the EXIT, then resumes executing COS commands.

If BLDINP is run in a separate job from GRASP, it also becomes necessary to save the Input Data file for later use. In such a case, the user should consult the Cray COS Reference Manual.

3.2. Invoking GRASP

The steps required to invoke GRASP are very similar to those required to invoke BLDINP. In fact, many of the commands required duplicate those used to run BLDINP. In the event that BLDINP and GRASP are run sequentially in a single job, the duplicate commands should not be repeated (see Appendix C).

The first step is again to gain access to the subroutines that are needed to run the program. The subroutines are resident in Cray libraries named EXECLIB (GRASP main program and subroutines), ERRMLIB (Error Manager), INFMLIB (Information Manager), MATHLIB (Managed Information Utilities), UTILLIB (Utilities), and the IMSL library. The COS commands required to access these libraries are:

```
ACCESS,DN=EXECLIB,PDN=EXECLIB,ID=GRASPLIB.  
ACCESS,DN=ERRMLIB,PDN=ERRMLIB,ID=GRASPLIB.  
ACCESS,DN=INFMLIB,PDN=INFMLIB,ID=GRASPLIB.  
ACCESS,DN=MATHLIB,PDN=MATHLIB,ID=GRASPLIB.  
ACCESS,DN=UTILLIB,PDN=UTILLIB,ID=GRASPLIB.  
AMESLIB.  
IMSLIB.
```

The data used by GRASP are stored in the Input Data file, which was created by BLDINP. If BLDINP and GRASP are run sequentially, Input Data is automatically available to GRASP. If, however, GRASP is using a previously created Input Data file, that file must also be obtained.

The FORTRAN units must be then assigned. The file numbers and names used in GRASP are:

<u>GRASP File Name</u>	<u>Unit Number</u>	<u>Cray File Name</u>
Input Data	2	INPDAT
User Input	5	INPUT
User Output	6	RESULT

Input Data is the mass storage file created by BLDINP and is not assigned in the runstream. User Input (section 2.2) is data that are included at the end of the COS commands. Since the Cray defaults the unit number and file name to those desired, it is not necessary to assign them in the runstream. User Output is the file which contains all of the results of the GRASP calculations, plus any warning and error information. It is assigned as follows:

```
ASSIGN,DN=RESULT,A=FT06.
```

Having taken care of all of the preliminaries, GRASP is ready to be loaded and executed. The COS loader command identifies the data set containing the program to be run and the data sets containing the libraries from which unsatisfied externals may be loaded.

```
LDR,DN=EXECLIB,LIB=MATHLIB:INFMLIB:ERRMLIB:UTILLIB:IMSL,  
MAP=FULL,L=MAPFILE.
```

In this loader command, a full load map is created. The map may be useful if the program aborts, and need not be kept if the program terminates normally.

After the program has run, the only thing left to do is to return the program output to the user. For normal termination of the program, only the results and the logfile are needed. The following COS commands release User Data and the load map (they are no longer needed), rewind the results file and copy it into the logfile, and dispose that file back to the remote VAX.

```
RELEASE,DN=MAPFILE.  
REWIND,DN=RESULT.  
COPYF,I=RESULT,O=$OUT.  
DISPOSE,DN=$OUT,DEFER,TEXT='$DISK filename.OUT'.
```

Should the program abort, it is often convenient to print out the results, log file, and map separately. The following COS commands perform this function:

```
EXIT.  
REWIND,DN=RESULT.  
DISPOSE,WAIT,DN=RESULT,TEXT='$DISK filename.RSL'.  
REWIND,DN=MAPFILE.  
DISPOSE,DEFER,DN=$OUT,TEXT='$DISK filename.LOG'.  
DISPOSE,WAIT,DN=MAPFILE,TEXT='$DISK filename.MAP'.
```

Note that the EXIT command serves two purposes. If the program terminates normally, the operating system reads the command and terminates the job without performing the commands that come after it. If the program aborts, the operating system skips everything between the abort and the EXIT, then resumes executing COS commands.

4. INTERPRETING OUTPUT

4.1. User Output

User Output consists of all of the results produced by GRASP and any error or warning messages issued by the program. Upon normal termination, User Output is combined with the Log File (section 4.2), and appears just before the system messages. If GRASP terminates abnormally, User Output is sent to a separate .RSL file (section 3.2).

The contents of User Output depend largely on the directives issued by the user under "Control Data" (section 2.1.2). Through these directives, any data structure named at the directive level may be sent to User Output. In the following sections, the data structures used and produced by the Steady-state Solution and the Asymmetric Eigensolution will be described.

4.1.1. Steady-state Problem

Solution of the steady-state problem produces several different data structures that the user may wish to examine. These structures include the system model, the steady-deformations and residuals, and the steady-state solution. Each of these can be named by the user under the "SOLVE STEADY-STATE" directive (section 2.1.2). The following sections describe the contents and format of each data structure as it is displayed in User Output.

4.1.1.1. System Model

The system model for the steady-state problem consists of all of the data that GRASP uses internally to describe the model defined by the user in User Data. The only circumstance under which the system model is printed is if the user defines the model name to be something other than the default model name under the "SOLVE STEADY-STATE" directive (section 2.1.2). Documentation for the system model may be found in the GRASP Programmer's Manual.

The data contained in the system model are organized hierarchically as follows:

As displayed in User Output, the heirachical structure is not evident, but the order of the constituent data structures conforms to the order of data structures in the list above.

4.1.1.2. Steady-state Deformations

The Steady-state Deformations data structure contains the steady-state values for all of the degrees of freedom in the model. To print out this data structure, its name (sspdef) must be defined under the “SOLVE STEADY-STATE” directive (section 2.1.2) to be something other than the default name, and a “PRINT DATA SET” directive (section 2.1.2) must be given.

Within the Steady-state Deformations data structure are two data structures: the Steady-state Deformations for Subsystems (SDSSsspdef), and the Steady-state Deformations for Aeroelastic Beam Internals (SDAIsspdef). Each of these two structures consists of a set of single-column matrices. The Steady-state Deformations for Subsystems data structure contains one matrix for each subsystem, while the Steady-state Deformations for Aeroelastic Beam Internals data structure contains one matrix for each aeroelastic beam element. If a beam element has no internal degrees of freedom, the corresponding Aeroelastic Beam Internals Steady-state Deformations matrix has a length of zero.

The degree of freedom values for each subsystem are contained in the individual single-column matrices that are the constituents of the Steady-state Deformations for Subsystems data structure. These matrices are printed in order of ascending subsystem pre-order number. The names of the Subsystem Steady-state Deformations matrices can be used to identify the subsystem names, since they are all of the form “SSSDsbsnam”, where sbsnam is the subsystem name. The values of the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model under the Subsystem Variables Identifiers (section 4.1.1.1).

The internal degree of freedom values for each aeroelastic beam are contained in the individual single-column matrices that are the constituents of the Steady-state Deformations for Aeroelastic Beam Internals data structure. These matrices are printed in order of ascending aeroelastic beam number. The names of the Aeroelastic Beam Internals Steady-state Deformations matrices can be used to identify the aeroelastic beam elements, since they are all of the form “AISDsbsnam”, where sbsnam is the subsystem name. The values of the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model under the Aeroelastic Beam Internals Variables Identifiers (section 4.1.1.1).

4.1.1.3. Steady-state Residuals

The Steady-state Residuals data structure is the data structure that contains the values of the steady-state residuals for the degrees of freedom for each element in the model. To print out this data structure, its name (ssprsd) must be defined under the “SOLVE STEADY-STATE” directive (section 2.1.2) to be something other than the default name, and a “PRINT DATA SET” directive (section 2.1.2) must be given.

Within the Steady-state Residuals data structure are four data structures: the Steady-state Aeroelastic Beam Residuals (ABELMRSD), the Steady-state Air Mass Residuals (AMELMRSD), the Steady-state Direct Input Residuals (DIELMRSD), and the Steady-state Rigid-body Mass Residuals (RMELMRSD). Each of these structures consists of a set of single-column matrices that contain the residuals for all of the elements of that type in the model. If, for example, a model included three rigid-body mass elements, there would be three matrices contained in the Steady-state Rigid-body Mass Residuals data structure.

The degree of freedom residual values for each element are contained in the individual single-column matrices that are the constituents of the Steady-state Aeroelastic Beam Residuals, the Steady-state Air Mass Residuals, the Steady-state Direct Input Residuals, and the Steady-state Rigid-body Mass Residuals data structures. For each element type, these matrices are printed in order of ascending subsystem number. The names of the matrices can be used to identify the subsystem names, since they are all of the form "sbsnamABELMRSD", "sbsnamAMELMRSD", "sbsnamDIELMRSD", or "sbsnamRMELMRSD", where sbsnam is the subsystem name. The residual values for the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model under the Subsystem Variables Identifiers (section 4.1.1.1).

4.1.1.4. Steady-state Solution

The Steady-state Solution data structure displays the primary results of a steady-state problem in a format that is convenient to the user. The data structure is printed by default if its name is not specified under the "SOLVE STEADY-STATE" directive (section 2.1.2). If the name is specified, however, a "PRINT DATA SET" directive (section 2.1.2) must be given in order to have the data structure printed.

For each subsystem in the structure, the values of the steady-state deformations are displayed along with the degree of freedom numbers and the variable identifiers. Preceding the deformations for each subsystem is a header which identifies the subsystem pre-order number, name, and type. The results are displayed in three columns: degree of freedom numbers, steady-state deformation values, and degree of freedom variable identifiers. The variable identifiers consist of four words which uniquely identify each degree of freedom: subsystem name, node name, and degree of freedom name (two words).

4.1.2. Asymmetric Eigenproblem

Solution of the asymmetric eigenproblem produces several different data structures that the user may wish to examine. These structures include the system model, the reference deformations and residuals, the asymmetric eigenproblem matrices, the asymmetric eigenproblem intermediate solution, and the asymmetric eigenproblem solution. Each of these data structures can be named by the user under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2). The following sections describe the contents and format of each data structure as it is displayed in User Output.

4.1.2.1. System Model

The system model for the asymmetric eigenproblem consists of all of the data that GRASP uses internally to describe the model defined by the user in User Data. The only circumstance under which the system model is printed is if the user defines the model name to be something other than the default model name under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2). Documentation for the system model may be found in the GRASP Programmer's Manual.

The data contained in the system model are organized hierarchically as follows:

As displayed in User Output, the heirarchical structure is not evident, but the order of the constituent data structures conforms to the order of data structures in the list above.

For a single User Data file, the System Models for the steady-state problem (section 4.1.1.1) and the asymmetric eigenproblem are very similar, but they are not identical. For example, the Lengths of Aeroelastic Beam Internal State and Residual Vectors are always zero for the asymmetric eigenproblem because all of the internal degrees of freedom are combined with the subsystem degrees of freedom. Thus, for any aeroelastic beam element, the sum of the subsystem and internal degrees is the same for both the steady-state problem and the asymmetric eigenproblem. The entries in the Subsystem and Aeroelastic Beam Internals Variable Identifiers also reflect this difference in the models.

4.1.2.2. Reference Deformations

The Reference Deformations data structure contains the steady-state values for all of the degrees of freedom in the model. Since the Reference Deformations are calculated by a steady-state problem, it will be identical to one of the Steady-state Deformations data structures (section 4.1.1.2) created in the same GRASP run. To print out this data structure, its name (refdef) must be defined under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2) to be something other than the default name, and a "PRINT DATA SET" directive (section 2.1.2) must be given.

Within the Reference Deformations data structure are two data structures: the Reference Deformations for Subsystems (SDSSrefdef), and the Reference Deformations for Aeroelastic Beam Internals (SDAirefdef). Each of these two structures consists of a set of single-column matrices. The Reference Deformations for Subsystems data structure contains one matrix for each subsystem, while the Reference Deformations for Aeroelastic Beam Internals data structure contains one matrix for each aeroelastic beam element. If a beam element has no internal degrees of freedom, the corresponding Aeroelastic Beam Internals Reference Deformations matrix has a length of zero.

The degree of freedom values for each subsystem are contained in the individual single-column matrices that are the constituents of the Reference Deformations for Subsystems data structure. These matrices are printed in order of ascending subsystem pre-order number. The names of the

Subsystem Reference Deformations matrices can be used to identify the subsystem names, since they are all of the form "SSSDsbsnam", where sbsnam is the subsystem name. The values of the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model for the corresponding steady-state problem under the Subsystem Variables Identifiers (section 4.1.1.1).

The internal degree of freedom values for each aeroelastic beam are contained in the individual single-column matrices that are the constituents of the Reference Deformations for Aeroelastic Beam Internals data structure. These matrices are printed in order of ascending aeroelastic beam number. The names of the Aeroelastic Beam Internals Reference Deformations matrices can be used to identify the aeroelastic beam elements, since they are all of the form "AISDsbsnam", where sbsnam is the subsystem name. The values of the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model for the corresponding steady-state problem under the Aeroelastic Beam Internals Variables Identifiers (section 4.1.1.1).

4.1.2.3. Reference Residuals

The Reference Residuals data structure is the data structure that contains the values of the steady-state residuals for the degrees of freedom for each element in the model. Since the Reference Residuals are calculated by the steady-state problem, it will be identical to one of the Steady-state Residuals data structures (section 4.1.1.3) created in the same GRASP run. To print out this data structure, its name (refrsd) must be defined under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2) to be something other than the default name, and a "PRINT DATA SET" directive (section 2.1.2) must be given.

Within Reference Residuals data structure are four data structures: the Reference Aeroelastic Beam Residuals (ABELMRSD), the Reference Air Mass Residuals (AMELMRSD), Reference Direct Input Residuals (DIELMRSD), and the Reference Rigid-body Mass Residuals (RMELMRSD). Each of these structures consists of a set of single-column matrices that contain the residuals for all of the elements of that type in the model. If, for example, a model included three rigid-body mass elements, there would be three matrices contained in the Reference Rigid-body Mass Residuals data structure.

The degree of freedom residual values for each element are contained in the individual single-column matrices that are the constituents of the Reference Aeroelastic Beam Residuals, the Reference Air Mass Residuals, the Reference Direct Input Residuals, and Reference Rigid-body Mass Residuals data structures. For each element type, these matrices are printed in order of ascending subsystem number. The names of the matrices can be used to identify the subsystem names, since they are all of the form "sbsnamABELMRSD", "sbsnamAMELMRSD", "sbsnamDIELMRSD", or "sbsnamRMELMRSD", where sbsnam is the subsystem name. The residual values for the degrees of freedom in each matrix are identified only by the degree of freedom number. The degree of freedom names can be found in the System Model under the Subsystem Variables Identifiers (section 4.1.1.1).

4.1.2.4. Asymmetric Eigenproblem Matrices

The Asymmetric Eigenproblem Matrices data structure contains the mass, damping, and stiffness matrices for the highest-level subsystem in the system model. To print these matrices, the name of the data structure must be defined in the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2) to be different from the default name. Then, a "PRINT DATA SET" directive (section 2.1.2) must also be given.

Each matrix is displayed in standard matrix format and can be identified by its name. The names for the mass, damping, and stiffness matrices are "Maepmtx", "Caepmtx", and "Kaepmtx" respectively, where aepmtx is the name of the Asymmetric Eigenproblem Matrices data structure. The degree of freedom names that correspond to the row and column numbers in the matrices can be found in the System Model under the Subsystem Variables Identifiers (section 4.1.1.1) for the highest-level subsystem.

4.1.2.5. Asymmetric Eigenproblem Intermediate Solution

The Asymmetric Eigenproblem Intermediate Solution data structure contains the eigenvalues and eigenvectors obtained from the system of equations defined by the Asymmetric Eigenproblem Matrices (section 4.1.2.4). To print this data structure its name must be defined under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2) to be different from the default name. Then a "PRINT DATA SET" directive (section 2.1.2) must also be given.

The data structure itself consists of two matrices: the Asymmetric Linear System Eigenvalues and the Asymmetric Linear System Eigenvectors. The names of the eigenvalue and eigenvector data structures are "EVALaepisl" and "EVECaepisl" respectively, where aepisl is the name of the Asymmetric Eigenproblem Intermediate Solution.

The Asymmetric Linear System Eigenvalues data structure is a single-column matrix. Each row entry in the matrix is one of the eigenvalues of the linear system. The eigenvalues are not displayed in any particular order.

The Asymmetric Linear System Eigenvectors data structure is a matrix that has as many rows as there are degrees of freedom, as many columns as there are eigenvalues. Each column of the matrix represents an eigenvector that corresponds to the eigenvalue in the eigenvalues matrix having a row number that is the same as the eigenvector column number. The eigenvector row numbers correspond to the degree of freedom names in the System Model under the Subsystem Variable Identifiers (section 4.1.1.1) for the highest-level subsystem.

4.1.2.6. Asymmetric Eigenproblem Solution

The Asymmetric Eigenproblem Solution data structure displays the primary results of an asymmetric eigenproblem in a format that is convenient to the user. The data structure is printed by default if its name is not specified under the "SOLVE ASYMMETRIC EIGEN-PROBLEM" directive (section 2.1.2). If the name is specified, however, a "PRINT DATA SET" directive (section 2.1.2) must be given in order to have the data structure printed.

For each subsystem in the structure, the eigenvectors calculated for that subsystem are displayed along with their associated eigenvalues. Preceding the eigenvectors for each subsystem

is a header which identifies the subsystem pre-order number, name, and type. Preceding each eigenvector is a header that identifies the mode number, the modal frequency, and the modal damping. The eigenvectors are displayed in three columns: degree of freedom numbers, complex eigenvector values, and degree of freedom variable identifiers. The variable identifiers consist of four words which uniquely identify each degree of freedom: subsystem name, node name and degree of freedom name (two words).

The Asymmetric Eigenproblem Solution will display only the number of eigenvectors specified under "Complex Eigenproblem Parameters Definitions" (section 2.1.3.1.2) or the maximum number of eigenvectors that can be calculated for the model, whichever is smaller. If the specified number of eigenvalues (section 2.1.3.1.2) is greater than the specified number of eigenvectors, but smaller than the maximum number of eigenvalues, the eigenvalues and eigenvectors will be displayed for the lower modes and only the eigenvalues will be displayed for the higher modes.

4.2. Log File

The log file consists of three parts: an optional echo of the User Data file, Cray system messages, and the job history. Using the COS commands outlined in section 3 and Appendix C, the log file is merged with User Output when the the job terminates normally. If the job does not terminate normally, the log file is returned separately.

The User Data echo displays the User Data file exactly as it was obtained from its source. If User Data is not explicitly copied to \$OUT in the COS command runstream, the echo will not be produced. Also, since there is no User Data required to run the program GRASP, a GRASP run that does not first invoke BLDINP does not produce an echo.

Immediately in front of the job history are the system messages. These messages announce operating hours, help messages, and other useful information for users of the Cray.

The job history records the COS commands issued by the user and the system responses to those commands. Also, there may be messages issued during a run either by the computer or by the user program. For example, GRASP sends a message to the log file whenever it begins executing a new directive. One message that often appears after "Model System" is:

```
UT009 - NAMED RECORD NOT FOUND, NAME = xxxxxx UNIT = FT02
```

Although this message appears to indicate an error, it is really a result of a system-type subsystem having neither structural nor air nodes. It therefore may be ignored.

4.3. Map File

The map file is a complete Cray load map for GRASP. It is only generated if GRASP terminates abnormally. For most users, it will be of little help in debugging problems that arise in running GRASP, and may be suppressed by removing the appropriate COS commands from the job runstream. For information on how to read and interpret the load map, Consult the Cray COS Reference Manual.

A. USER DATA SUMMARY

The hierarchical structure of the User Data file is summarized in this appendix. Since blanks are ignored, indentation is arbitrary but useful in reading the file. Within any level of the hierarchy, the order of records is arbitrary, except that the definition of the number (or length) of a set of records must precede the definition of that record set. For example, NUMBER OF MODELS must precede BEGIN MODELS, and LENGTH OF SS NODE DEFINITION SET must precede BEGIN SUB-SYSTEM NODE DEFINITIONS.

Character constants consist of a string of characters enclosed in apostrophes, with the maximum length as indicated. Arrays consist of a series of real or integer numbers separated by commas. A character constant or an array may either be on the same line as the keyword for that record, or on the following line. Except for direction cosine arrays (section 2.1.3.3.3a), continuations from one line to the next are not allowed.
