## I. Introduction

This report is the final report on National Aeronautics and Space
Administration Contract No. NAS8-11231 (including Modifications No. 1 and No. 2) entitled "Study of Optimal and Adaptive Control Theory".

During the study period, which began in May 1964 and continued through June 1966, the principal investigator conducted investigations into a variety of theoretical questions which arise naturally in the study of modern optimal and adaptive control techniques for large launch vehicles. The particular topics chosen for investigation were selected through consultations with the staff of the AeroAstrodynamics Laboratory of the George C. Marshall Space Flight Center, Huntsville Alabama. The principal investigator is especially grateful to Mr. Clyde Baker, Mr. Judson Lovingood, Dr. David Ford ${ }^{*}$ and Mr. Tommy Carter, of the Aero-Astrodynamics Laboratory, for their many stimulating and informative discussions during this study.

The material in this report is arranged in chapters, with each chapter representing a self-contained exposition of a particular topic. Reference and figure citations in the individual chapters refer only to the list of references and collection of figures given in that particular chapter.

The subject of optimal control with a "Minimax-type" performance index received particular attention during this study because of its' potential application in the design of load-minimizing control systems for large launch vehicles. Some of the methods which have previously been used to solve such problems are summarized in Chapter II. In addition, Chapter II contains a detailed account of an essentially "new" method for effectively solving such problems. Application of this proposed new method is illustrated by five examples which are worked in detail.

The study of "worst-case" optimal control problems with unknown disturbances leads naturally to the study of variational problems with "competing controls". This class of problems can be cast as continuous games in function spaces and was first studied as such by R. Isaacs in the early 1950's. A general study of this class of problems was initiated by the principal investigator in the early period of the contract. However, the idea of a general study was subsequently abandoned with the publication of Isaac's

[^1]highly original, and now well-known, 1965 treatise on this subject. Instead, several specific examples were studied in detail by the principal investigator and those examples are presented in Chapter III.

The so-called "phase-variable canonical form" for single-input linear dynamical systems has found many applications in the area of modern linear control theory. Two of the most interesting theoretical aspects of this topic are the matrix theoretic structure of and computational algorithms for the required transformation matrix. The results of studies of these two topics are described in Chapters IV and V.

In many practical applications of modern control theory the concept of invariant hyperplanes in the system state space plays an important role. For instance, this concept forms the theoretical foundation for N.A.S.A.'s "Drift-Minimum" control principle. In the course of the present study the principal investigator studied the algebraic theory of invariant hyperplanes for linear dynamical systems and, by this means, was able to show connections between that topic and the important and related subjects of controllability and observability. These results are described in Chapter VI.

The application of optimal control techniques in the design of large launch vehicle control systems has centered around the well-known, and almost completely solved, linear optimal regulator problem. During the present study, the principal investigator considered several variations on the usual formulation of the linear optimal regulator problem. In particular, the fixed-time regulator problem with time-invariant feedback control and the unspecified-time regulator problem with bounded control were studied in detail. The results obtained for these two problems are described in Chapters VII and VIII.

## Summary

The optimal control of dynamical systems with conventional Mayer, Lagrange, and Bolza type performance indices has been studied in some detail [1], ${ }^{2}$ [2], [3]. In the present work the optimal control of dynamical systems with a certain minimax type performance index, which cannot be expressed in the Mayer, Lagrange, or Bolza format, is studied. The form of the optimal control is described and certain geometric properties of the solution are discussed. Several examples are worked in detail to illustrate application of the proposed method of solution.

## 1. Introduction

Consider the class of dynamical systems described by

where $\underset{\sim}{x}$ is the system state vector and $u(t)$ is the scalar input or control. The optimal control of this class of dynamical systems has been studied in detail for the three particular cases in which $J[u]$, the performance index functional to be minimized, is:
(i) a scalar function $G$ of the initial and/or terminal state (the Mayer type problem)

(iii) a sum of (i) and (ii) (the Bolza type problem)

The theoretical work of Pontryagin, Bellman, LaSalle, Kalman, Berkovitz, and others has led to the development of a relatively complete mathematical theory for this particular class of optimal control problems.

In many practical applications, however, the actual physical perfo:mance criterion cannot be expressed as a Mayer, Lagrange, or Bolza type performance index. For example, in the case of regulator type control systems, the actual performance index may be expressed as per-cent overshoot due to a step change in load with a specified upper bound on settling time. In other practical applications the performance index may be expressed as the maximum or peak value of velocity, acceleration, force, torque, stress, temperature, etc., which occurs during some specified interval of control. Performance indices of this type fall into the general category of what we will call Chebyshev minimax performance indices in which the objective is to minimize the maximum value attained by a scalar function $C(\underset{\sim}{x}(t))$, evaluated along the state trajectory, over some specified closed interval of time. ${ }^{3}$

Optimal control problems with minimax performance indices of the type described above belong to a broad class of extremal problems which have their origin in the highly original researches of the Russian mathematician P。L。Chebyshev [Tchebycheff]. In his 1854 studies [15] of mechanical linkages which generate approximate straight line motion, Chebyshev introduced the important idea of characterizing the quality of the approximation in terms of the maximum deviation from the desired straight line. Those investigations led to the formulation of more general mathematical problems of minimax approximation involving functions least deviating fromi zero and ultimately led to the development of the well-known Chebyshev
3. It is remarked that the term "minimax" has also been used (in a basically different sense) to describe a variety of confiict-type optimization problems which arise in game theory [4], statistical communication theory [5], [6], and optimal control theory [7][14]. In those problems, the performance index is usually of the conventional Mayer, Lagrange, or Bolza type and the minimum and maximum operations are taken with respect to the policies or control actions of two conflicting elements.
polynomials [16] and the more general theory of Chebyshev approximation [17], [18]. The extension of Chebyshev's minimax approximation ideas to problems in approximating solutions to ordinary differential equations was considered in a 1907 paper by Young [19] and more recently by Lanczos [20] and Carter [21].

In 1956, Bellman, Glicksburg, and Gross, [22] gave one of the first accounts of the application of Chebyshev minimax performance indices to problems of optimal control of dynamical systems. In subsequent investigations, Bellman [23], [24], [25], Sevin [26], and Bellman, Glicksburg and Gross [27] studied a variety of particular examples from this class of problems. Some of the more recent researches in this class of problems are described in [28]-[35].

In this paper, we formulate a particular class of optimal control problems with Chebyshev minimax [C-minimax] performance index and describe a method of solution which is essentially different from those proposed in [22]-[35]. Some geometric properties of the optimal trajectory are discussed and a practical technique for computing the optimal control is described. Several examples are worked in detail to illustrate application of the theory.

## 2. Statement of the Problem

The problem is to find, in the class of piecewise continuous functions, a scalar control $u=u(t)$ which minimizes the functional

4. The case in which the independent variable $t(T)$ appears as an explicit argument in one or more of the functions $C, F,(\mathcal{J})$ can be case into the form of (1)-(5) by introducing an auxiliary state variable $x_{n+1}$ defined by

$\operatorname{In}(1), \underset{\sim}{x}=\left(x_{1}, \ldots, x_{n}\right)$ is an $n$-vector: the system state vector, and $C(\underset{\sim}{x})$ is the performance index: a real, single valued, scalar function of $\underset{\sim}{x}$ defined throughout a set $D$ of the $n$-dimensional euclidean state space $E^{n} 。 \ln (2), \underset{\sim}{F}$ is a vector function continuous in $u$ and continuously differentiable with respect to $\underset{\sim}{x} \in D$. Equation (4) defines the terminal manifold, $J \subset D$, an $m$-dimensional ( $m<n$ ) hypersurface of admissible terminal states $\underset{\sim}{x}(T)$. The terminal time $T$ is specified implicitly, by (4), as the first time $t \geq t_{0}$ which satisfies $J(\underset{\sim}{x}(t))=0$. Problems involving more explicit restrictions on $T$ [for example, such as $T=T^{*}$ or $T \leq T^{*}$ where $T^{*}$ is some specified constant] can be accommodated in this formulation by the technique described in footnote 4 below. It is assumed that $C(\underset{\sim}{x})$ and $\boldsymbol{J}(\underset{\sim}{x})$ are once continuously differentiable and $\mathcal{J}$ is connected.

A piecewise continuous real valued function $u(t)$ with values belonging to the closed, convex, and bounded set $U$ is called an admissible control. An admissible control $u=u^{\circ}(t)$ which yields an absolute minimum of the functional (1), subject to the restrictions (2)-(4), is called optimal. ${ }^{5}$ An optimal control of the foriri $u^{\circ}(t)=u^{\circ}(\underset{\sim}{x}(t))$ is an optimal control law. An integral curve of (2) corresponding to an optimal control, is an optimal trajectory. The set $D \subset E^{n}$ is taken as the set of all states $\underset{\sim}{x}$ which are controllable to $\mathcal{T}$. That is, for each initial state ${\underset{\sim}{0}} \in \mathrm{D}$ there exists at least one admissible control $u(t)$ such that the corresponding solution of (2) satisfies (3) and (4). Hereafter, we assume that $D$ is non-void and $u^{\circ}(\underset{\sim}{x})$ exists for all $\underset{\sim}{x} \in D$.

## 3. Form of the Solution

Let $u^{0}(\underset{\sim}{x})$ be an optimal control law, and let

It may be noted that an optimal control for the functional (1) is also optimal for every functional of the form $J[u]=\max _{\dagger_{0} \leq t \leq T} M[C(\underset{\sim}{x}(t))]$ where $M(C)$ is any monotonically increasing continuous function of $C$. For this reason, the previously stated assumption concerning the differentiability of the performance index can usually be realized, even when the original function $C(\underset{\sim}{x})$ is not continuously differentiable, by proper choice of an alternative performance index $\mathrm{M}[\mathrm{C}(\underset{\sim}{x})]$.

From (1), it is clear that

It is assumed hereafter that $V(\underset{\sim}{x})$ is continuous at each state $\underset{\sim}{x}$ in the interior of $D$ 。 Let $R_{0} \supset \mathcal{J}$ be the set of all states $\underset{\sim}{x} \in D$ with the following properties. For each ${\underset{\sim}{x}}_{0} \in R_{0}$ an admissible control $u=\phi\left(t ; x_{0}\right)$ exists such that ( 8 ) is satisfied everywhere along the corresponding solution of (2) and, in addition

Clearly, the set $R_{o}$ is connected and closed relative to $D$. It is remarked that $\phi\left(t ;{\underset{\sim}{0}}_{0}\right)$ is not unique, in general. Moreover, the set $R_{0}-\mathcal{J}$ might be empty. Let $\partial R_{0}$ denote the boundary of the set $R_{0}$ and suppose that $\partial R_{0}$ is defined by $B(\underset{\sim}{\prime})=T$, $\underset{\sim}{x} \in \mathrm{D}$. Suppose also that $\underset{\sim}{\nabla} \mathrm{B}(\underset{\sim}{x})$ exists at $\underset{\sim}{x}$ and let $\underset{\sim}{\nu}(\underset{\sim}{x})$ be the outward pointing normal to the boundary $\partial R_{0}$. It also follows, from the definition of $R_{o}$, that the regions of $\partial R_{o}$ at which (14) and (15) are satisfied (i.e.: $U^{\prime}(\underset{\sim}{x})$ is empty) are built up from integral manifolds of optimal trajectories which belong to $R_{0}$.

It is clear that $u=\phi\left(t ;{\underset{\sim}{0}}^{x}\right)$ is an optimal control when ${\underset{\sim}{x}}_{0} \in R_{0}$. Moreover, an optimal control law $u^{0}(\underset{\sim}{x}), \underset{\sim}{x} \in R_{0}$, satisfies, ${ }^{8}$ in addition to (8), (10), (11), the condition

Equations (13)-(15) remain valid at points on $\partial R_{o}$ where $B(\underset{\sim}{x})$ is not continuously differentiable provided that the set $U^{\prime}(\underset{\sim}{x})$ is interpreted as the set of values $u \in U$ which "point" the local velocity vector $\underset{\sim}{F}(\underset{\sim}{x}, \underset{U}{\sim}), \underset{\sim}{x} \in \partial R_{0}$, into the interior of the set $R_{0}$.
8. It should be stressed that $C(\underset{\sim}{x}(t))$ need not be monotonic non-increasing along every optimal trajectory which passes through a given initial state $x_{0} \in R_{0}$. However, it is evident from (8) and the definition of $R_{0}$ that through each initial state ${\underset{\sim}{0}} \in R_{0}$ there passes at least one optimal trajectory along which $C(\underset{\sim}{x}(t))$ is monotonic non-increasing. In $R_{o}$, optimal trajectories of this latter type are the only ones which possess the Markovian property required for application of the Principle of Optimality [36]. It follows that an optimal control law can be defined in $R_{0}$ only for optimal trajectories of this Iatter type.

It is remarked that the set $R_{0}$ has a convenient interpretation in terms of Liapunov stability theory. In particular, if the performance index $C(\underset{\sim}{x})$ is considered as a generalized Liapunov function for the system $\underset{\sim}{\dot{x}}=\underset{\sim}{F}\left(\underset{\sim}{x}, u^{o}(\underset{\sim}{x})\right)$, in the sense of LaSalle [37], then the interior of $R_{0}$ is the corresponding estimate of the domain $D$ of asymptotic stability with respect to the terminal manifold $\mathcal{J}$.

Let $R_{m} \subset\left(D-R_{0}\right)$ denote the largest (not necessarily connected) set of states $\underset{\sim}{x}$ with the following properties. For each $\underset{\sim}{x} \in R_{m}$, an admissible control $u=\gamma\left(t ;{\underset{\sim}{x}}_{0}\right)$ and a time ${ }^{\dagger}$, exist such that the following conditions are satisfied along the corresponding solution of (2).

It is evident from (26) that optimal trajectories in the set $R_{m}$ lie on hypersurfaces of constant $V(\underset{\sim}{x})$. Moreover, since $C(\underset{\sim}{x})$ is assumed continuous, the function $V(\underset{\sim}{x})$ defined by (17) and (26) must be continuous ${ }^{10}$ at points $\underset{\sim}{x}$ where optimal trajectories from $R_{m}$ cross over common boundaries of $R_{o}$ and $R_{m}$. Thus, the equation defining the locus of such boundary points can be obtained by equating the two expressions (17) and (26).

It is remarked that, in certain instances, the condition (21) may fail to yield a well-defined control $\gamma(t)=\gamma(\underset{\sim}{x}(t), \underset{\sim}{p}(t))$ during some positive interval of time. In such cases, the possibility of singular solutions [38], [39] of the variational problem (24) should be investigated.

From the properties of the sets $R_{0}, R_{m}$ it follows that an optimal trajectory $\underset{\sim}{x}(t)$ which passes through an initial state $\underset{\sim}{x} \notin R_{0} U R_{m}$ must necessarily ${ }^{11}$ enter the set $R_{o} \cup R_{m}$ at some time $t_{2}\left(t_{0}<t_{2}<T\right)$. Continuing with this process the region $D$ may be completely partitioned into the two families of sets $\left\{R_{o}^{i}\right\}=\left\{R_{o}, R_{o}^{2}, R_{o}^{3}!\ldots\right\}$; and $\left\{R_{m}^{i}\right\}=\left\{R_{m}, R_{m}^{2}, R_{m}^{3}, \ldots\right\}$. When the partitioning of $D$ into the sets $\left\{R_{o}^{i},\left\{R_{m}^{i}\right\}\right.$ is completed, the optimal control for the original problem (1)-(5) is completed, the optimal control for the original problem (1)-(5) is known. problem (24) where the "terminal manifold" is taken as the boundaries of the immediately adioining sets of the $R_{o}$ type. In this way, the state $\underset{\sim}{x}(t)$ progresses alternately ${ }^{12}$ and optimally through the sets of the $R_{0}$ and $R_{m}$ type and eventually reaches the original terminal manifold.

## 4. Minimax Points

The function $V(\underset{\sim}{x})$, defined in (6), associates a characteristic number with each initial state $\underset{\sim}{x}{\underset{\sim}{0}}^{x} \in \mathrm{D}$. This number represents the maximum value of the scalar function $C(\underset{\sim}{x}(t))$ which occurs along the particular optimal trajectory which starts at ${\underset{\sim}{x}}_{0}$. It some applications, it may be desirable to identify the actual state (or states) $\underset{\sim}{x}=\underset{\sim}{\boldsymbol{\sim}}$, along the optimal trajectory which starts at ${\underset{\sim}{0}}_{0}$, at which the maximum of $C(\underset{\sim}{x}(t))$ occurs. We shall call a charateristic state $\left.\underset{\sim}{\varepsilon}=\underset{\sim}{\varepsilon} \underset{\sim}{x} x_{0}\right)$ a minimax point for the state $\underset{\sim}{x} .{ }_{0}$. Every state $\underset{\sim}{x} \in D$ has an associated minimax point. However, the minimax point $\underset{\sim}{\xi}(x)$ associated with a given state $x_{\sim}{ }_{0}$ is not unique, in general, owing to the presence of the equality signs in (8) and (20).

From the defirition of the sets $\left\{R_{o}^{\mathbf{i}}\right\}$ it follows that

12. Some of the sets $\left\{\mathrm{R}_{0}^{i}\right\}$ might share common boundaries of the type described by (14)-(15). In such cases, there may exist (non-unique) optimal trajectories which do not progress alternately through the sets $\left\{R_{0}^{i}\right\},\left\{R_{m}^{i}\right\}$. Some examples of this type are illustrated in Section 8 below.

law such that $\mathrm{T}<\infty$ for the corresponding optimal trajectory. ${ }^{14}$ For this purpose, we set $\tau=T-t(\tau \geq 0)$ in (2) and consider the reverse-time solutions $\underset{\sim}{x}(\tau)$ of (2) corresponding to various choices of admissible control functions $u(\tau)$ 。 At each state $\underset{\sim}{x} \in R_{0}$ the condition

It is clear that each state $\underset{\sim}{x} \in D$ which can be "reached" by such a solution is contained in the set $R_{0}$. Moreover, it follows from the definition of $R_{0}$ that each state $\underset{\sim}{x} \in R_{0}$ must be reachable by at least one such solution. Thus, the set $R_{o}$ is the set of all states $\underset{\sim}{x}$ which can be reached by admissible reverse-time solutions of (?) with initial conditions satisfying $\underset{\sim}{x}(\tau=0) \in \mathscr{J}$ and along which the condition (30) is elveays satisfied. It is recalled that the appropriate condition (13) or (14), (15) is satisfiex it non-terminal states $\underset{\sim}{x}$ on the boundary of $R_{0}$.

When the boundary of $R_{0}$ is known, the backward-time technique can be used to establish optimal trajectories in $R_{m}$ by integrating equations (2) and ( $\overline{2}$ ), in reverse time, starting on the boundary ${ }^{15}$ of $R_{0}$. In this case, the "initial conditions" for (22) are given by (23) and the optimal control $\gamma(\tau)=\underset{\sim}{\gamma}(\underset{\sim}{x}(\tau), \underset{\sim}{p}(\tau))$ is determined from (21), provided the solution does not contain singular sub-arcs. It is clear from the definition of $R_{o}$ that as (2) and (22) are integrated through $R_{m}$ in reverse time, the value of

$C(\underset{\sim}{x}(\tau))$ must first decrease below its initial value. The reverse-time integration through $R_{m}$ is continued until a point $\underset{\sim}{x}$ is reached where any further continuation of the reverse-time integration will result in the value of $C(\underset{\sim}{x}(\tau))$ exceeding its initial value. Each point $\underset{\sim}{x}$ determined in this manner is a boundary point ${ }^{16}$ of $R_{m}$.

When the boundaries of $R_{o}$ and $R_{m}$ are known, the backward-time procedure described above may be used to identify the sets $R_{o}^{2}, R_{m}^{2} ; R_{o}^{3}, R_{m}^{3}$, etc. in an analogous way.

The procedure described above suggests the possibility of using an analog or digital computer and self-organizing system techniques to search out and determine points on the boundaries of the sets $\left\{R_{0}^{i}\right\},\left\{R_{m}^{i}\right\}$ by completely automatic machine solution. This is an interesting area for further research.

## 6. Secondary Performance Indices

The optimal control law $\left.U^{0} \underset{\sim}{x}\right)$ is, in general, not unique ${ }^{17}$ in the sets $\left\{R_{o}^{i}\right\}$. For this reason, the design and instrumentation of $C$-minimax optimal control laws affords a degree of flexibility which is not usually associated with optimal control laws for other performance indices. For example, in the sets $\left\{\mathrm{R}_{0}^{i}\right\}$ it is not unusual to find that the same optimal performance is obtained when the controller is expressed as either (i) a bang-bang control law, (ii) a linear, continuous, control law, (iii) a nonlinear, continuous, control law, or (iv) a combination of (i), (ii) and (iii).

The non-uniqueness of the $C$-minimax optimal control law in the sets $\left\{\mathrm{R}_{0}^{i}\right\}$ suggests the possibility of introducing a secondary performance index for those sets. Suppose, for example, that $\underset{\sim}{\hat{u}} \underset{\sim}{x})$ is an optimal control law for (2)-(5) with a certain Mayer, Lagrange, or Bolza type performance index. Then, the control law $\underset{\sim}{\hat{U}} \underset{\sim}{x})$ can be used as the C-minimax optimal control law for (2)-(5) in a set $R_{0}^{k} \subset\left\{R_{o}^{i}\right\}$ provided that

[^3]is satisfied together with the appropriate boundary conditions. Some applications of this technique are illustrated in Section 8 below.

## 7. Some Alternative Methods of Solution

If the performance index $C(\underset{\sim}{x})$ is a non-negative definite function it can be shown that the functional (1) can be written as ${ }^{18}$

where $(\cdot)^{1 / \mu}$ denotes the real and positive $\mu^{\text {th }}$ root of ( $\cdot$ )。 [An elementary proof of (32) is given in the Appendix.] Thus, for the special case when $C(\underset{\sim}{x})$ is non-negative definite, a solution to the original C-minimax optimal control problem (1)-(5) can be obtained, through a limiting process, by minimizing instead the Lagrange-type performance index

It is interesting to note that, although the control obtained by minimizing the performance index (33), as $\mu \rightarrow \infty$, does coincide with one of the optimal controls which minimizes (1), it does not exhibit the same degree of nonuniquesness, in general. An application of this alternative method of solution is illustrated in Example 1, Section 8. A further discussion of this topic may be found in [35].

Another alternative method of solution consists in replacing the original C-minimax optimal control problem (1)-(5) by the following problem of controllability in restricted state space: Find an admissible control $u=u^{c}(t)$ which transfers the state of the dynamical system (2) from the initial state $\underset{\sim}{x}\left(t_{0}\right)={\underset{\sim}{x}}_{0} \in D$ to the terminal

Warga [30], [31] has developed an elegant alternative method of solution by using the result (37) to convert the original problem (1)-(5) into a special Mayer problem in restricted state space and then applying a comprehensive set of necessary conditions, (developed by Warga), for solutions of Mayer-type optimal control

problems in restricted state space. In an independent study, Dubovitskii and Milyutin [28], [29] used function space techniques involving Stieltjes integrals to develop a set of necessary conditions (for C-minimax control problems) which closely resemble some of the results given in [30]. It is remarked that the possibility of using Stieltjes integrals in the study of C-minimax control problems was pointed out by Bellman et al. in [22].

The functional equation technique of dynamic programming has also been used to study discrete versions of several special cases of the problem (1)-(5). Some of the results are described in [23], [24] and [25].

## 8. Examples

The following examples illustrate application of the method of solution proposed in Section 3. It will be noted that the simplicity of these examples permits the validity of the solutions obtained to be readily verified by inspection.

Example 1. As a special case of (1)-(5), let

Moreover, it is readily verified that in order to satisfy (49)-(53) it is necessary to choose

\begin{equation*}
p_{2}(t)=-2\left|x_{2}(t)\right| x_{1}\left(t_{1}\right) \tag{55}
\end{equation*}
$$

Thus, (54) can be written in the form

$$
\begin{equation*}
u^{o}(t)=-\operatorname{sgn}\left[x_{1}\left(t_{1}\right)\right] \quad \underset{\sim}{x} \in R_{m} \tag{56}
\end{equation*}
$$

or, since $\operatorname{sgn} x_{1}\left(t_{1}\right)=\operatorname{sgn} x_{2}(t),\left(x_{2}(t) \neq 0\right),(56)$ can be written in the control law form

$$
\begin{equation*}
u^{0}(\underset{\sim}{x}(t))=-\operatorname{sgn}\left[x_{2}(t)\right] \quad \underset{\sim}{x} \in R_{m} \tag{57}
\end{equation*}
$$

From (39) and (57) the optimal trajectories in the set $R_{m}$ are obtained as the one parameter family of curves defined by

$$
\begin{equation*}
x_{1}+\frac{1}{2}\left|x_{2}\right| x_{2}=k \quad k=\text { real, scalar constant } \tag{58}
\end{equation*}
$$

Since $\dot{x}_{1}(t)$ does not change sign along the optimal trajectories in $R_{m^{\prime}}$, it follows from (58) that (48) is satisfied in the region ( $E^{2}-R_{o}$ ) where

$$
\begin{cases}x_{1}+\frac{1}{4} x_{2}^{2} \geq 0 & x_{2}>0  \tag{59}\\ x_{1}-\frac{1}{4} x_{2}^{2} \leq 0 & x_{2}<0\end{cases}
$$

Thus, the set $R_{m}$ is bounded by the curves

$$
\partial R_{m}:\left\{\begin{array}{l}
x_{2}=0  \tag{60}\\
x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}=0
\end{array}\right.
$$

In the complement of $R_{o} U R_{m}$ every admissible control law has the property that if $\underset{\sim}{x}\left(t_{0}\right) \in E^{2}-\left(R_{0} \cup R_{m}\right)$ then $\underset{\sim}{x}\left(t_{2}\right)$ satisfies the second of (60) for some $t_{2}$ and, in addition, ${\underset{\sim}{r}}^{x}(t) \in \mathrm{E}^{2}-\left(R_{0}^{m} U R_{m}\right)$ and $d / d t\left(x_{1}^{2}(t)\right) \leq 0, t_{0} \leq t \leq t_{2}$. It follows that $E^{2}-\left(R_{0} \cup R_{m}\right)$ is a set $R_{0}^{2}$ of the $R_{0}$ type and every admissible control law is an optimal control law for ${\underset{\sim}{x}}^{x} \in R_{0}^{2}$ ! $\ln$ particular, one can choose

$$
\begin{equation*}
u^{0}(\underset{\sim}{x}(t))=-\operatorname{sgn}\left[x_{2}(t)\right] \quad \underset{\sim}{x} \in R_{0}^{2} \tag{61}
\end{equation*}
$$

The $x_{1}, x_{2}$ plane is now completely partitioned into sets of the $R_{0}$ and $R_{m}$ type. One choice for the corresponding set of optimal control laws is given by (46), (57) and (61). It may be noted that (46) gives a correct optimal control law for all three sets $R_{o}, R_{m}, R_{o}{ }^{2}$. Thus, for this example, the minimum-time control law also minimizes (38).

In the sets $R_{o}, R_{0}{ }^{2},(6)$ is given by

V(x)=x_{1}^{2}, \quad \underset{\sim}{x} \in R_{0} U R_{0}^{2} \tag{62}
\end{equation*}
$$

In the set $R_{m}$, the $V(\underset{\sim}{x})=$ constant contours correspond to the trajectories (58). Thus, in $R_{m}$

\begin{equation*}
V(\underset{\sim}{x})=\left[x_{1}+\frac{1}{2}\left|x_{2}\right| x_{2}\right]^{2} \quad \underset{\sim}{x} \in R_{m} \tag{63}
\end{equation*}
$$

The sets $R_{o}, R_{m}, R_{o}^{2}$ are shown in Fig. 1, together with some representative $V(\underset{\sim}{x})=$ constant contours and a typical optimal trajectory corresponding to the optimal control law (46).

In this particular example, it turns out that the sets $R_{o}$ and $R_{0}^{2}$ share a common boundary defined by (44). For this reason, the previously selected optimal control law for the set $R_{o} \cup R_{o}^{2}\left[i_{0} . e\right.$ (46) and (61)] can be replaced by any admissible control law such that (45) is satisfied. One such alternative optimal control law, which in view of (57) happens to be optimal for the set $R_{m}$ as well, is given by

u^{o}(\underset{\sim}{x})=-\operatorname{sgn}\left[x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}\right] \quad \underset{\sim}{x} \in \mathrm{E}^{2} \tag{64}

Any control law which minimizes (38) also minimizes

$$
\begin{equation*}
J[u]=\max _{t_{0} \leq t \leq T}\left|x_{1}(t)\right| \tag{65}
\end{equation*}
$$

and vice versa. Moreover, from (32), (33) it follows that the limiting control law obtained by minimizing the integral

$$
\begin{equation*}
J[u]=\int_{t_{0}}^{T}\left|x_{1}(t)\right|^{\mu} d t \tag{66}
\end{equation*}
$$

as $\mu \rightarrow \infty$, must coincide with one of the control laws which minimize (38) and (65). Fuller [41] has shown that the control law $u(\underset{\sim}{x}, \mu)$ which minimizes (66), subject to the conditions (39)-(42), can be written as

u\left(x_{\sim}, \mu\right)=-\operatorname{sgn}\left[x_{1}+\frac{1}{2} \frac{1-k(\mu)}{1+k(\mu)}\left|x_{2}\right| x_{2}\right] \tag{67}

where the parameter $k(\mu)$ is determined from a certain auxiliary algebraic equation and has the particular values $k(1) \approx 0.01433, k(2) \approx 0.05862$, and $\lim _{\mu \rightarrow \infty} k(\mu)=1 / 3$, Thus, the control law which minimizes (66), as $\mu \rightarrow \infty$, coincides exactly with the alternative C-minimax optimal control law (64).

Example 2. The following example illustrates a case in which the performance index $C \underset{\sim}{x})$ is not sign definite and the optimal trajectories in a subset of $R_{m}$ are not unique.

Suppose the performance index of the problem (1)-(5) has the form

J[u]=\max _{t_{0} \leq t \leq T} x_{1}(t) \tag{68}
\end{equation*}
$$

with (2)-(5) the same as (39)-(42) in Example 1. Then, following the same procedure as in the previous example, it may be verified that the set $R_{o}$ is the closed set of points in the fourth quadrant of the $x_{1}, x_{2}$-plane bounded by the curves

$$
\partial R_{0}: \begin{cases}x_{2}=0 & x_{1} \geq 0  \tag{69}\\ x_{1}-\frac{1}{2} x_{2}^{2}=0 & x_{2} \leq 0\end{cases}
$$

The set $R_{m}$ is likewise found to be the set of all points in the first, second, and third quadrants of the $x_{1}, x_{2}$-plane with the exception of the points on the positive $x_{1}$-axis. In the particular subset $R_{m_{1}} \subset R_{m}$ defined by

\begin{equation*}
R_{m_{1}}=\left\{\underset{\sim}{x} \left\lvert\, x_{1}+\frac{1}{2} x_{2}^{2} \geq 0\right., \quad x_{2}>0\right\} \tag{70}
\end{equation*}
$$

the optimal control $u^{\circ}(t)$ is unique and can be written in the control law form

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=-\operatorname{sgn}\left(x_{2}\right) \quad x_{2} \in R_{m_{1}} \tag{71}
\end{equation*}
$$

In the set $R_{m 2}=R_{m}-R_{m 1}$, however, the optimal control, obtained by solving the appropriate Mayer problem (24), is non-unique. This is due to the fact that the function $C(\underset{\sim}{x})=x_{1}$, evaluated on the "terminal manifold" $\partial R_{o}$, attains its minimum value at a state $(\underset{\sim}{x}=0)$ which can be reached, using an admissible control satisfying (20), from every initial state ${\underset{\sim}{x}}_{0} \in R_{m_{2}}$. That is, the functional $J[u]$ defined by (68) turns out to be "independent of path" for every trajectory $\underset{\sim}{x}(t) \in R_{m_{2}},{ }_{0} \leq t<T$, which satisfies (41). It follows that

$$
\begin{equation*}
V(\underset{\sim}{x})=\text { constant }=0 \quad \forall \underset{\sim}{x} \in R_{m_{2}} \tag{72}
\end{equation*}
$$

It may be verified that the set $E^{2}-R_{o} U R_{m}$ is a set $R_{o}^{2}$ of the $R_{o}$ type. The sets $R_{o}, R_{m}$ and $R_{o}^{2}$, together with some representative $V(\underset{\sim}{x})=$ constant contours and a typical optimal trajectory, are illustrated in Fig. 2.

Example 3. As another special case of (1)-(5), let

$$
\begin{equation*}
J[u]=\max _{t_{0} \leq t \leq T}\left[x_{1}(t)+x_{2}(t)\right]^{2} \tag{73}
\end{equation*}
$$


with (2)-(5) the same as (39)-(42) in Example 1. The absolute minimum of the functional (73) occurs on the line

$$
\begin{equation*}
x_{1}+x_{2}=0 \tag{74}
\end{equation*}
$$

which is an integral curve of (39) when $u$ is chosen appropriately. Therefore, the construction of the set $R_{0}$ begins by looking for a segment of the line (74) which is an integral curve of (39), for some admissible control, and along which the terminal condition (4l) is satisfied. It is readily verified that such a segment exists and is defined by

$$
\begin{equation*}
x_{1}+x_{2}=0 \quad\left|x_{1}\right| \leq 1 \tag{75}
\end{equation*}
$$

It is observed that the terminal condition (4I) is satisfied along the trajectory (75) only as $t \rightarrow \infty$. The remainder of the set $R_{0}$ consists of the set of all states $\underset{\sim}{x}$ which can be joined to the segment (75) by admissible integral curves of (39) along which the performance index $\left[x_{1}(t)+x_{2}(t)\right]^{2}$ is identically non-increasing. This set is bounded in part by the lines $\left|x_{2}\right|=1$ and in part by the curved segments defined by

$$
x_{2}= \begin{cases}+\sqrt{-2 x_{1}-1} & x_{1} \leq-1  \tag{76}\\ -\sqrt{2 x_{1}-1} & x_{1} \geq 1\end{cases}
$$

It is observed that $\partial R_{0}$ is not everywhere differentiable.
The optimal control law in the set $R_{o}$ can be constructed in a variety of ways since the optimal control in that region is non-unique. One possible optimal control law is constructed as follows. Equations (75) and (76) together define a continuous curve $\Omega$ in the $\times_{1}, \times_{2}$ state plane. In the subset of $R_{0}$ which lies to the right of the curve $\Omega$, the optimal control law can be chosen as

u^{o}(\underset{\sim}{x})= \begin{cases}-\operatorname{sgn} \underset{\sim}{\Downarrow}(\underset{\sim}{x}), \psi_{1}(\underset{\sim}{x}) \neq 0, & x_{1}>1  \tag{77}\\ +1, \psi_{1}(\underset{\sim}{x})=0, & x_{1}>1 \\ -\operatorname{sgn} \underset{\sim}{\underset{\sim}{x}),} \underset{\sim}{\zeta} \underset{\sim}{x}) \neq 0, & \left|x_{1}\right| \leq 1 \\ -x_{2}-\underset{\underset{\sim}{x}(\underset{\sim}{x}), \underset{\sim}{x}(x)=0,}{ }\left|x_{1}\right| \leq 1, k \geq 0\end{cases}
$$

where $\psi_{1}(\underset{\sim}{x})=\sqrt{2 x_{1}-T}+x_{2}$ and $\left.\underset{\sim}{\underset{\sim}{x}} \underset{\sim}{x}\right)=x_{1}+x_{2}$. Likewise, in the subset of $R_{0}$ which lies to the left of the curve $\Omega$, the optimal control law can be chosen as

$$
u^{\circ}(\underset{\sim}{x})= \begin{cases}-\operatorname{sgn}{\underset{\sim}{2}}_{2}(\underset{\sim}{x}), \psi_{2}(\underset{\sim}{x}) \neq 0, & x_{1}<-1  \tag{78}\\ -1, \psi_{2}(\underset{\sim}{x})=0 & x_{1}<-1 \\ -\operatorname{sgn} \underset{\sim}{\underset{\sim}{x}} \underset{\sim}{x}, \underset{\sim}{\zeta(x)} \neq 0, & \left|x_{1}\right| \leq 1 \\ \left.-x_{2}-k \underset{\sim}{x}(\underset{\sim}{x}), \underset{\sim}{x}\right)=0, & \left|x_{1}\right| \leq 1, k \geq 0\end{cases}
$$

where $\psi_{2}(\underset{\sim}{x})=-\sqrt{-2 x_{1}-1}+x_{2}$. The arbitrary scalar constant $k$ in (77) and (78) is introduced as a technical device to permit stabilization [39] of the integral curve (75). Altematively, the control law in the last members of (77) and (78) can be replaced by the expression

u^{\circ}(\underset{\sim}{x})=-\operatorname{sgn}\left(x_{1}+x_{2}\right),\left|x_{1}\right| \leq 1 \tag{79}
\end{equation*}

in which case the representative point ${\underset{\sim}{x}}^{(t)}$ will move along the curve (75) in a sliding (chattering) mode [42].

The set $R_{m}$ is determined, as before, by solving the appropriate Mayer type variational problem (24) using the boundary of $R_{0}$ as the terminal manifold. In this way, it is found that the boundary of $R_{m}$ is defined, in part, by the lines $\left|x_{2}\right|=1$ and in part, by the curved segments

x_{2}=\left\{\begin{align*}
-1+2 \sqrt{-x_{1}} & x_{1} \leq-1  \tag{80}\\
1-2 \sqrt{x_{1}} & x_{1} \geq 1
\end{align*}\right.
$$

The optimal control law in the set $R_{m}$ can be written as

$$
\begin{equation*}
\left.u^{0} \underset{\sim}{x}\right)=-\operatorname{sgn} x_{2} \quad \underset{\sim}{x} \in R_{m} \tag{81}
\end{equation*}
$$

The complement of $R_{0} \cup R_{m}$ is a set of the $R_{0}$ type (and is therefore denoted by $R_{0}^{2}$ ) because for each initial state $\underset{\sim}{x_{0}} \in R_{0}^{2}$ there exists an admissible control law and a time $t_{2}>t_{0}$ such that $\underset{\sim}{x}(t) \in R_{0}^{2} \stackrel{\sim}{0}$ and $\frac{0}{d} / d t\left[x_{1}(t)+x_{2}(t)\right]^{2} \leq 0$ for all $t_{0} \leq t \leq t_{2}$
and $\underset{\sim}{x}\left(t_{2}\right) \in \partial R_{m}$ 。 For example, choose the control law

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=-\operatorname{sgn} x_{2} \quad \underset{\sim}{x} \in R_{o}^{2} \tag{82}
\end{equation*}
$$

In the sets $R_{o}$ and $R_{o}^{2}$, (6) is given by

$$
\begin{equation*}
V(\underset{\sim}{x})=\left(x_{1}+x_{2}\right)^{2} \quad \underset{\sim}{x} \in R_{0} \cup R_{0}^{2} \tag{83}
\end{equation*}
$$

In the set $R_{m}, \underset{\sim}{x}(\underset{\sim}{x})=$ constant along optimal trajectories and (6) is given by

$$
\begin{equation*}
V(\underset{\sim}{x})=\left[x_{1} \operatorname{sgn} x_{2}+\frac{1}{2}\left(1+x_{2}^{2}\right)\right]^{2}, \quad \underset{\sim}{x} \in R_{m} \tag{84}
\end{equation*}
$$

Expressions (80), which define the common boundary segments between $R_{m}$ and $R_{o}{ }^{2}$ can be obtained, alternatively, by equating expressions (83) and (84).

The sets $R_{o}, R_{m}$, and $R_{o}{ }^{2}$, together with some representative $V(\underset{\sim}{x})=$ constant contours and a typical optimal trajectory, are illustrated in Fig. 3.

It is interesting to compare the optimal control law (77), (78), (81), (82), for the present example with the optimal control law for the problem of minimizing the Lagrange, integral type, performance index

$$
\begin{equation*}
J[u]=\int_{t_{0}}^{T}\left[x_{1}(t)+x_{2}(t)\right]^{2} d t, \quad(T-\text { unspecified }) \tag{85}
\end{equation*}
$$

subject to the same restrictions (39)-(42). The solution to this latter problem has been described in [39], [43], and [44] and consists of both a bang-bang mode and a singular mode. The singular mode trajectory is identical with the line segment (75) and is joined, at $\left|x_{1}\right|=1$, to two bang-bang switching curves. A comparison of these two solutions is shown in Fig. 4. It may be verified, from Fig. 4 and the fact that the sets $R_{0}, R_{o}^{2}$ share a common boundary, that the control law which minimizes (85) also minimizes (73) for initial conditions $\underset{\sim}{x}$ offficiently near the origin.

## Example 4. As another special case of (1)-(5), let

$$
\begin{gather*}
J[u]=\max _{t_{0} \leq t \leq T} x_{1}^{2}(t)  \tag{86}\\
\stackrel{\dot{x}}{1}=x_{2} \\
\dot{x}_{2}=-x_{1}+u(t)  \tag{87}\\
\underset{\sim}{x}\left(t_{0}\right)={\underset{\sim}{x}}_{0}^{x} \\
\underset{\sim}{x}(T)=\underset{\sim}{\sim} T-\text { unrestricted }  \tag{88}\\
|u(t)| \leq 1 \tag{89}
\end{gather*}
$$

For this problem it may be verified that $R_{0}$ is the connected and closed set of states $\underset{\sim}{x}$ bounded by the curves

$$
\partial R_{0}:\left\{\begin{array}{l}
x_{2}=0  \tag{90}\\
\left(x_{1}+\operatorname{sgn} x_{2}\right)^{2}+x_{2}^{2}=1, \quad\left|x_{1}\right| \leq 2
\end{array}\right.
$$

and lying in the second and fourth quadrants of the $x_{1}, x_{2}$-plane. The aptimal control law for $\underset{\sim}{x} \in R_{0}$ can be chosen as any admissible control law which satisfies (8), (11), (88) and

$$
\begin{equation*}
\frac{d}{d t}\left(x_{1}^{2}(t)\right) \leq 0 \quad t_{0} \leq t \leq T \tag{91}
\end{equation*}
$$

along the corresponding solution of (87). One such control law is given by

$$
\begin{equation*}
u^{0}(\underset{\sim}{x})=\operatorname{sgn}\left[x_{1}^{2}-2\left|x_{1}\right|+x_{2}^{2}\right], \quad \underset{\sim}{x} \in R_{0} \tag{92}
\end{equation*}
$$

with

$$
\operatorname{sgn}[0]=\left\{\begin{array}{l}
+1 \text { if } x_{1}>0 \\
-1 \text { if } x_{1}<0
\end{array}\right.
$$

which may be recognized [1] as the time-optimal control law [in the set $R_{0}$ ] for the dynamical system described by (87).

The set $R_{m}$ is determined，as before，by solving the appropriate Mayer problem （24）．In this way it is found that $R_{m}$ is the two sets of points bounded by the curves

\partial R_{m}:\left\{\begin{array}{l}
x_{2}=0  \tag{93}\\
x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}=0 \\
\left(x_{1}+\operatorname{sgn} x_{2}\right)^{2}+x_{2}^{2}=9 \quad\left|x_{1}\right| \leq 2
\end{array}\right.
$$

In $R_{m}$ the optimal control law can be expressed as

$$
\begin{equation*}
\left.v^{o} \underset{\sim}{x}\right)=-\operatorname{sgn} x_{2}, \quad \underset{\operatorname{sgn}(0)}{x \in R_{m}}=\operatorname{sgn}\left(x_{1}\right) \tag{94}
\end{equation*}
$$

It may be noted that the particular boundary segment of $R_{m}$ defined by the last expression in（93）is an optimal trajectory which belongs to $R_{m}$ 。

The set $R_{0}^{2} \subset\left(E^{2}-R_{0} U R_{m}\right)$ is the largest set of initial states ${\underset{\sim}{*}}_{0}$ with the following property．For each $\underset{\sim}{x} x_{0} \in R_{0}^{2}$ there exists an admissible control $u(t), t_{0} \leq t \leq t{ }_{2}$ ， such that，along the corresponding solution of（87），$C(\underset{\sim}{x}(t)) \leq C(\underset{\sim}{x})$ and $\underset{\sim}{x}(t) \in R_{o}^{2}$ for all $t_{0} \leq t<t_{2}$ and $\underset{\sim}{x}\left(t_{2}\right) \in \partial R_{m}$ ．In contrast with the previous examples，the set $R_{0}^{2}$ for the present example is not the complement of $R_{o} \cup R_{m}$ 。 Instead，it is found that $R_{o}^{2}$ is the two，disconnected，sets of states bounded by the curves

$$
\partial R_{0}^{2}:\left\{\begin{array}{l}
x_{2}=0  \tag{95}\\
x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}=0 \\
x_{1}^{2}-2\left|x_{1}\right|+x_{2}^{2}=0 \\
\left(x_{1}+\operatorname{sgn} x_{2}\right)^{2}+x_{2}^{2}=9
\end{array}\right.
$$

and lying in the second and fourth quadrants of the $x_{1}, x_{2}$－plane。 In $R_{0}^{2}$ the optimal control law can be chosen as

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=\operatorname{sgn} x_{2} \quad \quad \underset{\sim}{x} \in R_{o}^{2} \tag{96}
\end{equation*}
$$

The set $R_{m}^{2}$ is determined，as before，by solving the appropriate Mayer problem （24）using $\partial R_{o}^{2}$ as the＂terminal manifold。＂In this way，it is found that $R_{m}^{2}$ is bounded by the curves

$$
\partial R_{m}^{2}:\left\{\begin{array}{l}
x_{2}=0  \tag{97}\\
x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}=0 \\
\left(x_{1}+\operatorname{sgn} x_{2}\right)^{2}+x_{2}^{2}=9 \\
\left(x_{1}+\operatorname{sgn} x_{2}\right)^{2}+x_{2}^{2}=25
\end{array}\right.
$$

It is noted that the set $R_{m}^{2}$ shares a common boundary with the set $R_{m}$ ．In $R_{m}^{2}$ the optimal control law can be expressed in the same form as（94）．

The remainder of $E^{2}$ is partitioned into the sets $R_{o}^{3}, R_{o}^{4}, \ldots$ and $R_{m}^{3}, R_{m}^{4}, \ldots$ by repeating the process described above．It may be verified that，because the sets $\left(R_{0}, R_{0}^{2}\right),\left(R_{0}^{2}, R_{o}^{3}\right)$ ，etc．share common boundaries，the individual control laws for the families of sets $\left\{R_{o}^{\mathbf{i}}\right\}$ and $\left\{R_{m}^{\boldsymbol{i}^{i}}\right\}$ can be replaced by the one control law

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=-\operatorname{sgn}\left[x_{1}+\frac{1}{4}\left|x_{2}\right| x_{2}\right], \quad \underset{\sim}{x} \in E^{2} \tag{98}
\end{equation*}
$$

which is optimal throughout $E^{2}$ ．Alternatively，the somewhat more complex time－ optimal control law［1］for（87）－（89）can also be used as a C－minimax optimal control law for arbitrary $\underset{\sim}{x} \in \mathrm{E}^{2}$ 。

The particular sets $R_{0}^{\mathbf{i}}, R_{m}^{\mathbf{i}}, \boldsymbol{i}=1, \ldots, 3$ together with some representative $V=$ constant contours and a typical optimal trajectory are illustrated in Figure 5.

Example 5．As a special case of（1）－（5），let

$$
\begin{equation*}
J[u]=\max _{t_{0} \leq t \leq T}\left[x_{1}^{2}(t)+x_{2}^{2}(t)\right] \tag{99}
\end{equation*}
$$

with（2）－（5）the same as（39）－（42）in Example 1 。


For this problem, the set $R_{0}$ is the closed and connected set of states $\underset{\sim}{x}$ bounded by the curves

$$
\partial R_{0}: \begin{cases}x_{2}=0 & \left|x_{1}\right|>1  \tag{100}\\ x_{1}+\frac{1}{2}\left|x_{2}\right| x_{2}= & \operatorname{sgn} x_{2}\end{cases}
$$

It may be noted that $\partial R_{0}$ is not everywhere differentiable.
The optimal control for ${\underset{\sim}{\sim}}^{x} \in R_{0}$ can be chosen as any admissible control which satisfies (8), (11) and (41). An optimal control law must satisfy the additional requirement

$$
\begin{equation*}
\frac{d}{d t}\left[x_{1}^{2}(t)+x_{2}^{2}(t)\right] \leq 0 \quad t_{0} \leq t \leq T \tag{101}
\end{equation*}
$$

along the corresponding solution of (39).
The set $R_{m}$ consists of the largest set of states $\underset{\sim}{x} \epsilon\left(E^{2}-R_{o}\right)$ for which the condition

$$
\begin{equation*}
\left[x_{1}^{2}(t)+x_{2}^{2}(t)\right] \leq\left[x_{1}^{2}\left(t_{1}\right)+x_{2}^{2}\left(t_{1}\right)\right] \quad t_{0} \leq t \leq t, 1 \tag{102}
\end{equation*}
$$

is satisfied naturally along solutions of the Mayer variational problem (24). Proceeding as in Example 1, it is found that the set $R_{m}$ consists of two disconnected sets: (i) the set of states $\underset{\sim}{x}$ lying above the broken curve defined by

$$
\partial R_{m}: \begin{cases}x_{2}=0 & x_{1} \geq 1  \tag{103}\\ x_{1}+\frac{1}{4} x_{2}^{2}=+1 & x_{2} \geq 0\end{cases}
$$

and (ii) the set of states $\underset{\sim}{x}$ lying below the broken curve defined by

$$
\partial R_{m}: \begin{cases}x_{2}=0 & x_{1} \leq-1  \tag{104}\\ x_{1}-\frac{1}{4} x_{2}^{2}=-1 & x_{2} \leq 0\end{cases}
$$

In the set $R_{m}$ the optimal control law can be written as

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=-\operatorname{sgn} x_{2} \quad \underset{\sim}{x} \in R_{m} \tag{105}
\end{equation*}
$$

The complement of $R_{0} U R_{m}$ is a set of the $R_{0}$ type and is therefore denoted by $R_{0}^{2}$. For any state $\underset{\sim}{x} \in R_{0}^{2}$ it is always possible to find an admissible control law such that along the corrrsponding solution of (39) the following conditions are satisfied

$$
\begin{array}{cc}
\underset{\sim}{x}(t) \in R_{0}^{2} & t_{0} \leq t<t_{2} \\
\underset{\sim}{x}\left(t_{2}\right) \in \partial R_{m} & \\
\frac{d}{d t}\left[x_{1}^{2}(t)+x_{2}^{2}(t)\right] \leq 0 & t_{0} \leq t \leq t_{2} \tag{108}
\end{array}
$$

for some $t_{2}>t_{0}$. For example, one such control law is

$$
\begin{equation*}
v^{0}(\underset{\sim}{x})=-\operatorname{sgn} x_{2} \quad \underset{\sim}{x} \in R_{0}^{2} \tag{109}
\end{equation*}
$$

The $x_{1}, x_{2}$ plane is now completely partitioned into sets of the $R_{o}$ and $R_{m}$ type. In the set $R_{o}$ and $R_{o}{ }^{2},(6)$ is given by

$$
\begin{equation*}
V(\underset{\sim}{x})=\left(x_{1}^{2}+x_{2}^{2}\right) \quad \underset{\sim}{x} \in R_{0} \cup R_{0}^{2} \tag{110}
\end{equation*}
$$

and in the set $R_{m^{\prime}}{ }^{(6)}$ is given by (compare with (63))

$$
\begin{equation*}
V(\underset{\sim}{x})=\left[x_{1}+\frac{1}{2}\left|x_{2}\right| x_{2}\right]^{2} \quad \underset{\sim}{x} \in R_{m} \tag{111}
\end{equation*}
$$

Since $V(\underset{\sim}{x})$ is continuous across the common boundary segments of $R_{m}$ and $R_{o}^{2}$ the equations for those boundary segments, previously given in (103) and (104), can be obtained directly by equating (110) and (111).

The sets $R_{o}, R_{m}$, and $R_{o}^{2}$, together with some representative $V(\underset{\sim}{x})=$ constant contours and a typical optimal trajectory are illustrated in Fig。 6.


## 9. Performance Improvement with C-Minimax

 Control - A Geometric InterpretationSuppose that the uncontrolled dynamical system described by

$$
\begin{equation*}
\underset{\sim}{\dot{x}}={\underset{\sim}{F}}^{0}(\underset{\sim}{x}) \tag{112}
\end{equation*}
$$

is asymptotically stable with respect to the terminal manifold (4) for all initial states $\underset{\sim}{x} \in D^{\circ} \subset D$. Suppose further that the same dynamical system, when subjected to an external control $u(t)$, obeys the differential equation

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{F}(x, u(t)) \tag{113}
\end{equation*}
$$

where $\underset{\sim}{F}(\underset{\sim}{x}, 0)=\underset{\sim}{F} \underset{\sim}{0}(\underset{\sim}{x})$.
The maximum value of the performance index $C(\underset{\sim}{x}(t)), t_{0} \leq t \leq T$, which occurs along the solutions of the uncontrolled system (112) [with $\left.\underset{\sim}{x}{ }_{0} \in D^{0}\right]$, can be studied by the same techniques used in Section 3. By this means, the two sets $R_{0}$ and $R_{m}$ defined by

$$
\begin{align*}
& R_{0}=\left\{\left.{\underset{\sim}{x}}_{x} \in D^{0}\right|_{\max _{0} \leq t \leq T} C(\underset{\sim}{x}(t))=C(\underset{\sim}{x})\right\}  \tag{114}\\
& R_{m}=\left\{\left.\underset{\sim}{x} \in D^{0}\right|_{\max _{0} \leq t \leq T} C(\underset{\sim}{x}(t))>C(\underset{\sim}{x})\right\}
\end{align*}
$$

can be constructed in the state space $E^{n}$ of the system (112). Then, proceeding as in (6), one can define a function $V(\underset{\sim}{x})$ on the subset $D^{\circ} \subset E^{n}$ by

$$
\begin{equation*}
\underset{\sim}{V}\left(x_{0}\right)=\max _{t_{0} \leq t \leq T} C(\underset{\sim}{x}(t)) \quad \underset{\sim}{x} \in D^{0} \tag{115}
\end{equation*}
$$

so that

$$
V \underset{\sim}{x})=\left\{\begin{array}{cc}
C(\underset{\sim}{x}), & \forall \underset{\sim}{x} \in \mathbb{R}_{0}  \tag{116}\\
>C \underset{\sim}{x}) & \forall \underset{\sim}{x} \in \mathbb{R}_{\mathrm{m}}
\end{array}\right.
$$

The function $V\left(\underset{\sim}{x_{0}}\right)$ in (115) indicates the quality of $C$-minimax performance which is realized from the transient response of the uncontrolled system (112). The result (116) can be visualized geometrically in the product space $E^{1} X E^{n}: z, x_{1}, x_{2}, \ldots, x_{n}$ by considering the two surfaces $V$ and $C$ defined as

$$
\begin{align*}
& V=\left\{(z, \underset{\sim}{x}) \in E^{1} \times E^{n} \mid z-V(\underset{\sim}{x})=0\right\} \\
& C=\left\{(z, \underset{\sim}{x}) \in E^{1} \times E^{n} \mid z-C(\underset{\sim}{x})=0\right\} \tag{117}
\end{align*}
$$

According to (116), the surface $V_{\text {lies "above" the surface } C}$ at each state $x \in R_{m}$ while, at each state $x \in \mathbb{R}_{0}$, the surfaces $\mathbb{V}_{\text {and }} C$ intersect (coincide). Thus, the set $t R_{0} \subset D^{0}$ is the projection, onto the subspace $E^{n}$, of the "points of contact" between the two surfaces $V$ and $C$.

It follows from (7), (115) and (116) that, for initial states $\underset{\sim}{x} \in \mathbb{R} \mathcal{R}_{0}$, the quality of C-minimax performance of the uncontrolled system (112) cannot be improved by application of external control $u(t)$ 。 That is, the application of external control $u(t)$ cannot improve the quality of performance if the initial state ${\underset{\sim}{0}}$ corresponds to a "point of contact" between the two surfaces $V_{\text {and }} C$. On the other hand, if $x_{0} \in \mathcal{R}_{\mathrm{m}}$ the surface $\mathscr{V}$ lies "above" the surface $C$ and therefore the quality of $C$-minimax performance for that initial state can be improved by the application of external control, provided that an admissible control (satisfying (4)) can be found which moves the surface $V$ "closer" to the surface $C$. The new "points of contact" between $V$ and $C$, achieved by this means, correspond to states $\underset{\sim}{x}$ which leave the set $\mathbb{R}_{m}$ and ioin the set $\mathbb{R}_{0}$. In addition, any initial state $\underset{\sim}{x} \in E^{n}-D^{0}$ which can be controlled to the terminal manifold (4) by some admissible control $u(t)$ becomes a member of one or the other of the sets $R_{0}$ or $R_{m}$ 。 In this way, the set $D$ is obtained as the union of $D^{\circ}$ and the set of all states ${\underset{\sim}{x}}_{0} \in E^{n}-D^{0}$ which can be controlled to $\mathcal{J}_{\text {with }}$ an admissible control.

Thus, the effect of applying a C-minimax optimal control to the system (113) can be viewed in $E^{1} \times E^{n}$ as a "depressing" of the surface $V$ down onto the surface $C$
in such a way as to (i) increase the areas of contact between $V$ and $C$ wherever possible and (ii) decrease the original "distance" between $V$ and $C$ at those states $\underset{\sim}{x} \in D$ where contact between $V$ and $C$ cannot be achieved. The absolute "best" performance, in the sense of C -minimax control, is achieved when the two surfaces $q$ and $C$ coincide for every state $\underset{\sim}{x} \in D$.

## 10. A More Gcneral Class of C-Minimax Performance Indices

The particular class of C-minimax performance indices considered in the present study does not admit those cases in which the performance index $C(\cdot)$ is an explicit function of the control $u(t)$. On the other hand, there appear to be many practical situations where such a performance index is physically meaningful. It is of some interest, therefore, to consider the possibility of extending the techniques described above to the more general class of $C$-minimax performance indices of the form $C=$ $C(\underset{\sim}{x}, u)$. Two methods for accomplishing this are described below.

One method which permits application of the $C$-minimax theory developed above to the case $C=C(\underset{\sim}{x}, u)$ consists of introducing the new state variaiablex ${ }_{n+1}=u(t)$ and considering $w(t)=d u(t) / d t$ as the new control variable. In this way, the additional state variable equation

$$
\begin{equation*}
\dot{x}_{n+1}=w(t) \tag{118}
\end{equation*}
$$

can be appended to (2) and the resulting performance index $C(\underset{\sim}{x}, u)=C\left(\underset{\sim}{x}, x_{n+1}\right)$ can be expressed in the form of (1). Application of this method is complicated by the necessity for selecting a suitable class of admissible control functions $w(t)$ [it may be necessary to introduce an artificial bound on admissible values of $w(t)$ ] and by the presence of "hard" (inequality) constraints imposed on the new state variable $x_{n+1}$ through the original control set (5).

An alternative method for treating the case $C=C(\underset{\sim}{x}, u)$ consists of introducing, as before, the new state variable $x_{n+1}=u(t)$ and requiring that $x_{n+1}$ satisfy the special state variable equation

$$
\begin{equation*}
\dot{x}_{n+1}=-k\left(x_{n+1}-w(t)\right) \tag{119}
\end{equation*}
$$

where $k$ is a positive scalar constant and $w(t)$ is a new control function which belongs to the same class of admissible functions as the original control $u(t)$. By this means, (119) can be appended to (2) and the performance index $C\left(\underset{\sim}{x}, x_{n+1}\right)$ is reduced to the form (1). The exact solution to the original problem [i.e.: the attainment of the condition $\left.x_{n+1}(t)=u(t) \equiv w(t)\right]$ is obtained, through a limiting process, by letting $k \rightarrow \infty$ in (119). This method has the advantages that the new optimal control function $w(t)$ is sought in the same class of functions as $u(t)$ and, except for the initial condition requirement $x_{n+1}\left(t_{0}\right) \in U$, no inequality constraints are imposed on $x_{n+1}(t)$ 。

The two techniques described above can be used to study a variety of the cases $C(\underset{\sim}{x}, u)$. However, if $C(\cdot)$ has the special form $C=C(u)$, the $C$-minimax optimal control can be obtained by means of an essentially different method based on the theory of functional analysis. Some particular results which have been obtained by this method are described in [45]-[50].

## 11. Areas for Further Research

The deterministic C-minimax problem considered in the present study can be generalized to include dynamical systems with non-deterministic parameters. In particular, one might consider dynamical systems described by stochastic differential equations and replace $C \underset{\sim}{x}(t))$ in the functional (1) by the expectation of $C(\underset{\sim}{x}(t))$. Stochastic optimal control problems of this type have apparently been studied relatively little[51], [52].

## Appendix

An Integral Representation for the Maximum of a Non-Negative Continuous Function - An Elementary Proof

Theorem
Let $f(t), t \in\left[t_{o}, T\right]$, be a real, non-negative definite, single-valued, bounded, and continuous scalar function defined on $\left[t_{0}, T\right]$ 。Suppose

$$
\begin{equation*}
\max _{t \in\left[t_{0}, T\right]} f(t)=M \tag{120}
\end{equation*}
$$

Then

$$
\begin{equation*}
\lim _{\mu \rightarrow \infty}\left[\int_{t_{0}}^{T}[f(t)]^{\mu} d t\right]^{1 / \mu}=M \tag{121}
\end{equation*}
$$

Proof
Choose a constant $0<\epsilon<M$ and define the comparison function $\hat{f}(t)$, $t \in\left[t_{0}, T\right]$, as follows

$$
\hat{f}(t)= \begin{cases}0, & \text { if } f(t)<(M-\epsilon)  \tag{122}\\ M-\epsilon, & \text { if } f(t) \geq(M-\epsilon)\end{cases}
$$

Clearly,

$$
\begin{equation*}
\hat{f}(t) \leq f(t) \leq M \quad \forall t \in\left[t_{0}, T\right] \tag{123}
\end{equation*}
$$

so that

$$
\left[\begin{array}{r}
{\left[\int_{t_{0}}^{T}[\hat{f}(t)]^{\mu} d t\right]^{1 / \mu} \leq\left[\int_{t_{0}}^{T}[f(t)]^{\mu} d t\right]^{1 / \mu} \leq\left[\int_{t_{0}}^{T} M^{\mu} d t\right]^{1 / \mu}}  \tag{124}\\
\forall t \in\left[t_{0}, T\right], \mu>0
\end{array}\right.
$$

which can be written

$$
(M-\epsilon)\left[\begin{array}{l}
k  \tag{125}\\
\sum_{1} \delta_{i}(\epsilon)
\end{array}\right]^{1 / \mu} \leq\left[\int_{t}^{T}[f(t)]^{\mu} d t\right]^{1 / \mu} \leq M\left[T-t_{0}\right]^{1 / \mu}
$$

where the $\delta_{i}(\epsilon), i=1, \ldots, k$, denote the $k$ positive intervals of time for which $f(t) \geq(M-\epsilon)$. Note that $0<\sum_{j}^{k} \delta_{i}(\epsilon) \leq\left(T-t_{o}\right)$ for all $0<\epsilon<M$. Taking the limit as $\mu \rightarrow \infty$ in (125) there obtains

$$
\begin{equation*}
(M-\epsilon) \leq \lim _{\mu \rightarrow \infty}\left[\int_{t_{0}}^{T}[f(t)]^{\mu} d t\right]^{1 / \mu} \leq M \tag{126}
\end{equation*}
$$

Since (126) is valid, in particular, for arbitrarily small positive $\varepsilon$ the result (121) follows as $\epsilon \rightarrow 0$.

It can be shown [40] that the result (121), with $M$ interpreted as the essential supremum of $f(t)$, remains valid (almost everywhere on [ $t_{0}, T$ ]) even when $f(t)$ is only a measureable function.

III. Three Examples of Differential Game Problems in Optimal Control Theory

C. D. Johnson

The purpose of this study is to illustrate, by examples, the type of optimal control problems which can be solved by application of the theory of differential games. The method of solution is based on the combined application of the classical Hamilton-Jacobi-Carathéodory theory of a value function and the Principle of Optimality. The theoretical foundations for this method are omitted here since they are described, in detail, in the recently published treatise on differential games by R. Isaacs [1]. The reader is assumed to have some familiarity with this basic reference. The first example illustrates a differential game with quadratic performance index and hard inequality constraints on both controls. The second example illustrates a bounded control differential game which possesses a singular solution - a situation which is quite common in this class of problems. The last example is the differential game analogue of the classical optimal linear regulator problem.

## Example 1-A First Order System

In the class of piecewise continuous functions, find a pair of minimax controls $\left\{u^{\circ}(t), w^{\circ}(t)\right\}$ such that the minimax condition

$$
\begin{equation*}
J\left[u^{\circ}, w|\leq J| u^{0}, w^{0}\right] \leq J\left[u, w^{0}\right] \tag{1}
\end{equation*}
$$

is satisfied for all admissible controls $u(t), w(t)$ where

$$
\begin{align*}
J[u, w] & =\frac{1}{2} \int_{0}^{T}\left[x^{2}(t)+u^{2}(t)\right] d t  \tag{2}\\
\dot{x} & =-a x+u+w \tag{3}
\end{align*}
$$

and

$$
\begin{aligned}
& x(0)=x_{0} \\
& x \cdot(T)=0
\end{aligned}
$$

T - unrestricted

$$
\begin{align*}
& |w(t)| \leq M \\
& |u(t)| \leq N \quad(N>M>0) \tag{4}
\end{align*}
$$

In (3), a is a real scalar constant and $u(t), w(t)$ are real scalar functions of time.
Proceeding in the spirit of differential game theory, we define the value of the game payoff $V(x)$ as

$$
\begin{aligned}
V(x)= & \min \max J[u, w], x_{0}=x \\
& u \in U W \in W
\end{aligned}
$$

where $U$ and $W$ represent the set of admissible values for the controls $u$ and $w$ respectively. It is assumed here, and in all examples which follow, that the game has a proper saddle point so that

$$
\begin{equation*}
\min _{u \in U} \max _{w \in W} J[u, w]=\max \min _{W \in W} J[u, w] \tag{6}
\end{equation*}
$$

Then, the value $V(x)$ satisfies the Hamilton-Jacobi equation
$a x \frac{\partial V}{\partial x}-M\left|\frac{\partial V}{\partial x}\right|+N \frac{\partial V}{\partial x} \operatorname{sat}\left(\frac{1}{N} \frac{\partial V}{\partial x}\right)-\frac{N^{2}}{2} \operatorname{sat}^{2}\left(\frac{1}{N} \frac{\partial V}{\partial x}\right)-\frac{1}{2} x^{2}=0$
and the minimax controls $u^{\circ}(t), w^{\circ}(t)$ are given by

$$
\begin{align*}
& u^{\circ}(t)=-N \operatorname{sat}\left[\frac{1}{N} \frac{\partial V(x(t))}{\partial x}\right] \\
& w^{\circ}(t)=M \operatorname{sgn}\left[\frac{\partial V(x(t))}{\partial x}\right] \tag{8}
\end{align*}
$$

The pair $\left\{u^{\circ}(t), w^{\circ}(t)\right\} \quad$ can be determined by solving (7) directly, or, alternatively, by solving for the characteristic strips of (7). Here, we solve (7) directly.

Assume that

$$
\begin{equation*}
0<\frac{\partial V}{\partial x} \leq N \tag{9}
\end{equation*}
$$

Then, $w^{\circ}=+M$ and, noting the required boundary conditions (4), it follows from (7) that

$$
\begin{equation*}
\frac{\partial V}{\partial x}=-(a x-M)+(\operatorname{sgn} x) \sqrt{(a x-M)^{2}+x^{2}} \tag{10}
\end{equation*}
$$

From (9), it is clear that (10) is valid in the region

$$
\begin{equation*}
0<x \leq+a N+\sqrt{N^{2}\left(a^{2}+1\right)-2 N M} \tag{11}
\end{equation*}
$$

In a similar manner, it is found that in the region

$$
\begin{equation*}
-N \leq \frac{\partial V}{\partial x}<0 \tag{12}
\end{equation*}
$$

(7) is satisfied by

$$
\begin{equation*}
\frac{\partial V}{\partial x}=-(a x+M)+(\operatorname{sgn} x) \sqrt{(a x+M)^{2}+\dot{x}^{2}} \tag{13}
\end{equation*}
$$

which holds in the region

$$
\begin{equation*}
-a N-\sqrt{N^{2}\left(a^{2}+1\right)-2 N M} \leq x<0 \tag{14}
\end{equation*}
$$

It may be noted that (11) and (4) define real upper and lower boundaries, respectively, only if

$$
\begin{equation*}
N \geq \frac{2 M}{a^{2}+1} \tag{15}
\end{equation*}
$$

Finally, from (10) and (13) the minimax optimal controls (8) can be written in the state variable feedback form

$$
\begin{gather*}
u^{\circ}(x)=N \operatorname{sat} N^{-1}\left[a x-(\operatorname{sgn} x)\left(M+\sqrt{(a x-M \operatorname{sgn} x)^{2}+x^{2}}\right)\right] \\
w^{\circ}(x)=M \operatorname{sgn} x \tag{16}
\end{gather*}
$$

## Example 2 - A Second Order System

In the class of piecewise continuous functions, find a pair of minimax controls $\left\{u^{\circ}(t), w^{\circ}(t)\right\}$ such that (1) is satisfied for all admissible controls $u(t), w(t)$ where

$$
\begin{align*}
& J[u, w]=1 / 2 \int_{0}^{T}\left[x_{1}^{2}(t)+x_{2}^{2}(t)\right] d t  \tag{17}\\
& \dot{x}_{1}=x_{2}+w  \tag{18}\\
& \dot{x}_{2}=u  \tag{19}\\
& x(0)={\underset{\sim}{o}}^{x} \\
& x_{1}(T)=0 \\
& x_{2}(T)=\text { unrestricted } \\
& T-\text { unrestricted }
\end{align*}
$$

$$
\begin{align*}
& |w(t)| \leq M \\
& |u(t)| \leq N \tag{20}
\end{align*}
$$

In this case, the value $V(\underset{x}{ })$ of the game satisfies the Hamilton-Jacobi equation

$$
\begin{equation*}
x_{2} \frac{\partial V}{\partial x_{1}}+M\left|\frac{\partial V}{\partial x_{1}}\right|-N\left|\frac{\partial V}{\partial x_{2}}\right|+\frac{1}{2} x_{1}^{2}+\frac{1}{2} x_{2}^{2}=0 \tag{21}
\end{equation*}
$$

and the minimax controls are given by

$$
\begin{align*}
& u^{\circ}(t)=-N \operatorname{sgn} \frac{\partial V}{\partial x_{2}}(\underset{\sim}{x}(t)) \\
& w^{\circ}(t)=-M \operatorname{sgn} \frac{\partial V}{\partial x_{1}}(\underset{\sim}{x}(t)) \tag{22}
\end{align*}
$$

In this example, it is not so easy to solve (21) directly. However, if there exists a singular solution [2], it may be possible to effectively solve for $\left\{\nu^{\circ}, w^{\circ}\right\}$ by tracing out the characteristic strips of (21) starting on the singular manifold.

Proceeding as in [2] we find that there are two possible singular solutions. The particular singular condition

$$
\begin{equation*}
\frac{\partial V}{\partial x_{1}}(\underset{\sim}{x}(t)) \equiv 0 \tag{23}
\end{equation*}
$$

implies that

$$
\begin{gather*}
x_{1}(t) \equiv \circ \\
\frac{d}{d t}\left|x_{2}(t)\right|=\min \tag{24}
\end{gather*}
$$

This yields the minimin solution; i.e., both controls "working together" to achieve an absolute minimum of (17). This solution is of no interest in the present study.

The other singular condition

$$
\begin{equation*}
\frac{\partial V(\underline{x}(t))}{\partial x_{2}} \equiv 0 \tag{25}
\end{equation*}
$$

implies that

$$
\begin{gather*}
u_{s}^{o}(t)=x_{1}(t), \quad\left|x_{1}(t)\right| \leq N \\
w_{s}^{o}(t)=-M \operatorname{sgn} x_{2}(t) \tag{26}
\end{gather*}
$$

From (21), (26) and the given terminal and constraint conditions (20), the singular manifold for this case is found to be described by the expression

$$
\begin{equation*}
x_{2}=\operatorname{sgn} x_{2}\left[M+\sqrt{M^{2}+x_{1}^{2}}\right] \tag{27}
\end{equation*}
$$

which is defined over the regions

$$
\begin{array}{ll}
-N \leq x_{1} \leq 0 & \text { if } x_{2}>0 \\
0 \leq x_{1} \leq+N & \text { if } x_{2}<0 \tag{28}
\end{array}
$$

There is some reason to suspect that this singular solution does play a role in the present minimax problem. For instance, as $M \rightarrow 0$ ( $\mathrm{i}_{\mathrm{e}} \mathrm{e}$. as the "player" $w(t)$ becomes less and less potent) the singular manifold (27), (28) degenerates to

$$
\begin{equation*}
x_{2}=-x_{1} \quad, \quad\left|x_{1}\right| \leq N \tag{29}
\end{equation*}
$$

However, the solution to the case $M=0$ is already available [3] and it is true that, for that problem, the singular manifold (29) is optimal. A rigorous proof of the minimax optimality of the singular manifold (27), (28) can be established by showing that the derived function $J[u, w], x_{0}=x$, evaluated throughout an $\epsilon$ neighborhood of the singular manifold (27), (28), does indeed satisfy the Hamilton-Jacobi equation (21). This process usually involves somewhat lengthy calculations and will not be attempted here. Hereafter, we proceed on the assumption that this proof has been established.

On the singular manifold (27), (28) the values of $\partial V / \partial x_{1}, \partial V / \partial x_{2}$ are given by

1. In [3], the terminal condition is specified as $x_{1}(T)=x_{2}(T)=0$.

$$
\begin{align*}
& \left.\frac{\partial V}{\partial x_{1}}\right|_{s}=-x_{2} \\
& \left.\frac{\partial V}{\partial x_{2}}\right|_{s}=0 \tag{30}
\end{align*}
$$

Also, the general expressions for the characteristic strips of (21) are (setting: $p_{1}=$ $-\partial V / \partial x_{1}, \quad P_{2}=-\partial V / \partial x_{2} ;$ see [4])

$$
\begin{gather*}
\dot{p}_{1}=x_{1} \\
\dot{p}_{2}=-p_{1}+x_{2} \tag{31}
\end{gather*}
$$

Thus, by computing the reverse time solutions to (18), (19) and (31), using the initial conditions (30) with $u^{\circ}(T)= \pm N$, we may "flood" the $x_{1}-x_{2}$ space with minimax "optimal" trajectories which have one end lying on the singular manifold. This process does not completely "cover" the $x_{1}-x_{2}$ space with trajectories. The voids are filled by reverse time trajectories of (18), (19) and (31) which start on the specified terminal manifold: $x_{1}(T)=0$. In this case, we replace the initial conditions (30) by corresponding values computed from the transversality condition which yields

$$
\begin{gather*}
\left.\frac{\partial V}{\partial x_{1}}\right|_{t=T}= \begin{cases}\frac{x_{2}^{2}}{2\left(M-x_{2}\right)} ; & x_{2}>M \\
\frac{-x_{2}^{2}}{2\left(M+x_{2}\right)} ; & x_{2}<-M\end{cases} \\
\left.\frac{\partial V}{\partial x_{2}}\right|_{t=T}=0 \tag{32}
\end{gather*}
$$

It may be noted that there are no minimax optimal trajectories which terminate on the sector of the terminal manifold defined by：$x_{1}=0,\left|x_{2}\right|<M$ ．This result is characteristic of＂minimax＂differential games．

As the flood paths described above are traced out in backward time，the set of points $\left\{{\underset{\sim}{x}}_{i}(t)\right\}_{P_{2}}$ ，at which $P_{2}(t)=0$ ，build up a＂switching manifold＂across which $u^{\circ}(t)$ switches from $\pm N$ to $\overline{+} N_{0}{ }^{2}$ This $u^{\circ}$ switching boundary joins with the singular manifold（27），（28）．This completes the solution to this minimax problem． The results are summarized in Figure 1 。

Example 3－An $n^{\text {th }}$ Order System
In the class of piecewise continuous functions，find a pair of minimax controls $\left\{u^{0}(t), w^{\circ}(t)\right\}$ such that（ 1 ）is satisfied for all admissible controls $u(t)$ ， $w(t)$ ，where ${ }^{3}$

$$
\begin{gather*}
J[u, w]=\frac{1}{2} \int_{0}^{T}\left[\langle\underset{\sim}{x}(t), \underset{\sim}{Q} \underset{\sim}{x}(t)\rangle+c^{2} u^{2}(t)-r^{2} w^{2}(t)\right] d t  \tag{33}\\
\underset{\sim}{\dot{x}}=\underset{\sim}{A} \underset{\sim}{x}+{\underset{\sim}{f}}_{f}^{f}+w \underset{\sim}{b} \tag{34}
\end{gather*}
$$

and

$$
\begin{align*}
& \underset{\sim}{x}(0)={\underset{\sim}{x}}_{0}^{x} \\
& \underset{\sim}{x}(T)=\underset{\sim}{0} \\
& T-\text { unrestricted } \tag{35}
\end{align*}
$$

In（33），$\underset{\sim}{x}$ is a real $n$－vector，$\underline{Q}$ is a real $n \times n$ ，constant，positive definite matrix， and $c$ and $r$ are real，non－zero scalars． $\ln (34), \underset{\sim}{A}$ is a real $n \times n$ ，constant matrix and $\underset{\sim}{f}$ and $\underset{\sim}{b}$ are real $n$－vectors．In this example，the values of $u(t), w(t)$ are not restricted．

2
It turns out that the function $\mathrm{p}_{1}(\mathrm{t})$ has no zeros along the flood paths．Thus， $w^{\circ}(t)=M \operatorname{sgn} x_{1}(t)$ 。

Here，$\langle\underset{\sim}{x}, \underset{\sim}{y}\rangle$ denotes the inner product of $\underset{\sim}{x}$ and $\underset{\sim}{y}$ 。


Figure 1 -- Field of Minimax Optimal Trajectories for Example 2.

We need to assume this game is proper. That is, for any initial condition ${\underset{\sim}{0}}^{0}$ and any admissible $w(t)$ there is at least one admissible $u(t)$ which can satisfy the terminal conditions (35). This requirement is the differential game analog of controllability. Under these assumptions, the value of the game $\mathrm{V}(\underset{\sim}{\mathrm{x}})$ satisfies the Hamilton-Jacobi equation

$$
\begin{equation*}
\langle\underset{\sim}{V} V, \underset{\sim}{A}\rangle\rangle-\frac{1}{2} c^{-2}\langle\underset{\sim}{\nabla} V, \underset{\sim}{f}\rangle^{2}+\frac{1}{2} r^{-2}\langle\underset{\sim}{\nabla} V, \underset{\sim}{b}\rangle^{2}+\frac{1}{2}\langle\underset{\sim}{x}, \underset{\sim}{Q} \underset{\sim}{x}\rangle=0 \tag{36}
\end{equation*}
$$

where $\underset{\sim}{\nabla} V=\left(\frac{\partial V}{\partial x_{1}}, \ldots, \frac{\partial V}{\partial x_{n}}\right)$, and the minimax controls are given by

$$
\begin{align*}
& u^{0}(t)=-c^{-2}\langle\underset{\sim}{\nabla} V(\underset{\sim}{x}(t)), \underset{\sim}{f}\rangle \\
& w^{o}(t)=r^{-2}\langle\underset{\sim}{\nabla} V(\underset{\sim}{x}(t)), \underset{\sim}{b}\rangle \tag{37}
\end{align*}
$$

In this particular example, the direct solution of (36) can be carried out by assuming the solution $V(\underset{\sim}{x})$ is a quadratic form in $\underset{\sim}{x}$. More precisely, let

$$
\begin{equation*}
V(\underset{\sim}{x})=\frac{1}{2}\langle\underset{\sim}{x}, \underset{\sim}{M} \underset{\sim}{x}\rangle \tag{38}
\end{equation*}
$$

where $\underset{\sim}{\mathcal{M}}$ is a real, constant, positive definite, ${ }^{4} n \times n$ matrix. Then, (38) is a solution of (36) if $\underset{\sim}{M}$ satisfies the matrix equation

$$
\begin{equation*}
\underset{\sim}{M A}+\underset{\sim}{A}{ }_{\sim}^{\prime} \underset{\sim}{M}+\underset{\sim}{M}\left(r^{-2} \underset{\sim}{b b^{\prime}}-c^{-2} \underset{\sim}{f f^{\prime}}\right) \underset{\sim}{M}+\underset{\sim}{Q}=0 \tag{39}
\end{equation*}
$$

Under appropriate conditions on the matrix $\left[r^{-2} \underset{\sim}{\underset{\sim}{b}}{ }^{\prime}-c^{-2} \underset{\sim}{f f^{\prime}}\right]$, (39) has a unique real, positive definite solution $\underset{\sim}{\mathcal{M}}$ 。Using this solution, the minimax controls (37) can be written in the state variable feedback form

$$
\begin{align*}
& u^{o}(\underset{\sim}{x})=-c^{-2}\langle\underset{\sim}{\mathcal{M}} \underset{\sim}{x}, \underset{\sim}{f}\rangle \\
& w^{o}(\underset{\sim}{x})=r^{-2}\langle\underset{\sim}{\mathcal{M}} \underset{\sim}{x}, \underset{\sim}{b}\rangle \tag{40}
\end{align*}
$$

[^5]It may be noted from (40) that $u^{\circ}(\underset{\sim}{x})$ and $w^{\circ}(\underset{\sim}{x})$ are linear functions of the state variables $x_{1}, \ldots, x_{n}$.

The case of the above problem with bounded controls, $|v(t)| \leq N,|w(t)| \leq \bar{M}$, can be solved, in principle, by employing the techniques which were used to solve the Problem of Letov [5].

IV. A Note on the Transformation to Canonical (Phase-Variable) Form

> C. D. Johnson and W. M. Wonham

Introduction
Consider the control system defined by

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{A} \underset{\sim}{x}+u(t) \underset{\sim}{f}, \quad \quad=\frac{d}{d t} \tag{1}
\end{equation*}
$$

where $\underset{\sim}{x}=\left(x_{1}, \ldots, x_{n}\right)$ is the state vector of the plant, $\underset{\sim}{A}$ is an $(n \times n)$ constant matrix, $\underset{\sim}{f}=\left(f_{1}, \ldots, f_{n}\right)$ is a constant $n$ vector and $u(t)$ is the scalar control function.

It is well known ${ }^{1,2}$ that, if the pair $(\underset{\sim}{A}, f)$ is controllable, there exists a nonsingular linear transformation

$$
\underset{\sim}{x}=\underset{\sim}{K} \underset{\sim}{y}
$$

which reduces (1) to the canonical (phase-variable) form

$$
\underset{\sim}{\dot{y}}=A_{\sim}^{A} \underset{\sim}{y}+u(t){\underset{\sim}{o}}
$$

where

$$
\underset{\sim}{A_{o}}=\left[\begin{array}{ccccc}
0 & 1 & 0 & \ldots & 0  \tag{2}\\
0 & 0 & 1 & . & . \\
& & & . & 0 \\
& & & & \cdot \\
a_{1} & a_{2} & a_{3} & \ldots & a_{n}
\end{array}\right],{\underset{\sim}{o}}=\left[\begin{array}{c}
0 \\
0 \\
\cdot \\
\cdot \\
0 \\
1
\end{array}\right] .
$$

[^6]In a previous paper, ${ }^{3}$ a general procedure for obtaining the matrix $\underset{\sim}{K}$ was described but no explicit expressions for $\underset{\sim}{K}$ were given. In the present note, an expression for $\underset{\sim}{K}$ is derived in terms of the Vandermonde matrix and a modal matrix of $\underset{\sim}{A}$, on the assumption that the eigenvalues of $\underset{\sim}{A}$ are distinct.

## Main Result

Let the eigenvalues of $\underset{\sim}{A}$ be $\lambda_{1}, \ldots, \lambda_{n}$ and let ${\underset{\sim}{1}}, \ldots,{\underset{\sim}{n}}$ be a corresponding set of eigenvectors. We recall that the Vandermonde matrix of $\underset{\sim}{A}$ is the matrix ${\underset{\sim}{M}}_{v}$ with elements

(\underset{\sim}{M})_{i j}=\lambda_{i}^{i-1} \quad(i, i=1, \ldots, n) . \tag{3}
\end{equation*}

The modal matrix $\underset{\sim}{M}$ is

$$

and has the property

\end{equation*}
$$

where

\Lambda_{\sim}=\operatorname{diag}\left[\lambda_{1}, \ldots, \lambda_{n}\right]
$$

The pair ( $\underset{\sim}{A}, \underset{\sim}{f}$ ) is controllable if the vectors $\underset{\sim}{f}, \underset{\sim}{A}, \ldots,{\underset{\sim}{\prime}}^{n-1} f$, are linearly independent.

It will be shown that the required transformation is

$$
\begin{equation*}
\underset{\sim}{K}=\underset{\sim}{M B}{\underset{\sim}{-1}}_{\sim}^{M} \underset{\sim}{-1} \tag{5}
\end{equation*}
$$

where $\underset{\sim}{B}$ is a diagonal matrix defined in the following theorem.
Theorem
Let $\underset{\sim}{A}, \underset{\sim}{f}$ be real and let $(\underset{\sim}{A}, \underset{\sim}{f})$ be controllable. Suppose the eigenvalues $\lambda_{1}, \ldots, \lambda_{n}$ of $\underset{\sim}{A}$ are distinct. Let $\underset{\sim}{M}$ be the modal matrix of $\underset{\sim}{A}$ and let $\underset{\sim}{\underset{\sim}{M}}$ be the Vandermonde matrix of $\underset{\sim}{A}$. Then a nonsingular diagonal matrix $\underset{\sim}{B}$ exists such that

$$
\begin{equation*}
\underset{\sim}{M} \underset{\sim}{B M} M_{\sim}^{-1} \underset{\sim}{f}=\underset{\sim}{f} . \tag{6}
\end{equation*}
$$

Moreover, the matrix

$$
\begin{equation*}
A_{0}=\underset{\sim}{M} \underset{\sim}{B M_{\sim}^{-1}} \underset{\sim}{A} M_{\sim} B_{\sim}^{-1} M_{V}^{-1} \tag{7}
\end{equation*}
$$

is of canonical form (2) with real elements. If

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{A x}+u(t) \underset{\sim}{f}, \tag{8}
\end{equation*}
$$

then the transformation

$$
\underset{\sim}{x}=\underset{\sim}{M} B_{\sim}^{-1} \underset{\sim}{M}{\underset{V}{-1}}_{\underset{\sim}{y}}
$$

reduces (8) to

$$
\underset{\sim}{\dot{y}}=A_{\sim}^{A} \underset{\sim}{y}+u(t){\underset{\sim}{0}}_{0} .
$$

Proof
The transformation $\underset{\sim}{x x} \underset{\sim}{\sim} \underset{\sim}{z}$ reduces (8) to

$$
\underset{\sim}{\dot{\underset{\sim}{x}}}={\underset{\sim}{z}}^{z}
$$

where

$$
\begin{equation*}
\underset{\sim}{c}=M_{\sim}^{-1} \underset{\sim}{f} . \tag{9}
\end{equation*}
$$

Since ( $\underset{\sim}{A}, \underset{\sim}{f}$ ) is controllable, the vectors $\underset{\sim}{c},{\underset{\sim}{\sim}}_{\sim}^{c}, \cdots, \Lambda_{\sim}^{n-1} \underset{\sim}{c}$ are linearly independent; it follows, since the $\lambda_{i}$ are distinct, that the components $c_{i}$ of $\underset{\sim}{c}$ are all nonzero.

Let $\underset{\sim}{C}=\operatorname{diag}\left(c_{1}, \ldots, c_{n}\right)$; then $\underset{\sim}{M} \underset{\sim}{C}$ is nonsingular. Define

$$
\begin{align*}
\underset{\sim}{b} & =\left(b_{1}, \ldots, b_{n}\right)^{\prime} \\
& =(\underset{\sim}{M} \underset{\sim}{C})^{-1}{\underset{\sim}{f}}^{\prime} ; \tag{10}
\end{align*}
$$

and let

$$
\begin{equation*}
\underset{\sim}{B}=\operatorname{diag}\left(b_{1}, \ldots, b_{n}\right) . \tag{11}
\end{equation*}
$$


The $b_{i}$ are all nonzero. For suppose $b_{i}=0$ if $i=i_{1}, \ldots, i_{k}$. By
 last $k$ rows and $i_{j}, \ldots, i_{k}$ th columns. Then $\bar{\sim} \bar{V}_{V}^{C}$ is nonsingular; the last equation implies $b_{i}=0$ for the remaining $b_{i}$ 's; and this contradicts ( 6 ). Hence $\underset{\sim}{B}$ is nonsingular, $A_{\sim}^{A}$ is well defined by (7); and (4), (7) give

$$
\begin{equation*}
\underset{\sim}{A}={\underset{\sim}{M}}_{V} \underset{\sim}{\sim}{\underset{\sim}{M}}^{-1} \tag{12}
\end{equation*}
$$

Writing $\left[\underset{\sim}{M}{ }^{-1}\right]_{i \mathrm{i}}=\mu_{\mathrm{ij}}$ and using (3) and (12),

$$
\begin{aligned}
& {\left[A_{\sim}\right]_{i j}=\sum_{r=1}^{n} \sum_{s=1}^{n} \lambda_{r}^{i-1} \lambda_{r} \delta_{r s} \mu_{s i}} \\
& = \begin{cases}\delta_{i}+1, i & (i=1, \ldots, n-1 ; i=1, \ldots, n) \\
\sum_{r=1}^{n} \lambda_{r}^{n} \mu_{r i}(i=n ; i=1, \ldots, n) .\end{cases}
\end{aligned}
$$

Thus $\underset{\sim}{A}{ }_{0}$ is of form (2) and, since $\underset{\sim}{A}, \underset{\sim}{A}{ }_{0}$ have the same eigenvalues,

$$
\lambda^{n}-\sum_{i=1}^{n} a_{i} \lambda^{i-1} \equiv\left(\lambda-\lambda_{1}\right) \cdots\left(\lambda-\lambda_{n}\right)
$$

so that the $a_{i}$ are real if $\underset{\sim}{A}$ is real. This completes the proof. The transfomation to canonical form is illustrated in Fig. 1.

## An Example

As an application of the theorem, consider a third-order system (1) with

$$
\underset{\sim}{A}=\left[\begin{array}{rrr}
-2 & -1 & 1  \tag{13}\\
1 & 0 & 1 \\
-1 & 0 & 1
\end{array}\right] ; \quad \underset{\sim}{f}=\left[\begin{array}{l}
1 \\

1
\end{array}\right]
$$

The eigenvalues of $A$ are

$$
\begin{aligned}
& \lambda_{1}=1 \\
& \lambda_{2}=-1+i \\
& \lambda_{3}=-1-i \quad(i=\sqrt{-1})
\end{aligned}
$$

and the modal matrix of $A$ is

$$
\underset{\sim}{\mathcal{M}}=\left[\begin{array}{ccc}
0 & 5 & 5 \\
1 & -3-4 i & -3+4 i \\
1 & 2+i & 2-i
\end{array}\right]
$$

From (3), the Vandermonde matrix of $\underset{\sim}{A}$ is

$$
{\underset{\sim}{M}}_{v}=\left[\begin{array}{ccc}
1 & 1 & 1 \\
1 & -1+i & -1-i \\
1 & -2 i & 2 i
\end{array}\right]
$$

With these values of $\underset{\sim}{f}, \underset{\sim}{M}$ and $\underset{\sim}{M} V_{v}$, the matrix $\underset{\sim}{B^{-1}}$ is found from (6) to be

{\underset{\sim}{B}}^{-1}=\frac{1}{5}\left[\begin{array}{ccc}
20 & 0 & 0 \\
0 & 1-3 i & 0 \\
0 & 0 & 1+3 i
\end{array}\right]
$$

The matrix $\underset{\sim}{K}$ is then given by (5),

\underset{\sim}{K}=\left[\begin{array}{rrr}
0 & -1 & 1 \\
0 & 3 & 1 \\
2 & 1 & 1
\end{array}\right]
$$

and the transformation $\underset{\sim}{x}=\underset{\sim}{K} \underset{\sim}{y}$ takes (13) into the canonical (phase-variable) form

0 & 1 & 0 \\
0 & 0 & 1 \\
2 & 0 & -1
\end{array}\right] ; \quad{\underset{\sim}{0}}=\left[\begin{array}{l}

\end{array}\right] .

## V. Another Note on the Transformation to Canonical (Phase-Variable) Form

Introduction
The problem of determining a nonsingular linear transformation $\underset{\sim}{x}=\underset{\sim}{K} \underset{\sim}{y}$ which will take an arbitrary, completely controllable, single-input, timeinvariant linear dynamical system

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{A x}+u(t) f \quad(\cdot=d / d t) \tag{1}
\end{equation*}
$$

into the canonical (phase-variable) form

$$
\begin{equation*}
\underset{\sim}{\dot{y}}=\underset{\sim}{A} \underset{\sim}{\underset{\sim}{y}}+u(t) f{ }_{\sim} \tag{2}
\end{equation*}
$$

where

$$
{\underset{\sim}{0}}_{A}=\left[\begin{array}{cccccc}
0 & 1 & 0 & 0 & \ldots & 0  \tag{3}\\
0 & 0 & 1 & 0 & \ldots & 0 \\
0 & 0 & 0 & 1 & \ldots & 0 \\
\cdot & & & \ddots & \vdots \\
\cdot & & & & 1 & 0 \\
0 & & & & 0 & 1 \\
a_{1} & a_{2} & \cdots & a_{n-1} & a_{n}
\end{array}\right] ; \quad \underset{\sim 0}{f}=\left[\begin{array}{c}
0 \\
0 \\
. \\
0 \\
0 \\
1
\end{array}\right]
$$

was posed and completely solved in [1]. Since the publication of that result various features of the transformation method described therein have been rediscovered and published as "new results," [2], [3], [4]. The purpose of this note is to point out, in more detail, some of the inherent computational features of the transformation method originally described in [1].

## A General Method for Determining the Matrix K

In Appendix 1 of [1], it was shown that, given an arbitrary completely controllably pair ( $\underset{\sim}{\sim}, \underset{\sim}{f}$ ), the required transformation matrix $\underset{\sim}{K}$ could be effectively computed by the following procedure.

1) Form the controllability matrix ${ }^{1} \underset{\sim}{H}$ defined by
2) Compute ${\underset{\sim}{H}}^{-1}$
3) Compute the coefficients $a_{i}$ of the characteristic polynomial
of ${\underset{\sim}{A}}^{A}\left[\right.$ i.e., last row of ${\underset{\sim}{o}}_{0}]$ by the following rule ${ }^{2}$

$$
\begin{equation*}
a_{i}=\left\langle\bar{h}_{i}, \underset{\sim}{A_{n}^{n}} \underset{\sim}{n} \quad i=1, \ldots, n\right. \tag{5}
\end{equation*}
$$

where $\bar{h}_{i}$ is the $i^{\text {th }}$ row of ${\underset{\sim}{H}}^{-1}$.
4) Form the symmetric matrix $\underset{\sim}{L}$ defined by

$$
L=\left[\begin{array}{ccccccc}
-a_{2} & -a_{3} & -a_{4} & \cdots & -a_{n-1} & -a_{n} & 1  \tag{6}\\
-a_{3} & -a_{4} & & \cdots & -a_{n} & 1 & 0 \\
-a_{4} & & & & 1 & 0 & 0 \\
\vdots & & & \cdots & & & \\
-a_{n-1} & -a_{n} & & & & \\
-a_{n} & 1 & & & & & \\
1 & 0 & & \cdots & & & 0
\end{array}\right]
$$

5) Set

$$
\begin{equation*}
\underset{\sim}{K}=\underset{\sim}{H} \mathrm{~L} . \tag{7-a}
\end{equation*}
$$

This gives, by direct calculation,

$$
\begin{equation*}
\underset{\sim}{K}=[\underset{\sim}{k}, \underset{\sim}{k}, \ldots, \underset{\sim}{k}] \tag{7-b}
\end{equation*}
$$

1. It is recalled that the pair $(\underset{\sim}{A}, \underset{\sim}{f})$ is completely controllable if and only if rank $\underset{\sim}{\mathrm{H}}=\mathrm{n}$.
2. $\langle\underset{\sim}{x}, \underset{\sim}{\underset{y}{y}}\rangle$ denotes the scalar product of $\underset{\sim}{x}$ and $\underset{\sim}{y}$.
where

$$
\begin{align*}
& \underset{\sim}{k}=-\underset{s=1}{\sum} a_{r+s} \underset{\sim}{A}{ }_{\sim}^{s-1} \underset{\sim}{f}+\underset{\sim}{A} \underset{\sim}{n-r_{f}} \quad r=1,2, \ldots, n-1  \tag{7-c}\\
& \underset{\sim}{k}{ }_{n}=\underset{\sim}{f}
\end{align*}
$$

It may be noted that the vectors ${\underset{\sim}{r}}^{k}$ in the first equation of $(7-c)$ satisfy the recursion equation

$$
\underset{\sim}{k}=-a_{r+1} \underset{\sim}{f}+\underset{\sim}{A k} \underset{r+1}{ } \quad r=1,2, \ldots, n-1 \quad \text { (7-d) }
$$

The constructive procedure described above is so designed to provide a "built in" check on the validity of the assumption that the pair ( $\underset{\sim}{A}, f)$ is completely controllable [eg., Step 2)]. Moreover, the apparent excess of information generated in Step 2) [to check controllability it is only necessary to compute $|\underset{\sim}{\mathrm{H}}|$ ] is effectively used in Step 3) to evaluate the characteristic polynomial of $\underset{\sim}{A}$ and thereby avoid the necessity of directly expanding the determinant $\left|A-\lambda I{ }_{\sim}\right|$.

Of course, if one knows a priori that the pair ( $\underset{\sim}{A}, f)$ is completely controllable then Step 2) can be ignored and the elements $a_{i}, \mathbf{i}=1, \ldots, n$ in Step 3) can be determined alternatively by the more common procedure of evaluating the characteristic polynomial of $\underset{\sim}{A}$

$$
\begin{equation*}
|\underset{\sim}{A}-\lambda I|=\lambda^{n}-\sum_{1}^{n} a_{i} \lambda^{i-1} . \tag{8}
\end{equation*}
$$

A possible disadvantage of this alternative, albeit more direct, procedure is that by it the matrix $\underset{\sim}{K}$ defined in (7) can be formally constructed even when the system (1) is not completely controllable. The possibility of using the set of vectors $\underset{\sim}{k}, \ldots,{\underset{\sim}{n}}$ defined in ( $7-c$ ), as a basis for the canonical (phase-variable) form was pointed out in [5]. ${ }^{3}$ This result has also been described in a recent textbook [6].

In practical applications of the transformation to phase-variable form one usually needs both $\underset{\sim}{K}$ and $\underset{\sim}{K^{-1}}$. Using the procedure outlined above, we have

$$
\begin{equation*}
{\underset{\sim}{K}}^{-1}={\underset{\sim}{L}}^{-1} \underset{\sim}{H^{-1}} \tag{9}
\end{equation*}
$$

3. Equations (7-c) coincide with the results given in [5] if the term a $\mathrm{o}_{\sim}$ in [5] is replaced by $a_{1} g$. This is apparently a typographical error.

The matrix $\underset{\sim}{\underset{\sim}{H}}$ has already been computed in Step 2). The expression for ${\underset{\sim}{L}}^{-1}$ is easily computed ${ }^{4}$ to be

{\underset{\sim}{L}}^{-1}=\left[\begin{array}{cccccc}
0 & 0 & & \cdots & & 0  \tag{10}\\
0 & 1 \\
0 & & & 0 & 1 & b_{n} \\
0 & & & 1 & b_{n} & b_{n-1} \\
\cdot & & \cdots & & . \\
0 & 0 & 1 & b_{n} & . & \\
0 & 1 & b_{n} & b_{n-1} & \cdots & b_{3} \\
1 & b_{n} & b_{n-1} & \cdots & b_{3} & b_{2}
\end{array}\right]
$$

where

$$
\begin{gathered}
b_{n}=a_{n} \\
b_{i}=a_{i}+\sum_{i=i+1}^{n} a_{n+i+1-i} b_{i}, i=n-1, n-2, \ldots, 3,2 .
\end{gathered}
$$

Other Methods for Determining the Matrix K
The general procedure described above for computing the pair $(\underset{\sim}{K}, \underset{\sim}{K})$ may offer certain advantages in numerical calculation since it does not require the computation of eigenvalues or eigenvectors and does not involve an explicit evaluation of the determinant $|A-\lambda I|$. On the other hand, it is of some interest to study the algebraic structure of the matrix $\underset{\sim}{K}=\underset{\sim}{K}(\underset{\sim}{A}, \underset{\sim}{f})$ in terms of the fundamental matrix theoretic notions of eigenvalues and eigenvectors. In such a study, the relative efficiency of numerical computing schemes is not of primary importance. The result given in [7] showed how, when the pair (A, f) is completely controllable and $\underset{\sim}{A}$ has distinct eigenvalues, the matrix $\underset{\sim}{K}$ can be written as

$$
\begin{equation*}
\underset{\sim}{K}=\underset{\sim}{M} \underset{\sim}{M}{ }_{v}^{-1} \tag{11}
\end{equation*}
$$

where $\underset{\sim}{M}$ is a certain modal matrix of $\underset{\sim}{A}$ (the columns of $\underset{\sim}{\mathcal{M}}$ are $n$ linearly independent column eigenvectors of the matrix $A$ which have been normalized ${ }^{5}$ in a special way) and ${\underset{\sim}{M}}_{v}$ is the Vandermonde matrix of $\underset{\sim}{A}$. In later and independent studies of this problem, Mufti [8] and Ainsworth and Gunderson [9] generalized the result in [7] to allow for the possibility of non-distinct eigenvalues.

5. In the notation of $[7], \underset{\sim}{\mathcal{M}}=\underset{\sim}{M} B^{-1}$ where the columns of $\mathcal{M}$ are $n$ linearly independent column eigenvectors of $\underset{\sim}{A}$, and $\underset{\sim}{B}$ is a non-singular diagonal matrix which acts as a normalizing factor.

## Relationships with Controllability and Observability

A study of controllability and the structure of $\underset{\sim}{K}$ in terms of the spectral properties of the matrix $\underset{\sim}{A}$, brings to light some facts which may have practical value. Some of these results have been described in [10]. In addition we have the following result

Proposition
Let $\underset{\sim}{A}$ be a real, constant $\mathrm{n} \times \mathrm{n}$ matrix with at least one repeated eigenvalue. Let $\underset{\sim}{R}$ denote a nonsingular matrix which transforms $\underset{\sim}{A}$ to the diagonal form $\underset{\sim}{\underset{\sim}{\sim}}=\operatorname{diag} .\left(\lambda_{1}, \ldots, \lambda_{n}\right)$

$$
\begin{equation*}
{\underset{\sim}{R}}^{-1} \underset{\sim}{A R}=\boldsymbol{\sim} \tag{12}
\end{equation*}
$$

and let I denote a nonsingular matrix which transforms $\underset{\sim}{A}$ to the companion form ${\underset{\sim}{0}}_{A_{0}}$ [defined as in (3)]

$$
\begin{equation*}
{\underset{\sim}{T}}^{-1} \underset{\sim}{A T}={\underset{\sim}{A}}_{0} \tag{13}
\end{equation*}
$$

Then if $\underset{\sim}{R}$ exists ${ }_{\sim}^{T}$ does not exist.
Proof
If $\underset{\sim}{R}$ exists, $\underset{\sim}{A}$ must possess a total of $n$ linearly independent column eigenvectors. On the other hand, if I exists, the minimal polynomial of $\underset{\sim}{A}$ must equal the characteristic polynomial of $\underset{\sim}{A}$. The latter condition is satisfied if and only if $\underset{\sim}{A}$ has no more than one (within a constant multiplier) column eigenvector corresponding to each set of repeated eigenvalues. It follows that, when $\underset{\sim}{A}$ has repeated eigenvalues, $\mathrm{I}_{\sim}$ cannot exist if $\underset{\sim}{R}$ exists.

In the literature on control theory, the concept of complete controllability of the linear dynamical system (1) is often illustrated by transforming the matrix A to diagonal or Jordan canonical form and then observing the effect of this transformation on the vector $\underset{\sim}{f},[11],[12],[13]$. As a complement to this procedure, the above result has the interesting

## Corollary

Suppose the matrix $\underset{\sim}{A}$ in (1) has repeated eigenvalues.
Then, if $\underset{\sim}{A}$ is similar to a diagonal matrix $\underset{\sim}{1}$, the linear dynamical
system (1) is always uncontrollable for any choice of the vector $\underset{\sim}{f}$. Moreover, if $y=\langle\underset{\sim}{c}, x\rangle$ is the scalar "output" of (I) then, under the conditions stated, (1) is always unobservable for any choice of the vector $\underset{\sim}{c}$.

In light of this fact, qualifying statements such as that found in the footnotes on pages 350-35] of [12] are seen to be unnecessary. The Corollary also shows that, from the viewpoint of controllability and observability, the case when $\underset{\sim}{A}$ has repeated eigenvalues actually does exhibit certain special properties. ${ }^{6}$
6. It is recalled that every real, symmetric matrix $A$ is similar to a strictly diagonal matrix $\underset{\sim}{\Lambda}$. Thus, the presence of repeated eigenvalues is a necessary and sufficient condition that (1), with a real symmetric A, be always uncontrollable and unobservable for any choice of the vectors $\underset{\sim}{f}$ and $\underset{\sim}{c}$.

## VI. Invariant Hyperplanes for Linear Dynamical Systems <br> C. D. Johnson

Abstract - In certain problems associated with the control of linear dynamical systems, the concept of invariant hyperplanes in the system state space plays an important role [1]-[8]. This paper gives conditions for the existence of invariant hyperplanes for linear dynamical systems and describes some geometric properties of these hyperplanes. In addition, some relationships between invariant hyperplanes and the concepts of controllability and observability are discussed.

Introduction
An important class of linear dynamical systems, with scalar input and output, can be described by ${ }^{1}$

& \underset{\sim}{\dot{x}}=\underset{\sim}{A x}+u(t) f \quad(\cdot=d / d t)  \tag{la}\\
& y=\langle\underset{\sim}{x}, \underset{\sim}{x}\rangle \tag{lb}

where $\underset{\sim}{x}=\left(x_{1}, \ldots, x_{n}\right)$ is a real $n$-vector (the state vector of the system), $A$ is a real, constant $n \times n$ matrix, $u(t)$ is a real, scalar function of time (the system input or control), $\underset{\sim}{f}$ and $\underset{\sim}{h}$ are real, constant, non-zero $n$-vectors, and $y$ is a real scalar (the system output). Many of the mathematical properties associated with the dynamical system of (1) have convenient geometrical interpretations in the system state space, a euclidean $n$-space $E^{n}$ whose points have coordinates $x_{1}, \ldots, x_{n}$.

This paper concerns a question about the existence of a certain property of the solutions of (la) for the special case when $u(t) \equiv 0$. In particular, the following question is posed. What conditions are required for the existence of a linear form

which is invariant along solutions of

for arbitrary initial conditions satisfying (2) ? $\ln (2), \underset{\sim}{c}=\left(c_{1}, \ldots, c_{n}\right)$ is a real, constant, nonzero $n$-vector. In addition to answering this question, this paper gives a characterization of the stability of (2) along solutions of (3) and shows relationships

between the form (2) and the real eigenvalues and eigenvectors of A. Finally, a solution is given for certain inverse problem associated with (2) and there is presented, for a special class of problems, a simple geometric interpretation of Kalman's concepts of controllability and observability.

The linear form (2) can be associated with an ( $n-1$ )-dimensional hyperplane in the state space $E^{n}$. This hyperplane has the property that if $\langle\underset{\sim}{c}, \underset{\sim}{x}(0)\rangle=0$ then $<\underset{\sim}{c}, \underset{\sim}{x}(t)>\equiv 0$ for all $+>0$ when $\underset{\sim}{x}(t)$ is a solution of (3). In the following, a linear form (2) having the above property is referred to as an invariant hyperplane $\mathcal{H}$ of (3).

If $\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0$ is an invariant hyperplane of (3) and if an arbitrary solution $\underset{\sim}{x}(\dagger)$ of (3) satisfies

then the invariant hyperplane is called stable (unstable).
Let the eigenvalues of $\underset{\sim}{A}$ be $\lambda_{1}, \ldots, \lambda_{n}$ and let $\underset{\sim}{a}, \ldots, \underset{\sim}{a}$ be a corresponding set of column eigenvectors. It is recalled that the column eigenvectors of $A$ are nonzero and satisfy

\underset{\sim}{A} a_{i}=\lambda_{i}{\underset{\sim}{i}} \quad(i=1, \ldots, n) . \tag{5}
\end{equation*}
$$

It is further recalled that corresponding to each eigenvalue $\lambda_{i}, i=1, \ldots, n$, there is an associated nonzero row eigenvector $\beta_{i}^{\prime}$, which satisfies

\beta_{i}^{\prime} \underset{\sim}{A}=\lambda_{i} \underset{\sim}{\beta}{ }_{i}^{\prime} \quad(' \text { denotes transpose }) . \tag{6}
\end{equation*}

Results
The conditions for the existence of invariant hyperplanes of (3) are summarized in the following.

Theorem 1
Let $A$ be a real, constant $n \times n$ matrix and let the real, nonzero eigenvalues of $A$ be denoted by $\lambda_{1}, \ldots, \lambda_{m} ; m \leq n$. Then, corresponding to each eigenvalue $\lambda_{i}(i=1, \ldots, m)$, there exists a real, constant, nonzero $n$-vector $\underset{\sim}{c} \underset{i}{ }$ satisfying

\begin{equation*}
\underset{\sim}{A^{\prime}} \underset{\sim}{c}=\lambda_{i} \underset{\sim}{c} i \quad i=1, \ldots, m \tag{7}
\end{equation*}
$$

and such that

$$
\begin{equation*}
\left\langle\underset{\sim}{c} i^{\prime} \underset{\sim}{x}(t)>\equiv 0 .\right. \tag{8}
\end{equation*}
$$

along every solution of $\underset{\sim}{\dot{\underset{\sim}{x}}}=\underset{\sim}{A} \underset{\sim}{x}$ which satisfies

$$
\begin{equation*}
\langle\underset{\sim}{c}, \underset{\sim}{x}(0)>=0 \tag{9}
\end{equation*}
$$

Moreover, ${\underset{\sim}{c}}_{\mathbf{j}}$ is a row eigenvector corresponding to $\lambda_{i}$ and the invariant hyperplane

$$
\begin{equation*}
\mathcal{H}_{i}=\left\{\underset{\sim}{x} \mid\left\langle{\underset{\sim}{i}}^{\prime}, \underset{\sim}{x}\right\rangle=0\right\} \tag{10}
\end{equation*}
$$

is stable (unstable), in the sense of (4), if $\lambda_{i}<0(>0)$.
Proof: Let $\underset{\sim}{B}$ denote the $n \times n$ matrix whose columns are

\underset{\sim}{c}, \underset{\sim}{A} \underset{\sim}{c},{\underset{\sim}{A}}_{\sim}^{\prime} \underset{\sim}{c}, \ldots, A_{\sim}^{n-1} \underset{\sim}{c} . \tag{11}

Then, from repeated differentiation of (2) it may be seen that (8) is satisfied along solutions of (3) for each $\underset{\sim}{x}(0)$ satisfying (9), if and only if rank $\underset{\sim}{\underset{\sim}{8}}=1$. This latter condition is satisfied if and only if

$$
\begin{equation*}
{\underset{\sim}{A}}_{\underset{\sim}{c}}^{\underset{\sim}{c}}=\underset{\sim}{c} \tag{12}
\end{equation*}
$$

for some real scalar $p$. It follows from (6) that (12) has real, nonzero solutions $\boldsymbol{p}_{i}=\lambda_{i}, \underset{\sim}{c}=\underset{\sim}{\beta} \underset{i}{ }$ corresponding to each real nonzero eigenvalue $\lambda_{i}, i=1, \ldots, m$. Setting ${\underset{\xi}{i}}=\left\langle\underset{\sim}{c} i^{\prime}, \underset{\sim}{x}\right\rangle, \underset{\sim}{c}=\underset{\sim}{\beta_{i}}$, the derivative of $\xi_{i}$ along an arbitrary solution of (3) is found to be

\frac{d_{\xi}(t)}{d t}=\lambda_{i} \xi_{i}(t) \quad i=1, \ldots, m . \tag{13}
\end{equation*}
$$

It follows that the invariant hyperplane $\mathcal{H}_{i}=\left\{x \mid\left\langle\underset{\sim}{\beta} i^{\prime} \underset{\sim}{x}\right\rangle=0\right.$ is stable (unstable) if $\lambda_{i}<0(>0) i=1, \ldots, m$.
Corollary
Let $\underset{\sim}{a}, \ldots, \sim_{\sim}^{a}$ be the set of real column eigenvectors of $\underset{\sim}{A}$ and let $\left.\underset{\sim}{c}\right]_{1}$, $\ldots, \sim_{m}^{c}$ be the set of normal vectors associated with the corresponding $m$ invariant hyperplanes of $\underset{\sim}{\dot{x}}=\underset{\sim}{A x}$. Then the vectors ${\underset{\sim}{c}}_{i}, \underset{\sim}{a}$ satisfy the following orthogonality equation

$$
\begin{equation*}
\left\langle c_{i}, a_{k}\right\rangle=0 ; \lambda_{i} \neq \lambda_{k}(i, k=1, \ldots, m) . \tag{14}
\end{equation*}
$$

Proof: The proof follows immediately from the well-known result that the row eigenvector corresponding to any eigenvalue is orthogonal to the column eigenvector corresponding to any different eigenvalue.

## Remarks

1) If $\underset{\sim}{A}$ has repeated real eigenvalues, it is sometimes, but not always, possible to find more than one linearly independent row eigenvector corresponding to the same (nondistinct) eigenvalue. Since any linear combination of such row eigenvectors is also a row eigenvector, it follows that in such a case an infinitude of distinct invariant hyperplanes will be associated with the same (nondistinct) eigenvalue.
2) The assumption that the real $\lambda_{i}$ are nonzero $(i=1, \ldots, m)$ assures that (13) has a unique equilibrium state $\xi^{(t)} \equiv 0$. In this case, the corresponding invariant hyperplanes $H_{i}$ always pass through the origin $\underset{\sim}{x}=\underset{\sim}{0}$. In the case of a distinct zero eigenvalue the corresponding vector $\underset{\sim}{c}$ still satisfies (7) but the equilibrium states of (13) are then defined by

$$

\xi=\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=z \tag{15}
\end{equation*}
$$

where $z$ is an arbitrary real scalar constant. Thus, to each distinct zero eigenvalue there corresponds an infinite number of parallel invariant hyperplanes (15). The parallel hyperplanes corresponding to a zero eigenvalue are neutrally stable in the sense that along solutions of (3)

for $\underline{\text { all }}$ values of $\left\langle\underset{\sim}{c}{ }_{m}{\underset{\sim}{x}}_{\underset{\sim}{x}}(t)>\right.$.
3) The Corollary shows that the eigenvector $\underset{\sim}{a}$, corresponding to the real eigenvalue $\lambda_{k}$, lies on the intersection of the set of invariant hyperplanes

$$
\mathcal{H}_{i}=\{x \mid\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0\} \text { where } \underset{\sim}{c} i \underset{\sim}{B} \underset{i}{B}\left(\lambda_{i}\right), \lambda_{i} \neq \lambda_{k}, i, k=1, \ldots, m \text {. In certain }
$$ special cases, this result leads to a useful geometric interpretation of eigenvectors. Consider, for example, the case $n=3$ and suppose that the corresponding three eigenvalues $\lambda_{1}, \lambda_{2}, \lambda_{3}$ are all real, distinct, and nonzero. In this case there are three distinct invariant hyperplanes which pass through the origin $x=0$. The pairwise intersections between these three hyperplanes generate three lines that pass through the origin $x=0$ and are collinear with the three eigenvectors $\alpha_{1}, a_{2}$, and $a_{3}$. This result is illustrated in Figure 1.



Figure 1 - Showing the eigenvectors ${\underset{1}{1}}, \alpha_{2}, a_{3}$ lying on the intersections of the invariant hyperplanes $\mathcal{H}_{1}, \mathcal{H}_{2}, \mathcal{H}_{3}$.
4) From (13) it is clear that in the state space $E^{n}$ the integral curves of the system (3) cannot cross over ${ }^{2}$ the invariant hyperplanes of that system. Thus, the set of invariant hyperplanes of $\underset{\sim}{\dot{x}}=\underset{\sim}{A x}$ define boundaries of $n$-dimensional convex subsets of the state space which are invariant for the corresponding solution $\underset{\sim}{x}(t)$. This fact, together with the fact that an arbitrary solution $\underset{\sim}{x}(t)$ always monotonically approaches (recedes from) ${ }^{3}$ each stable (unstable) H/, is useful in establishing relative bounds on components of $\underset{\sim}{x}(t)$.

## An inverse Problem

In this section the following inverse problem is considered: Find a real, constant $n$-vector $\underset{\sim}{\gamma}=\left(\gamma_{1}, \ldots, \gamma_{n}\right)$ such that the hyperplane

$$
\begin{equation*}
\mathcal{H}=\{\underset{\sim}{x} \mid\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0\} \tag{17}
\end{equation*}
$$

is invariant for the linear dynamical system described by

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{A} \underset{\sim}{x}+\langle\underset{\sim}{\gamma}, \underset{\sim}{x}\rangle \underset{\sim}{f} \tag{18}
\end{equation*}
$$

where $\underset{\sim}{c}$ and $\underset{\sim}{f}$ are real, constant $n$-vectors, and $\underset{\sim}{A}$ is a real, constant $n \times n$ matrix. This problem differs from the previous problem in that the hyperplane (17), (i.e., the vector $\underset{\sim}{c}$ ) is assumed to be specified a priori.

From the results of Theorem 1, it is clear that $\underset{\sim}{\gamma}$ must be chosen so that

1) the matrix

$$
\begin{equation*}
\underset{\sim}{A}+\underset{\sim}{f} \underset{\sim}{\prime} \tag{19}
\end{equation*}
$$

has at least one real eigenvalue, and
2) one of the invariant hyperplanes of (18), corresponding to one of the real eigenvalues of (19), is defined by (17).

A vector $\underset{\sim}{y}$ which has the required properties is given in Theorem 2.
Theorem 2
Let $\underset{\sim}{A}$ be a real, constant $n \times n$ matrix, and let $\underset{\sim}{\gamma} \underset{\sim}{f}$, and $\underset{\sim}{c}$ be real, constant $n$-vectors. Then, the hyperplane

\begin{equation*}
\mathcal{H}=\{\underset{\sim}{x} \mid\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0\} \tag{20}
\end{equation*}
$$

is invariant for the linear dynamical system
2. More precisely, if $\underset{\sim}{x}(0) \notin \mathcal{H}_{i}$ then $\underset{\sim}{x}(t)$ cannot enter $\mathcal{L} \mathcal{X}_{i}$ in finite time. 3. Here, the "distance" from $\underset{\sim}{x}(t)$ to $\tilde{H}_{\text {is taken as }}\|\underset{\sim}{c}\|^{-1}{ }_{\sim}^{c}, \underset{\sim}{x}(t)>$.

$$
\begin{equation*}
\underset{\sim}{\dot{x}}=\underset{\sim}{A} \underset{\sim}{x}+\langle\underset{\sim}{y}, \underset{\sim}{x}\rangle \underset{\sim}{f} \tag{21}
\end{equation*}
$$

if $\underset{\sim}{\boldsymbol{\gamma}}$ satisfies

$$
\begin{equation*}
\underset{\sim}{\gamma}=\langle\underset{\sim}{c}, \underset{\sim}{f}\rangle^{-1}\left(-A^{\prime}+k I\right) ⿷ \tag{22}
\end{equation*}
$$

where $k$ is an arbitrary, real scalar constant.
Moreover, for the system of (21) and (22), the invariant hyperplane (20) is stable (unstable), in the sense of (4), if $k<0(>0)$.

Proof: Using the notat'on $\underset{\xi}{ }=\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle$, the derivative $d_{\xi} / d t$ along an arbittary solution of (21) is computed to be

\frac{d \xi}{d t} & =\langle\underset{\sim}{c},(\underset{\sim}{A}+\underset{\sim}{f} \underset{\sim}{\gamma}) \underset{\sim}{x}(t)\rangle \\
& =k_{\xi}+\langle\underset{\sim}{c}, \underset{\sim}{f}\rangle\left\langle\left[\underset{\sim}{\gamma}-\langle\underset{\sim}{c}, \underset{\sim}{f}\rangle^{-1}\left(-{\underset{\sim}{A}}^{\prime}+\underset{\sim}{k I}\right) \underset{\sim}{c}\right], \underset{\sim}{x}(t)\right\rangle . \tag{23}
\end{align*}
$$

The last term on the right of (23) vanishes when

$$

\underset{\sim}{\gamma}=\langle\underset{\sim}{c}, \underset{\sim}{f}\rangle^{-1}\left(-A^{\prime}+\underset{\sim}{x I}\right) \underset{\sim}{c} \tag{24}
\end{equation*}

and in this case

\frac{d \xi}{d t}=k_{\xi} \tag{25}
\end{equation*}
$$

along an arbitrary solution of (21). This completes the proof of Theorem 2.
Remarks
Equation (18) defines the vector $\underset{\sim}{\dot{x}}$ in terms of the two components $\underset{\sim}{A x}$ and $\langle\underset{\sim}{\gamma}, \underset{\sim}{x}\rangle f$. For the special case $\langle\underset{\sim}{c}, \underset{\sim}{f}\rangle=0$, the component $\langle\underset{\sim}{\gamma}, \underset{\sim}{x}\rangle \underset{\sim}{f}$ is always in the hyperplane $\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0$. It follows that, for this special case, $\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0$ is an invariant hyperplane of (18) if and only if $\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0$ is an invariant hyperplane of $\underset{\sim}{\dot{x}}=\underset{\sim}{A x}$. Under this condition, the choice of the vector $\underset{\sim}{\gamma}$ is immaterial.

Relation with Controllability and Observability
The linear dynamical system (1) is said to be completely controllable [9] - [12] in the state space $E^{n}$ if and only if, for each finite pair of states $\left({\underset{\sim}{x}}_{0},{\underset{\sim}{x}}^{x}\right) \in E^{n}$, there exists a finite interval $[0, T]$ and a control $u=\phi\left(t ;{\underset{\sim}{o}}_{0}^{\prime} \underset{\sim}{x}\right), 0 \leq t \leq T$, such that if $\underset{\sim}{x}(0)=\underset{\sim}{x}{ }_{0}$ then $\underset{\sim}{x}(T)={\underset{\sim}{x}}_{T}$ along the corresponding solution of (1). In a like manner, the linear dynamical system (1) is said to be completely observable [9]-[12] in the state space $E^{n}$ if and only if, for each finite output $y(t), 0 \leq t \leq T>0$, which satisfies (1) [with $u(t) \equiv 0$ ], there corresponds a unique initial state $\underset{\sim}{x}(0)$.

Let $\underset{\sim}{P}$ be the $n \times n$ matrix whose columns are $f, \underset{\sim}{A f}, A_{\sim}^{2} f, \ldots$, and $A^{n-1} f$, and let ${\underset{\sim}{R}}^{R}$ be the $n \times n$ matrix whose columns are $\underset{\sim}{h},{\underset{\sim}{x}}^{\prime} \underset{\sim}{h},{\underset{\sim}{A}}^{\prime}{ }_{\sim}^{h}, \ldots$, and ${\underset{\sim}{A}}^{\prime N}{ }^{n-1} h$. Then a necessary and sufficient condition for the linear dynamical system (1) to be completely controllable (observable) is that rank $\underset{\sim}{P}=n(\operatorname{rank} \underset{\sim}{R}=n)$ [10]. In other words, the system (1) becomes uncontrollable (unobservable) if and only if the vector $\underset{\sim}{f}(h)$ lies in a proper $\underset{\sim}{A}$-invariant ( ${\underset{\sim}{\prime}}^{\prime}$-invariant) subspace ${ }^{4}$ of $E^{n}$ with dimension less than $n$.

The invariant hyperplanes discussed in Section II are ( $\mathrm{n}-1$ )-dimensional A-invariant subspaces of $E^{n}$. It follows from the previous remarks that the linear dynamical system (1) becomes uncontrollable, in particular, whenever $\underset{\sim}{f}$ lies in one or more of the invariant hyperplanes of (3). Suppose, for example, that $\langle\underset{\sim}{c}, f\rangle=0$ for some $\underset{\sim}{c} i$ which satisfies (7). Then, the derivative of $\xi=\left\langle c_{i}, \underset{\sim}{x}\right\rangle$ along an arbitrary solution of (la) is

$$

\frac{d \xi}{d t}=\lambda_{i} \xi \tag{26}
\end{equation*}
$$

which shows that, irrespective of the choice of $u(t)$, the integral curve $\underset{\sim}{x}(t)$ cannot cross over the hyperplane $\langle\underset{\sim}{c}, \underset{\sim}{x}\rangle=0$.

An important connection between the A-invariant and A'-invariant subspaces of $E^{n}$ is summarized in the following well-known result of matrix theory: If $S$ is an $A$-invariant subspace of $E^{n}$ then the orthogonal complement of $S$ is an $\underline{A}^{\prime}$ invariant subspace of $E^{n}$. Since the real column (row) eigenvectors of $A$ are one-dimensional $\underset{\sim}{A}$-invariant ( $A_{\sim}^{\prime}$-invariant) subspaces, this result shows that

1) each real row eigenvector of $\underset{\sim}{A}$ is orthogonal to an ( $n-1$ )-dimensional A-invariant subspace, and
2) each real column eigenvector of $A$ is orthogonal to an ( $n-1$ )-dimensional $A^{\prime}$-invariant subspace. The first of these facts is recognized as an alternative proof of the existence of the invariant hyperplanes described in Section II. The second fact shows that the linear dynamical system (1) becomes unobservable, in particular, whenever the vector $\underset{\sim}{h}$ lies in one or more of the ( $n-1$ )-dimensional
4. A subspace $S \subset E^{n}$ is said to be $\underset{\sim}{A}$-invariant if $\underset{\sim}{x} \in S$ implies $\underset{\sim}{A x} \in S$ for all $\underset{\sim}{x} \in S$.
hyperplanes orthogonal to the real column eigenvectors of $\underset{\sim}{\mathcal{A}}$.
In the state space $E^{n}$, the union of all $A$-invariant subspaces with dimension less than $n$ is the set $F(\underset{\sim}{A})$ of all vectors $\underset{\sim}{f}$ for which the system (1) is uncontrollable. Likewise, the union of all $A^{\prime}$-invariant subspaces with dimension less than $n$ is the set $H(A)$ of all vectors $\underset{\sim}{h}$ for which the system (1) is unobservable. The case when either of the sets $F(A)$ or $H(A)$ is $n$-dimensional is particularly important since, in that event, both $\mathrm{F}(\mathrm{A}), \mathrm{H}(\mathrm{A})$ are n -dimensional and the system ( 1 ) is always uncontrollable and unobservable irrespective of the choice of the vectors $f$ and $h$ ! This degenerate condition occurs if and only if rank $\underset{\sim}{P}<n$ for arbitrary $\underset{\sim}{f}$. In other words, if and only if there exist real scalars $r_{0}, r_{1}, \ldots, r_{k},(k \leq n-1)$, not all zero, such that

\begin{equation*}
r_{0} I+r_{1} A+r_{2} A^{2}+\ldots+r_{k} A_{\sim}^{k}=0 \tag{27}
\end{equation*}
$$

An $n \times n$ matrix $A$ which satisfies (27), with $k \leq n-1$, must necessarily ${ }^{5}$ possess repeated eigenvalues and is said to be derogatory. That is, the minimal polynomial of $\underset{\sim}{A}$ is of lower degree than the characteristic polynomial. The nature of the geometric structure that causes this degenerate condition can be illustrated by considering the special case $n=2$. For that case, the only proper A-invariant (A~~ ${ }_{\sim}^{\prime}$-invariant) subspaces of dimension less than $n$ are the real column (row) eigenvectors of A. Thus, the second-order system (1) is uncontrollable (unobservable) if and only if the vector $\underset{\sim}{f}(\mathrm{~h})$ is collinear with one of the real column (row) eigenvectors of $\underset{\sim}{A}$. If the $2 \times 2$ matrix $\underset{\sim}{A} \neq \underset{\sim}{0}$ is derogatory, it follows from (27) that the two eigenvalues of $\underset{\sim}{A}$ must be real and repeated, $\lambda_{1}=\lambda_{2}=\lambda \neq 0$, and $\underset{\sim}{A}$ must have the diagonal form

It is readily verified from (5) and (6) that the column and row eigenvectors of (28) are nondistinct and can be chosen as any vector in $E^{2}$. That is, the state space portrait of (3), with A given by (28) consists of the family of all straight lines that pass through the origin $\underset{\sim}{x}=\underset{\sim}{0}$. It follows that every vector $\underset{\sim}{f} \in E^{2}\left(\underset{\sim}{h} \in E^{2}\right)$
5. The presence of repeated eigenvalues is a necessary but not sufficient condition for $\underset{\sim}{A}$ to be derogatory. A necessary and sufficient condition for $\underset{\sim}{A}$ to be derogatory is that there exists more than one linearly independent column eigenvector corresponding to the same (repeated) eigenvalue.
is collinear with one of the column (row) eigenvectors of $A$.
In general, the proper $A$-invariant and $A_{N}^{\prime}-$-invariant subspaces of $E^{n}$ appear with a variety of dimensions. $\tilde{\sigma}^{\tilde{6}}$ For this reason, the loss of controllability and/or observability of the general nth-order system (1) cannot always be characterized solely in terms of the particular one-dimensional and ( $n-1$ )-dimensional invariant subspaces previously discussed. It is possible, however, to give such characterizations for the special cases $n=2$ and $n=3$ since, for those two cases, the real eigenvectors and their respective orthogonal complements are the only invariant subspaces of interest. These characterizations, which follow immediately from the results previously described, may be summarized as follows.

Theorem 3
The second order, $n=2$, linear dynamical system (1) is:

1) always completely controllable and completely observable, irrespective of the choices of the vectors $\underset{\sim}{f}$ and $\underset{\sim}{h}$, if and only if $\underset{\sim}{A}$ has no real eigenvalues (i.e., if and only if the system is "underdamped").
2) uncontrollable (unobservable) if and only if the vector $\underset{\sim}{f}(\underset{\sim}{h})$ is collinear with a real column (row) eigenvector of $A$.
3) always uncontrollable and unobservable irrespective of the choices of the vectors $\underset{\sim}{f}$ and $\underset{\sim}{h}$, if and only if $\underset{\sim}{A}=r_{0} \underset{\sim}{I}$ for some real scalar constant $r_{0}$. Theorem 4

The third order, $\mathrm{n}=3$, linear dynamical system (1) is:

1) always uncontrollable (unobservable) for some choices of the vector $\underset{\sim}{f}(\underset{\sim}{h})$,
2) uncontrollable (unobservable) if and only if the vector $\underset{\sim}{f}(\underset{\sim}{\mathrm{f}}$ ) is either collinear with a real column (row) eigenvector of $A_{\sim}$ or lies on a 2 -dimensional plane that is orthogonal to one of the real row (column) eigenvectors of $\underset{\sim}{A}$.
3) always uncontrollable and unobservable, irrespective of the choices of the vectors $\underset{\sim}{f}$ and $\underset{\sim}{h}$, if and only if either

[^7]for some real scalar constants $r_{0}, r_{1}$.
In both Theorem 3 and Theorem 4, the absence of repeated eigenvalues is sufficient to guarantee the nonexistence of the degenerate condition 3 ).

## Conclusion

In this paper, the set of $(\mathrm{n}-1)$-dimensional hyperplanes (2) that are invariant along solutions of (3) have been identified as the orthogonal complements of the real row eigenvectors of A. A stability property of these hyperplanes, along solutions of (3), has been defined and characterized in terms of the associated real eigenvalues of A. In addition, some geometric relationships between the concepts of controllability and observability and the real column and row eigenvectors of $\underset{\sim}{A}$ have been described. By means of these relationships, the notions of controllability and observability for second and third-order linear dynamical systems (1) can be completely explained in terms of simple geometric characterizations.

## VII. Optimal Control With Quadratic Performance Index And Fixed Terminal Time

C. D. Johrson ${ }^{+}$J. E. Gibson ${ }^{++}$

Summary
The conventional solution for the optimal control of a linear stationary regulator with quadratic performance index and fixed terminal time leads to a linear feedback law with time varying gain coefficients [1]. ${ }^{1}$ In addition to the usual disadvantages of time variable controllers, these time varying gain coefficients approach infinity as the specified terminal time is approached.

In the present paper, it is shown that the optimal control for the above problem can be expressed as a time invariant nonlinear feedback law. Certain parameters in the nonlinear feedback law are functions of the initial time and initial state of the system. The conventional time varying linear feedback law can be obtained directly from the time invariant nonlinear feedback law.

The results of the present paper are applicable to a more general class of optimal control problems involving linear and nonlinear systems. Two examples are given to illustrate the method.

1. Statement of the Problem

The problem is to find a control $u(t)$ which minimizes the functional ${ }^{2}$

In (1), $\underset{\sim}{Q}$ is a symmetric, positive semi-definite constant matrix and $c$ is a non-zero scalar constant. In (2), $\underset{\sim}{x}=\left(x_{1}, \ldots, x_{n}\right)$ is the state vector of the plant, $A$ is an ( $n \times n$ ) constant matrix, $f=\left(f_{1}, \ldots, f_{n}\right)$ is a constant $n$-vector and $u(t)$ is the scalar control function. It is assumed that $u(t)$ is piecewise continuous but otherwise unrestricted. It is further assumed that the pair ( $A, f$ ) is controllable. Then as shown in [2], there is no loss of generality in assuming that $\underset{\sim}{A}, \underset{\sim}{f}$ have the canonical form


The optimal control $u$ for the above problem can, in principle, be found by straightforward application of the Hamilton-Jacobi theory. Since the details of the Hamilton-Jacobi formulation of this problem have already been given in [1] we will only summarize the results.

## 2. Form of the Optimal Control Law

Let $\left.u^{0}=\phi^{0} \underset{\sim}{x}, t, T\right)$ be an optimal control law, and let

Then it can be shown [1] that $V$ satisfies the Hamilton-Jacobi equation
$\frac{\partial V}{\partial t}(\underset{\sim}{x}, t, T)+\langle\underset{\sim}{\nabla} V(\underset{\sim}{x}, t, T), \underset{\sim}{A} \underset{\sim}{x}\rangle-\frac{c}{2}^{-2}\langle\underset{\sim}{\nabla} V(\underset{\sim}{x}, t, T), \underset{\sim}{f}\rangle^{2}+\frac{1}{2}\langle\underset{\sim}{x}, \underset{\sim}{\underset{\sim}{x}} \underset{\sim}{x}=0(7)$
where

Further, the optimal control law is given by

The control law (9) may be determined by solving (7) directly or, alternately, by solving for the characteristic strips of (7). The direct solution of (7) is discussed below. The method of characteristic strips, which in this particular case leads to Pontryagin's canonical equations, is discussed in Appendix 1.

## 3. Solution of the Hamilton-Jacobi Equation

The term $\partial \mathrm{V} / \partial$ in (7) is related to Pontryagin's Hamiltonian function H by the relation

which holds along optimal trajectories $\underset{\sim}{x}(t)$. For the problem (1) - (4) it is well known that the Hamiltonian (10) is constant along optimal trajectories.

From (10) and (11), it is clear that a complete integral ${ }^{3}$ of (7) must be linear in t and of the form

where $\beta$ is given by (11). The $\alpha_{i}$ and $\beta$ in (12) are $n+1$ integration constants (constants of motion) which can be evaluated from the specified initial and terminal states (3), (4)。 ${ }^{4}$ Thus

Moreover, it can be shown [see Appendix 2] that along optimal trajectories there are an additional $n$ constants of motion given by

It is at this point that the present method of solution differs from conventional methods. In the conventional methods of solving the problem (1) - (4); $[1],[3],[4],[5],[6],[7],[8],[9],[10]$, it is assumed that the solution to (7) is a positive definite (or semi-definite) quadratic form ${ }^{5}$

where the elements of the $(n \times n)$ matrix $\underset{\sim}{\mathcal{M}}$ are functions of time $m_{i j}=m_{i j}(t, T)$ $i, i=1, \ldots, n$. Upon substituting (16) into (7) the $m_{i j}(t, T)$ are determined as the solution to an ordinary nonlinear matrix differential equation of the Riccati type. By this means, the assumed solution (16) leads to a time varying linear feedback control law of the form

where $\underset{\sim}{\gamma}(t, T)=\left(\gamma_{1}(t, T), \ldots, \gamma_{n}(t, T)\right)$ is a time varying gain vector. A well known practical disadvantage of the solution (17) is that $|\underset{\sim}{\gamma}(t, T)| \rightarrow \infty$ as $t \rightarrow T_{\text {. }}{ }^{6}$

In the present method of solving the problem (1) - (4), the solution to (7) is sought in the form of a complete integral of the type (12)。 ${ }^{7}$ By this means, the optimal control (9) is obtained as a time invariant nonlinear feedback law of the form

It is remarked that in some special cases it may be possible to obtain the expression (19) without solving for (12) explicitly.

In (19) the initial conditions ${\underset{\sim}{0}}^{\prime}, t_{0}$ are arbitrary for $t_{0} \leq T$. Thus, the nonlinear control law (19) can easily be transformed to the conventional time varying linear control law (17) by setting $\underset{\sim}{x}=\underset{\sim}{x}(t)$ and $t_{0}=t$ in (19). ${ }^{8}$ This

latter step illustrates the relationship between the two alternate forms of solutions (17) and (19). That is, in the solution (19) the time varying portion of (17) is replaced by the constants of motion (13), (14).9 The control functions (17) and (19) are mathematically equivalent solutions which differ only in functional form.

In the problem (1) - (4), if the fixed terminal time $T$ is infinite (or, equivalently, if $T$ is unrestricted) then $\beta$ in (11) becomes zero and the optimal control (9) reduces to a time invariant linear feedback law of the form [11]

\end{equation*}

where $\underset{\sim}{\gamma}=\left(\gamma_{1}, \ldots, \gamma_{n}\right)$ is a constant $n$-vector。
A variation of the problem (1) - (4) is obtained by fixing the elapsed time $\tau=T-\dagger_{0}$. In this case, one may arbitrarily set $\dagger_{0}=0, T=\tau$ and (19) contains one less parameter.

## 4. Comparison of Alternate Solutions

The conventional time varying linear feedback law (17) is illustrated in Figure 1. This form of solution has the advantage of being independent of the initial state $\underset{\sim}{x}\left(t_{0}\right)$. That is, the control $\cup^{0}(\underset{\sim}{x}, t, T)$ is always optimal with respect to any instantaneous state $\underset{\sim}{x}(t),(t \leq T)$. A practical disadvantage of this solution is the physical unrealizability and extreme sensitivity of the feedback controller as $t \rightarrow T$ and $|\underset{\sim}{\gamma}(t, T)| \rightarrow \infty$ 。

The time-invariant, nonlinear feedback law (19) is illustrated in Figure 2. The switches $s_{1}, s_{2}$ represent devices which, when activated, will sample and hold the initial conditions $\underset{\sim}{x}\left(t_{0}\right), t_{0^{\circ}}$ An apparent disadvantage of this solution is the fact that the control $v^{\circ}\left(\underset{\sim}{x}, \underset{\sim}{x},{ }^{\prime}{ }_{o}, T\right)$ is optimal only for states $\underset{\sim}{x}(t)$ lying on the optimal trajectory passing through the initial state $\underset{\sim}{x}\left(\dagger_{o}\right)$. Thus if, after

sampling the initial conditions $\underset{\sim}{x}\left(t_{0}\right), t_{0}$, the actual state $\underset{\sim}{x}(t)$ should deviate from the theoretical optimum trajectory (for instance, due to momentary external disturbances) then the control $u{ }^{0}\left(\underset{\sim}{x}, \underset{\sim}{x}, t_{0}, T\right)$ would not continue to be optimal with respect to the actual state $\underset{\sim}{x}(t)$ 。However, if such a disturbance should occur, the optimal control for the disturbed state $\underset{\sim}{x}(t)$ can be obtained by momentarily activating the sample and hold devices $s_{1}$ and $s_{2}$. By this means, the disturbed values $x(t)$, t become the new initial conditions $\underset{\sim}{x}\left(t_{0}\right), t_{0}$ This technique allows the step-wise readjustment of the nonlinear feedback law to account for any deviations of $\underset{\sim}{x}(t)$ from the original optimal trajectory. ${ }^{10}$ In the limit, as $s_{1}$ and $s_{2}$ sample $\underset{\sim}{x}(t)$ and $t$ continuously, the control $v^{0}\left(\underset{\sim}{x}, \underset{\sim}{x}, t_{0}, T\right)$ becomes $\cup^{0}(\underset{\sim}{x}, t, T)$ and the alternate solutions of Figures 1 and 2 become identical. By employing this dual mode property of the solution (19) it may be possible to eliminate some of the practical disadvantages of the conventional solution (17).
5. Example 1-A Linear Regulator of First Order

As a special case of (1), (2), let ${ }^{11}$

The field of trajectories for the plant (21) with control (29) is illustrated in Figure 3. A plot of the constant of motion $\beta$ given by (28) is shown in Figure 4. The contours $\beta=$ constant in Figure 4 may be interpreted as optimal trajectories. If $T=\infty$ (or, if $\mathrm{T}=$ unrestricted) then $\beta$ in (28) becomes zero and the optimal control (29) becomes

It may be noted in (31) that ctnh $[\sqrt{2}(\mathrm{~T}-\mathrm{t})] \rightarrow \infty$ as $t \rightarrow \mathrm{~T}$.
The expressions for the constants of motion provide a simple method for deriving expressions for $x(t)$. In the present example, (28) yields directly the expression

x(t)=x_{0} \frac{\sinh [\sqrt{2}(T-t)]}{\sinh \left[\sqrt{2}\left(T-t_{0}\right)\right]} . \tag{32}
\end{equation*}
$$

## 6. Example 2 - A More General First Order Problem

An advantage of the complete integral method of solution is that, in principle, it may be applied to a more general class of problems. Consider, for example, the problem of finding a control $u(t)$ which minimizes the functional

$$

J[u]=\int_{t_{0}}^{T}\left[g(x(t))+c^{2} u^{2}(t)\right] d t \tag{33}
\end{equation*}
$$

subject to the following conditions:

\begin{gather*}
\dot{x}=f(x)+u b(x)_{2}(x=\text { scalar })  \tag{34}\\
x\left(t_{0}\right)=x_{0} \\
x(T)=0 \quad(T=\text { fixed }) \tag{35}
\end{gather*}
$$

In (33), $g(x)$ is a non-negative definite continuous function $x$ and $c$ is a nonzero scalar constant. In (34) $f(x)$ and $b(x)$ are continuous functions of the scalar $x$.

It is assumed that $u(t)$ is piecewise continuous but otherwise unrestricted. Then, using the complete integral method described above, it is found that the optimal control $u^{\circ}$ (if it exists) can be expressed as

$$
u^{0}\left(\underset{\sim}{x}, \underset{\sim}{x}, t_{0}, T\right)=-\frac{f(x)}{b(x)}-\frac{(\operatorname{sgn} x)}{b(x)} \sqrt{[f(x)]^{2}+c^{-2}[b(x)]^{2}[g(x)+\beta]} . \text { (36) }
$$

The $\beta=\beta\left(x_{o},{ }_{0}, T\right)$ in (36) is a constant of motion which can be evaluated from the initial and terminal conditions (35).

If the terminal time $T$ in (35) is unrestricted, then $\beta$ is zero and (36)
becomes

$$
\begin{equation*}
u^{o}(\underset{\sim}{x})=-\frac{f(x)}{b(x)}-\frac{(\operatorname{sgn} x)}{b(x)} \sqrt{[f(x)]^{2}+c^{-2}[b(x)]^{2} g(x) .(3)} \tag{37}
\end{equation*}
$$

This method of solution can, in principle, be extended to problems of higher order. In the case of higher order problems, it may be necessary to evaluate several of the constants of motion (13), (14), (15).

## 7. Conclusions

The conventional solution for the optimal control of a linear regulator with quadratic performance index and fixed terminal time leads to a time varying linear control law which is physically unrealizable. It has been shown that the optimal control for this problem can be expressed as a time invariant nonlinear feedback law. Certain parameters in the nonlinear law are functions of the initial conditions $\underset{\sim}{x}\left(t_{0}\right), t_{0}$.

The time invariant nonlinear control law can be transformed to the conventional time variable control law by setting $\underset{\sim}{x}\left(t_{0}\right)=\underset{\sim}{x}(t)$ and $t_{0}=t$. By this means, it may be possible to design a physically realizable optimal controller which retains some of the desirable features of the conventional linear control law. The method of solution used here is applicable, in principle, to a more general class of optimal control problems.

The purpose of the present paper is to point out the possibility of employing the complete integral method in the solution of certain problems of optimal control. Although the principle is relatively simple, application of this method is complicated by the practical difficulties of finding complete integrals.

## 8. Appendix 1-Characteristic Strips of the Hamilton-Jacobi Equation

The equations of the characteristic strips of the Hamilton-Jacobi equation (7) are [13]

\underset{\sim}{\dot{p}}=\underset{\sim}{\underset{\sim}{x}} \underset{\sim}{x}-{\underset{\sim}{A}}^{\prime} \underset{\sim}{p} \quad(\text { denotes transpose) }(38
$$

where

& p=-\nabla V \\
& q=\frac{\partial V}{\partial t} .
\end{aligned}
$$

Equations (38) are equivalent to Pontryagin's canonical equations [14] and (39) is equivalent to the relation $\frac{\mathrm{dH}}{\mathrm{dt}}=0$.

When $\underset{\sim}{A}, \underset{\sim}{f}$ are of the canonical form (5), the first of equations (38) can be written as the single $n^{\text {th }}$ order differential equation

\begin{equation*}
s^{n} x_{1}-<\underset{\sim}{a}, \underset{\sim}{\pi}(s)>x_{1}-c^{-2} p_{n}=0 \tag{40}
\end{equation*}
$$

and the set of equations (38) can be written as one $2 \mathrm{n}^{\text {th }}$ order linear differential equation of the form
$s^{2 n} x_{1}-s^{n}\left\langle\underset{\sim}{a},\left(\underset{\sim}{\pi}(s)+(-1)^{n} \underset{\sim}{\pi}(-s)\right)\right\rangle x_{1}+(-1)^{n} c^{-2}\left\langle\underset{\sim}{\pi}(s),\left(\underset{\sim}{Q}+c^{2} \underset{\sim}{a a^{\prime}}\right) \underset{\sim}{\underset{\sim}{r}}(-s)\right\rangle x_{1}=0$
where

$$
\begin{aligned}
& s^{k} x_{1}=\frac{d^{k} x_{1}}{d t^{k}} . \\
& \underset{\sim}{a}=\left(a_{1}, \ldots, a_{n}\right) \\
& \underset{\sim}{\pi}(s)=\left(1, s, s^{2}, \ldots, s^{n-1}\right) .
\end{aligned}

It may be noted that the 2 n roots of the characteristic equation of (41) occur in pairs ( $\lambda,-\lambda$ ). Equation (40) represents the differential equation of the optimally controlled plant with $u^{0}(t)=c^{-2} p_{n}(t)$. Equation (41) may be considered as a $2 \mathrm{n}^{\text {th }}$ order differential equation which is obtained by taking $n$ successive derivatives of (40).

The order of (41) can be reduced to $n$ by taking $n$ successive first integrals of (41) to obtain

where $c_{1}, \ldots, c_{n}$ are $n$ constants of integration. Equations (40) and (42) may now be solved jointly to obtain

The constants of integration $c_{i}(i=1, \ldots, n)$ are chosen to satisfy the specified boundary conditions $\underset{\sim}{x}\left(t_{0}\right)={\underset{\sim}{x}}_{0}, \underset{\sim}{x}(T)=\underset{\sim}{0}$. By this means, there is obtained

However, since any state $\underset{\sim}{x}(t)$ along an optimal trajectory can be considered as the instantaneous initial state $\underset{\sim}{x}\left(t_{0}\right)$, the constants of integration in (44) can be written as

9. Appendix 2 - Complete Integrals of the Hamilton-Jacobi Equation and

Constants of Motion Along Optimal Trajectories
The Hamilton-Jacobi equation can be written as [1]

If $\underset{\sim}{x}$ is an $n$-vector then, following Lagrange, a complete integral of (47) is defined [13] as any solution of (47) which contains $n$ essential constants of integration $a_{i}(i=1, \ldots, n)$. Thus a complete integral of (47) is of the form ${ }^{13}$

[^11]It will now be shown that, if $V$ is sufficiently continuous in its arguments, the expressions

It is clear from (55) that along solutions of (49)

which constitute a general solution of the $2 n$ canonical equations (49). The $2 n$ constants $a_{i}, k_{i}(i=i, \ldots, n)$ are evaluated from the specified initial and terminal conditions of (57).

# VIII. <br> . On a Problem of Letov in Optimal Control'

In a series of papers [1, 2], ${ }^{2}$ A. M. Letov discussed an optimal regulator problem for a linear plant with bounded control variable and quadralic performance index. This problem was also discussed by Chang [3]. Krasovskii and Letov observed later [4] that the solution proposed in [1, 2, and 3] may be correct only for special choices of the initial value of the state vector. In the present note, further aspects of the solution in the general case are described and three examples are given. The possible existence of a regime of unsaturated-nonlinear optimal control is demonstrated. The presence of this regime in the optimal control law was apparently overlooked in [1-4].

## Statement of the Problem

The problem is to find a continuous control function $u=u(\ell)$ which minimizes the functional ${ }^{1}$

J[u]=\frac{1}{2} \int_{0}^{T}\left[\langle x(t), \mathrm{Q} \times(t)\rangle+c^{2} u^{2}(t)\right] d t \tag{1}
\end{equation*}
$$

subject to the following conditions:

\overline{\mathbf{x}}=\mathbf{A x}+u \mathbf{f} \quad(\cdot=d / d t)  \tag{2}\\
\mathbf{x}(0)=x_{0}  \tag{3}\\
\mathbf{x}(T)=0 \quad(T \text { is unrestricted })  \tag{4}\\
|u(t)| \leqq 1 \quad(0 \leqq t \leqq T) \tag{5}
\end{gather*}
$$

In (1), $\mathbf{O}$ is a positive semidefinite symmetric constant uatrix and $c$ is a scalar constant. In (2), $x=\left(x_{1}, \ldots, x_{n}\right)$ is the state vector of the plant, A is an ( $n \times n$ ) constant matrix, $f=$ ( $f_{1}, \ldots, f_{n}$ ) is a constant $n$-vector and $u$ is the scalar control function. It is assumed that the pair ( $\mathbf{A}, \mathbf{f}$ ) is controllable; that is, the vectors

$$
\begin{equation*}
f, A f, \ldots, A^{n-1 f} \tag{6}
\end{equation*}
$$

are linearly independent. Then, as shown in [5], there is no loss of generality in assuming that $\mathbf{A}$, $f$ have the form

$$
\mathbf{A}=\left[\begin{array}{cccccccc}
0 & & 1 & & 0 & . & . & .  \tag{7}\\
0 & & 0 & & 1 & . & . & . \\
& & & & & & & \\
& & & . & & & & \\

& & & a_{n}
\end{array}\right], \mathbf{f}=\left[\begin{array}{l}
0 \\
. \\
. \\
0 \\
1
\end{array}\right]
$$

It is further assumed that the state $x=0$ is reachable from $x_{0}$ using an admissible control (5). Then, if $\mathbf{Q}$ is appropriately restricted, an optimal control $u$ exists [9] and can in principle be found by straightforward application of Pontryagin's principle or dynamic programming. Since the details have already been given in [2 and 4] we first summarize the results.

## Form of the Oplimal Control Law

1 Let $u^{0}=\phi^{0}(x)$ be an optimal control law, and let

$$

V(\mathbf{x})=J\left[u^{0}\right], \quad \mathbf{x}(0)=\mathbf{x} \tag{8}
\end{equation*}
$$

We shall assume that $V$ is continuously differentiable in $x$. Then $V$ satisfies the Hamilton-Jacobi equation

&\langle\nabla V(x), A x\rangle-\frac{c^{-2}}{2}\langle\nabla V(x), f\rangle^{2}+\frac{1}{2}\langle x, O x\rangle=0 \\
& \text { if }\left|c^{-2}\langle\nabla V(x), f\rangle\right| \leqq 1 \tag{9a}
\end{align*}
$$

and

$$
\begin{array}{r}
\langle\nabla V(x), A x\rangle-|\langle\nabla V(x), f\rangle|+\frac{c^{2}}{2}+\frac{1}{2}\langle x, O x\rangle=0 \\
\text { if }\left|c^{-2}\langle\nabla V(x), f\rangle\right| \geqq 1 \tag{9b}
\end{array}
$$

In (9)

$$
\begin{equation*}
\nabla V=\left(\frac{\partial V}{\partial x_{1}}, \ldots, \frac{\partial V}{\partial x_{n}}\right) \tag{10}
\end{equation*}
$$

Further, the optimal control is given by

$$
\begin{equation*}
\phi^{0}(x)=\operatorname{sat}\left[c^{-2}\langle-\nabla V(x), f\rangle\right] \tag{11}
\end{equation*}
$$

where

$$
\text { sat } y= \begin{cases}y, & |y| \leqq 1  \tag{12}\\ \operatorname{sgn} y, & |y| \geqq 1\end{cases}
$$

Equation ( $9 a$ ) holds in the set of states $x$ where the control is unsaturated (i.e., $\left|\phi^{0}(x)\right|<1$ ) and ( $9 b$ ) holds in the set of states $x$ where the control is saturated (i.e., $\left|\phi^{0}(x)\right|=1$ ). Consider first the set where ( $9 a$ ) is satisfied. In the absence of the constraint (5), the restriction $\left|c^{-2}(\nabla V(x), p)\right| \leqq 1$ disappears and (9a) holds at all states $x$. For this case it is well known [6] that the solution of ( $9 a$ ) is

$$

V(x)=\frac{1}{2}\langle x, M x\rangle \tag{13}
\end{equation*}
$$

where the matrix $M$ is symmetric, positive definite, and uniquely defined by

& \text { ('denotes transpose) } \tag{14}
\end{align*}

Further, the optimal control law is linear and is given by

\end{equation*}

where

2 'To introduce the constraint $|u| \leqq 1$ we proceed as in [5]. Let $L$ be the set of states $x_{0}$ such that, if $x(0)=x_{0}$ and if $u=\phi_{L}(x)$ in (2), then $\left|\phi_{L}[x(t)]\right| \leqq 1$ for $t \geqq 0$. In other words, $L$ is the set of initial states for which the constraint $|u| \leqq 1$ is satigfied along the corresponding trajectories when the control law is $\phi_{L}(x)$. It is clear that if $x(0) \in L$ then $x(t) \in L$ for $t \geqq 0$; and it can be verified that $L$ is an $n$-dimensional, convex, and in general proper subset of the set of states $x$ defined by the inequality

$$
\begin{equation*}
\left|\phi_{L}(x)\right| \leqq 1 \tag{17}
\end{equation*}
$$

Obviously $L$ contains the origin $x=0$. It follows that

\phi^{\prime}(x)=\phi_{L}(x), \quad \text { when } \quad x \in L \tag{18}
\end{equation*}
$$

In general $\phi^{0}(x)$ is not given by (18) in the entire strip (17); the set $L$ coincides with the strip (17) only for special choices of the matrices $A$ and $\mathbf{Q}$ (see section, "Example 3"). Moreover $\phi^{0}(x)$ is not given, in general, by the simple rule

$$
\begin{equation*}
\phi^{0}(x)=\operatorname{sat} \phi_{L}(x), \quad \text { for all } x \tag{19}
\end{equation*}
$$

The control law (19) is the solution (iv general, incorrect) proposed in [1-3].

The set $L$ ia the largest set of states $x$ for which one can state a priori that (13) is a valid solution of ( $9 a$ ). " In general (9a) has solutions different from (13) which are valid in a certain region $N$. For $x$ in $N$, the optimal control is agsin unsaturated, i.e., $\mid c^{-2}$ $\langle\nabla V(x), f\rangle \mid<1$, but $\phi^{0}(x)$ is a nonlinear function $\phi_{N}(x)$ of the state $x$. The possible existence of $N$ was apparently overlooked in [1-4]. Failure to include the nonlinear regime, when it exists, will lead to the apparent discontinuities in $V(x)$ which were described in the last paragraph of [4].

The interior of $L \cup N$ is the set of states $x$ where the optimal control $\phi^{0}(x)$ is unsaturated ( $\left|\phi^{0}(x)\right|<1$ ). In the complement of $L \cup N$, which we shall denote by $S$, the control is saturated; i.e., $\left|c{ }^{2}(\nabla V(x), f\rangle\right|>1$ and $\phi^{0}(x)=\phi_{S}(x)= \pm 1$. In principle, analytic expressions for $\phi_{N}(x)$ and the boundaries of $N$ and $S$ are determined by solving (9) in $N$ and $S$ and then applying (11). In practice this procedure is complicated by the fact that the solution of (9) does not have the same analytic form throughout $N$ and $S$. Some results of applying this procedure to a concrete example are given later in Example 1. Further research is needed to determine more practical methods for obtaining, or approximating, $\phi_{N}(\mathbf{x})$.
3 The theory of characteristic strips [7] suggests an alternative and practical technique for determining the boundaries of $N$ and $S$. In this technique the equations of the characteristic strips of (9) are integrated in reversed time, starting from states on the boundary of $L$. For this problem the equations of the characteristic strips are equivalent to Pontryagin's canonical equations [8] and are

\dot{\mathbf{x}} & =\mathbf{A x}+u^{0} \mathbf{f} \\
u^{0}(t) & =\operatorname{sat}\left[c^{-2}\langle\boldsymbol{p}(t), \mathfrak{f}\rangle\right]  \tag{20}\\
\dot{\mathbf{p}} & =\mathbf{A x}-\mathbf{A}^{\prime} \mathbf{p}
\end{align*}
$$

where $p=-\nabla V(x)$. At states $x \in L(13)$ yields

$$
\begin{equation*}
p=-M x \tag{21}
\end{equation*}
$$

where $M$ is given by (14). Integration of (20) for $t \leqq 0$ (with initial conditions $x(0)=x, p(0)=-M x$ and $x$ on the boundary of $L$ ) presents no problem in principle, since the "sat" function is Lipschitz-continuous. In this way states on the common boundary of $N$ and $S$ are determined as the values of $\mathbf{x}(t)$ when $c^{-2}\langle\mathrm{p}(t), 1\rangle= \pm 1 .{ }^{6}$

## Example 1

As a special case of (1), (2), let

$$
\begin{align*}
& \dot{x}_{1}=x_{2}  \tag{22}\\
& \dot{x}_{2}=u, \quad|u(t)| \leqq 1
\end{align*}
$$

"Here the term "valid" means that $V(x)$ satisfies the definition (8).

- The computation of $u^{0}(t), t \leqq 0$, also allows one to determine numerical values of $V^{\prime}(x)$. This information may be useful in comparing various suboptimal control laws.

$$
\begin{equation*}
J[u]=\frac{1}{2} \int_{0}^{T}\left(x_{1}^{2}+x_{2}^{2}+c^{2} u^{2}\right) d t \tag{23}
\end{equation*}
$$

The linear control law is found from (14), (15) to be

$$
\begin{equation*}
\phi_{L}(x)=-c^{-1} x_{1}-c^{-1}(1+2 c)^{1 / 2} x_{2} \tag{24}
\end{equation*}
$$

The set $L$ is the largest subset of the strip $\left|\phi_{L}(x)\right| \leqq 1$ which is invariant for the system

$$
\begin{align*}
& \dot{x}_{1}=x_{2} \\
& \dot{x}_{n}=\phi_{L}(x) \quad(t \geqq 0) \tag{25}
\end{align*}
$$

Thus $L$ is bounded in part by the straight lines $\phi_{L}(x)= \pm 1$, and in part by the two trajectories of the syatem (25) which are tangent to these lines, Fig. 1. A trajectory of (25) is tangent to the line $\phi_{L}(x)= \pm 1$ at the state $\pm x_{0}$ where

$$

x_{0}=\left[1+c, \quad-(1+2 c)^{1 / 2}\right] \tag{26}
\end{equation*}
$$

The state $\pm x_{i}$, at which a trajectory tangent to $\phi_{L}(x)= \pm 1$ intersects the opposite boundary $\phi_{L}(x)=\mp 1$ is determined by integration of (25) for $t \leqq 0$, with $x(0)= \pm x_{\theta}$.

The boundaries of $N$ and $S$ are now established by integrating the canonical equations for $t \leqq 0$. The matrix $M$ is found from (14) to be

$$
M=\left[\begin{array}{cc}
(1+2 c)^{1 / 2} & c  \tag{27}\\
c & c(1+2 c)^{1 / 2}
\end{array}\right]
$$

and the canonical equations (20) become

$$
\begin{array}{ll}
\dot{x}_{1}=x_{:} & \dot{p}_{1}=x_{1} \\
\dot{x}_{2}=\text { gat }\left(c^{-2} p_{2}\right) & \dot{p}_{2}=-p_{1}+x_{2} \tag{28}
\end{array}
$$

The integration of (28) for $t \leqq 0$ need be started only from states $x$ on the linear boundary segments $\left[-x_{t}, x_{\theta}\right]$ and $\left[x_{l},-x_{\theta}\right] .{ }^{6}$ The correaponding initial values of $p_{1}, p_{2}$ are given by (21) and (27). For $c=1$, the results, obtained with an analog computer, are shown in Fig. 2. As an optimal trajectory is traced backward from $L$, the state trajectory first enters $S$, where the control $u^{0}(t)$ $=$ sat $\left[c^{-2} p_{2}(t)\right]$ remains constant at the saturation level $\pm 1$. The trajectory then passes through $N$ (the curved strip in Fig. 2), where $u^{0}(t)$ varies continuously from $\pm 1$ to $\mp 1$; and so on. As shown in Fig. 2 the set $S$ can be divided into two subsets $S_{ \pm}$ where $\phi^{0}(x)= \pm 1$. The behavior of $p_{2}(t)$ and of $u^{0}(t), t \leqq 0$, is illuatrated in Fig. 3.

As $c \rightarrow 0$ the set $L$ reduces to the linear segment $x_{1}+x_{2}=0$, $\left|x_{1}\right| \leqq 1$, and the boundaries of $N$ approach a common switching curve. The optimal control then has a bang-bang and a singular mode, Fig. 4. The general problem (1)-(5) with $c=0$ has been discussed in [5].

The following results (for $c=1$ ) were obtained by analytic solution of the Hamilton-Jacobi equation. From (9),
$x_{1} \frac{\partial V}{\partial x_{1}}-\frac{1}{2}\left(\frac{\partial V}{\partial x_{2}}\right)^{2}+\frac{1}{2}\left(x_{1}^{2}+x_{2}^{2}\right)=0, \quad\left|\frac{\partial V}{\partial x_{2}}\right| \leqq 1$
$x_{2} \frac{\partial V}{\partial x_{1}}-\left|\frac{\partial V}{\partial x_{i}}\right|+\frac{1}{2}+\frac{1}{2}\left(x_{1}{ }^{2}+x_{2}{ }^{2}\right)=0, \quad\left|\frac{\partial V}{\partial x_{2}}\right| \geqq 1$
In the set $L$, the solution of (29a) is given by (13) and (27):

$$
\begin{equation*}
V_{L}(\mathrm{x})=\frac{1}{2}\left(\sqrt{3} x_{1}^{2}+2 x_{1} x_{2}+\sqrt{3} x_{2}^{2}\right) \tag{30}
\end{equation*}
$$

In the subset $S_{1}$ of $S$, shown in Fig. 5, (29b) has the solution

$$
\begin{align*}
V_{S_{1}}(x)=(1 / 30)[ & -3 \sqrt{3}+15 x_{1}^{2} x_{2}+10 x_{1} x_{2}^{2}+15 x_{2} \\
& \left.+5 x_{2}^{8}+2 x_{2}^{5}+2\left|\left(1+2 x_{1}+x_{2}^{2}\right)^{6 / 2}\right|\right] \tag{31}
\end{align*}
$$

${ }^{6}$ Integration need not be started from the segments ( $\pm \mathrm{x}_{\mathbf{l}}, \pm \mathrm{x}_{\mathrm{f}}$ ) since these are characteristic curves of (9).

It can be verified that the solution (31) satisfies the requirement that $V$ be continuous on the ( $L, S_{1}$ ) boundary, defined by $x_{1}$ $+\sqrt{3} x_{2}=1,\left|x_{2}\right| \leqq \sqrt{3}$.
The boundary segment between $L \cup N$ and $S_{1}$, Fig. 5 , is determined by setting $\partial V(x) / \partial x_{2}=+1$ in (31). The result is

$$
\begin{align*}
-3+3 x_{1}^{2}+6 x_{1} x_{2}^{2}+3 x_{2}^{2} & +2 x_{2}^{4} \\
& +2 x_{2}\left|\left(1+2 x_{1}+x_{2}\right)^{1 / 2}\right|=0 \tag{32}
\end{align*}
$$

If $\left|x_{2}\right| \leqq \sqrt{\overline{3}}$, the left side of (32) vanishes when $x_{1}+\sqrt{3} x_{2}=1$; if $x_{2} \geqq \sqrt{3}$, the mode boundary ( $N, S_{1}$ ) defined by (32) is a curved segment lying between the parabola $1+2 x_{1}+x_{2}{ }^{2}=0$ and the line $x_{1}+\sqrt{3} x_{2}=1$. The fact that the boundary segment ( $N, S_{1}$ ) is not linear shows that the control law in the region .$V$ must be a nonlinear function of the state variables.

## Example 2

The following example was discussed briefly in [4]. Let

$$
\begin{align*}
\dot{x}_{1} & =x_{2} \\
\dot{x}_{2} & =-x_{1}+u \quad|u(t)| \leqq 1  \tag{33}\\
J[u] & =\frac{1}{2} \int_{0}^{T}\left(x_{2}^{2}+u^{2}\right) d t
\end{align*}
$$

The construction of the $L, N$, and $S$ boundaries for this problem proceeds in the same manner as for Example 1 and the resulte are shown in Fig. 6. The trajectories in $S+\left(S_{-}\right)$are circular arcs centered at $x_{1}=+1(-1), x_{2}=0$.

## Example 3 Optimal Dual-Mode Control

As mentioned earlier in the paper, the set $L$ coincides with the entire strip $\left|\phi_{L}(x)\right| \leqq 1$ only for special choices of the matrices $A$ and $\mathbf{Q}$. Expressed geometrically, a necessary condition is that the hyperplane $\phi_{L}(x)=0$ be invariant for the linear system defined by setting $u=\phi_{L}$ in (2). Sufficient conditions can be aimply expressed algebraically when $\mathbf{A}, \mathrm{I}$ are of canonical form (7), and in this case we have the following result.

## Theorem

Let the eigenvalues of A be $\alpha_{1}, \ldots, \alpha_{n}$. If (i) $\operatorname{Re} \alpha_{m}<0$ and the $\alpha_{m}$ are distinct, $m=1, \ldots, n-1$, (ii) $\alpha_{n}$ is real, (iii) $\mathbf{Q}=\left[q_{j k}\right]$ is so chosen that $q_{11}>0, O$ is symmetric positive semidefinite, and

$$
\begin{equation*}
\sum_{j=1}^{n} \sum_{k=1}^{n} q_{i k} \alpha_{m}^{j-1}\left(-\alpha_{m}\right)^{k-1}=0, \quad m=1, \ldots, n-1 \tag{34}
\end{equation*}
$$

then the optimal control law is

$$
\begin{equation*}
\phi^{0}(x)=\operatorname{sat}\left[\phi_{L}(x)\right] \tag{35}
\end{equation*}
$$

If $\alpha_{n} \leqq 0$, the origin $x=0$ is reachable from all $x_{0}$; if $\alpha_{n}>0$ the origin is reachable from $x_{0}$ if, and only if,

$$
\left|\phi_{L}\left(x_{0}\right)\right|<1+\left[1+q_{11}\left(c a_{1}\right)^{-2}\right]^{1 / 2}
$$

A proof is given in the Appendix.
Under the conditions of the theorem the optimal control law is of the very simple "dual-mode" form proposed in [1-3].

If $n=1$ the conditions hold trivially.
For $n \geqq 2$ the condition $\operatorname{Re} \alpha_{m}<0(m=1, \ldots, n-1)$ is somewhat restrictive and cannot be relaxed. However, it is always possible to choose $\mathbf{Q}$ such that (iii) is satisfied; for instance, choose real numbers $e_{1}=1, e_{2}, \ldots, e_{n}$ such that

$$
\sum_{j=1}^{n} e, \alpha_{m}^{j-1}=0 \quad\left(n_{i}=1, \ldots, n-1\right)
$$

snd put

$$
q_{i y}=e_{i} e_{j} \quad(i, j=1, \ldots, n)
$$

If the conditions of the theorem are satisfied, then as $c \rightarrow 0$, the strip $\left|\phi_{L}(x)\right| \leqq 1$ reduces to the $(n-1)$-dimensional hyperplane $\phi_{L}(x)=0$ and the optimal control law becomes

$$
\phi^{\circ}(x)= \begin{cases}\operatorname{gn} \phi_{L}(x), & \phi_{L}(x) \neq 0  \tag{36}\\ 0, & \phi_{L}(x)=0\end{cases}
$$

Here the control $\phi^{0}(x)=0$ is singular. This case of optimal linear switching has been discussed in [5].

As an application of the theorem let

$$
\begin{align*}
\dot{x}_{1} & =x_{2} \\
\dot{x}_{2} & =x_{1}+u, \quad|u(t)| \leqq 1  \tag{37}\\
J[u] & =\frac{1}{2} \int_{0}^{T}\left(x_{1}^{2}+x_{2}^{2}+c^{2} u^{2}\right) d t \tag{38}
\end{align*}
$$

By (35) the optimal control is

$$
\begin{equation*}
\phi^{0}(x)=-\operatorname{sat}\left[\left\{1+\left(1+c^{-2}\right)^{1 / 2}\right\}\left(x_{1}+x_{2}\right)\right] \tag{39}
\end{equation*}
$$

and the origin is reachable from $x=\left(x_{1}, x_{2}\right)$ provided

$$
\begin{equation*}
\left|x_{1}+x_{2}\right|<1 \tag{40}
\end{equation*}
$$

The results, for $c=1$, are shown in Fig. 7.
As $c \rightarrow 0$ the strip $L$ in Fig. 7 reduces to the line $x_{1}+x_{2}=0$ and the optimal control law becomes

$$
\phi^{0}(x)=\left\{\begin{array}{l}
-\operatorname{sgn}\left(x_{1}+x_{2}\right), \quad 0<\left|x_{1}+x_{2}\right|<1  \tag{41}\\
0, \quad x_{1}+x_{2}=0
\end{array}\right.
$$

The results for this case are shown in Fig. 8.

## Conclusions

The linear-saturation control law proposed in [1-3] is correct only for special choices of the problem parameters. Sufficient conditions are obtained for validity of this law. In general the optimal control law has three modes; namely, linear, nonlinear, and saturation. Some aspects of the general case have been illustrated with an example. A scheme has been proposed for computing the boundaries of the regions of linear, nonlinear and saturated optimal control. Further research is needed to determine explicit expressions or suitable approximations for the nonlinear control law.

The examples suggest some interesting theoretical problems. One is to obtain a more explicit description of the regions $L$ and $N$. Another is to relate the mode boundaries with the switching surface of time-optimal control.

## Proof of Theorem, Example 3

1 Let $\mathrm{x}=\mathrm{x}(t), \mathrm{p}=\mathrm{p}(t)=-\nabla V_{L}(x(t))$ be a characteristic strip of $V_{L}$. We shall put $e=1$. Then from (20)

& \dot{\mathbf{x}}=\mathbf{A}_{\mathbf{x}}+\langle\mathbf{p}, \mathbf{r}\rangle \mathbf{f}  \tag{42}\\
& \dot{\mathbf{p}}=\mathbf{Q}_{\mathbf{x}}-\mathbf{A}_{\mathbf{p}}^{\prime}
\end{align*}
$$

When $A$ and $f$ are given by (7) the characteristic polynomial of the system (42) is easily found to be

P(\lambda) & =\sum_{1}^{n} \sum_{1}^{n} q_{j k} \lambda^{j-1}(-\lambda)^{k-1} \\
& +\left[\lambda^{n}-\sum_{1}^{n} a_{k} \lambda^{k-1}\right]\left[(-\lambda)^{n}-\sum_{1}^{n} a_{k}(-\lambda)^{k-1}\right] \tag{43}
\end{align*}
$$

Let the zeros of $P(\lambda)$ be $\left(\lambda_{1},-\lambda_{1}\right), \ldots,\left(\lambda_{n},-\lambda_{n}\right)$, where $\operatorname{Re} \lambda_{m}$ $\leqq 0, m=1, \ldots, n$. Actually $\operatorname{Re} \lambda_{m}<0(m=1, \ldots, n)$, for if $\lambda=i \nu$ ( $\nu$ real)

\begin{gathered}
P(i \nu)=\left|\sum_{1}^{n} \sum_{1}^{n} q_{i k}(i \nu)^{i-1}(-i \nu)^{k-1}\right|+\left|(i \nu)^{n}-\sum_{1}^{n} a_{k}(i \nu)^{k-1}\right|^{2} \\
\geqq\left\{\begin{array}{l}
\left|(i \nu)^{n}-\sum_{1}^{n} a_{k}(i \nu)^{k-1}\right|^{2}>0, \quad \nu \neq 0 \\
q_{11}>0, \\
\nu=0
\end{array}\right.
\end{gathered}
$$

Hence the optimal linear control law $\phi_{L}(\mathbf{x})=\langle\boldsymbol{\gamma}, \mathbf{x}\rangle$ exists; and the optimal linear system is

$$
\begin{equation*}
\dot{x}=A x+\langle\gamma, x\rangle p \tag{44}
\end{equation*}
$$

with eigenvalues $\lambda_{1}, \ldots, \lambda_{n}$.
2 It will first be shown that the set $L$ coincides with the strip $|\langle\gamma, x\rangle| \leqq 1$. Equivalently,

\langle\boldsymbol{\gamma}, \dot{\boldsymbol{x}}\rangle<0 \quad(\text { or }>0) \tag{45}
\end{equation*}
$$

if

\langle\gamma, x\rangle=+1 \quad(\text { or }-1) \tag{46}
\end{equation*}

where $\dot{x}$ is given by (44).
From (34) and (43)

\begin{align*}
P(\lambda)= & q_{11}\left(\alpha_{1} \ldots \alpha_{n-1}\right)^{-2} \prod_{1}^{n-1}\left(\lambda-\alpha_{m}\right)\left(-\lambda \cdots \alpha_{m}\right) \\
& +\prod_{1}^{n}\left(\lambda-\alpha_{1 m}\right)\left(-\lambda-\alpha_{m}\right) \\
= & \left(\lambda-\lambda_{n}\right)\left(-\lambda-\lambda_{n}\right) \prod_{1}^{n-1}\left(\lambda-\alpha_{m}\right)\left(-\lambda-\alpha_{m}\right) \tag{47}
\end{align*}
$$

where

$$
\begin{equation*}
\lambda_{n}=-\left.\left|\alpha_{n}\right| a_{1}\right|^{-1}\left(a_{1}^{2}+q_{11}\right)^{1 / 2} \tag{48}
\end{equation*}
$$

and we have used the fact that

\left|a_{1}\right|=\left|\alpha_{1} \ldots \alpha_{n}\right| \tag{49}
\end{equation*}
$$

Thus, from (47)

\lambda_{m}=\alpha_{m}, \quad m=1, \ldots, n-1 \tag{50}
\end{equation*}
$$

Since $\lambda_{1}, \ldots, \lambda_{\mathrm{s}}$ are the eigenvalues of the system (44), we have also

\lambda_{m}^{n}-\sum_{k=1}^{n}\left(a_{k}+\gamma_{k}\right) \lambda_{m}^{k-1}=0, \quad m=1, \ldots, n \tag{51}
\end{equation*}

Hence by (50)

\sum_{k=1}^{n} \gamma_{\lambda} \alpha_{m}^{k-1}=0, \quad m=1, \ldots, n-1 \tag{52}
\end{equation*}

A simple calculation from (48), (50), and (51) shows that $q_{11}>0$ implies $\gamma_{n} \neq 0$. From (52) we now have the identities

where $\gamma_{0} \equiv 0$. Also from (47) and (51)

\lambda^{n}-\sum_{1}^{n}\left(a_{k}+\gamma_{k}\right) \lambda^{k-1}=\left(\lambda-\lambda_{n}\right) \prod_{1}^{n-1}\left(\lambda-\alpha_{m}\right) \tag{55}
\end{equation*}

On combining (53)-(55) it now follows that

\sum_{k=1}^{n}\left[\gamma_{k-1}+\gamma_{n}\left(a_{k}+\gamma_{k}\right)\right] \lambda^{k-1}=\lambda_{n} \sum_{1}^{n} \gamma_{k} \lambda^{k-1}

From (56) we have

\langle\gamma, \dot{x}\rangle=\lambda_{n}\langle\gamma, x\rangle \tag{57}
\end{equation*}

for all $x$ in $L$. Since $\lambda_{n}<0$, (46) implies (45), as was to be shown. 3 It will now be shown that

To this end the original optimization problem will be reduced to an equivalent problem for a system of first order. $\mathrm{B}_{y}(34)$, (52), and a slight extension of the results in Section 5 of [5] we can write

where $V_{0}$ is a homogeneous quadratic form in $x_{i}, \ldots, x_{n-1}$. Let

It is seen now that the original problem is equivalent to that of minimizing

Substitution of (48), (66), and (67) into (65) gives the desired result.

The second statement of the theorem can be verified easily from (62) and (66). This completes the proof.
