# (57) **ABSTRACT**

*An* interferometer having a light beam source that produces a plurality of separate and distinct wavelengths of light. Optic fibers are used to transport the wavelengths of light toward an object surface and to allow light reflected from the object to pass through a polarizer to improve the polarization ratio of the reflected light to determine a characteristic of the object surface.

## **OPTICAL DEVICE FOR MEASURING A SURFACE CHARACTERISTIC OF AN INTERFEROMETRY OBJECT BY MULTI-COLOR**

This invention was made with government support under contract NCC 3419 awarded by NASA.

The invention relates to the art of interferometry, and more particularly to multi-color interferometry for measuring the position of the surface of a solid or liquid object.

#### BACKGROUND OF THE INVENTION

Interferometers are widely used for measuring the profiles of smooth surfaces. In these devices, interfering beams are reflected from different areas on a solid surface and interferometric techniques are used to detect variations in surface height by measuring the path differences between the two interfering beams as the beams are moved across the solid surface. The interferometry transforms phase information encoded on a beam of coherent light into an intensity  $_{20}$ modulation that can be detected by conventional "squarelaw" detectors. The encoded information is typically a representation of fringes, in time or space, whose repeat frequency is determined by the period of one cycle of the optical wavelength. The fringe separation can be scaled somewhat by the geometry of the apparatus, but in general one fringe cannot be distinguished from another. **As** a result, it is not practical to identify a single fringe uniquely. This problem can be partially remedied when the bandwidth of the light is selected to give the highest contrast in the  $_{30}$ "zero-order'' fringe, and which the contrast is reducing in either direction. If the contrast of the fringe reduces rapidly enough to give unambiguous identification, the distance over which a useful measurement can be discriminated is proportionally altered (i.e. reduced or increased).

In addition to the fringe detection problems, typical interferometers are notoriously difficult to keep stable. Since the optical paths of light in different routes are the source of the desired measurement, any differences arising from accuracy. These include mechanical vibration; thermal expansion; intensity modulation; birefringence effects; spatial and temporal coherence reduction; optical, mechanical and/or electronic drift; and/or other unanticipated operational problems.

Previous interferometers have been able to measure relative surface displacements over a limited range. This has made it impossible to contour surfaces containing steps or other discontinuities. Previous interferometers have also used bulk optics for guiding and mixing the light. Bulk 50 optics suffer from alignment, stability and fringe contrast problems.

In view of the deficiencies of present interferometers used to measure relative surface displacement, there is a need for stability and fringe contrast problems, and can measure relative surface displacements over a larger range than heretofore.

#### SUMMARY OF THE INVENTION

The present invention relates to an improved apparatus and method of measuring surface characteristics of solids and liquids, and more particularly, to a multi-color interferometer that measures the absolute displacement and contouring of a solid or liquid.

The invention overcomes the problems associated with alignment, stability and fringe contrast, and provides useful

performance in a range of applications and environments not formerly accessible. The invention significantly expands the applicability of an interferometer by overcoming the restricted dynamic range arising from the inability to distinguish between adjacent "fringes", either in time or space. The dynamic range is typically restricted to the physical parameter represented by a single fringe in any given geometry. By shifting the fringe in time or space, the directional ambiguity can be resolved and the dynamic range can be extended by keeping count of fringes as they pass,  $10<sup>10</sup>$ thus increasing the relative dynamic range. However, fringe shifting alone cannot overcome the problems resulting from the temporary loss of a fringe which occurs by a discontinuity in the measured quantity, i.e. a step in the surface of a solid object.

In accordance with one aspect of the present invention, there is provided an interferometer that utilizes a plurality of wavelengths to measure the surface characteristics of a solid or liquid such as, but not limited to, the position of the surface of the solid or liquid. The dynamic range of the interferometer is increased by the inclusion of multiple colors of monochromatic radiation into the same optical path. Preferably, three colors are used; however two colors are sufficient to exploit advantages of the improved <sub>25</sub> interferometer, and more than three colors can produce various advantages in certain applications. The use of a plurality of colors enables the interferometer to obtain absolute displacement measurements. Preferably, the colors used in the interferometer are formed by three single lon-*30* gitudinal mode lasers of three different coherent emission wavelengths. **As** can be appreciated, other types of lasers can be use (i.e. the use of one or more modulated lasers that generate a plurality of wavelengths. When three or more wavelengths of light are used, two of the wavelengths 35 preferably have a similar, but not exact, frequency and at least one of the remaining wavelengths has a wavelength frequency that is significantly different from the two wavelengths of light having a similar frequency. By selecting such a wavelength frequency relationship, the dynamic effects other than that to be measured are ruinous to the  $40$  range of the interferometer is significantly increased. Preferably the wavelengths of light are selected from the visible range; however, one or more wavelengths can outside the visible light range.

In accordance with another aspect of the present 45 invention, there is provided an interferometer that is able to detect the change in the direction of displacement of the surface of a solid or liquid as the solid or liquid is passed through an interference node. The detected change in direction of displacement is accomplished without the need of sophisticated and expensive acoustic optic modulators. The interferometer is designed to determine the direction of motion by taking the ratio of the intensities of the fringes of the different colors of light used by the interferometer. By selecting wavelengths that are not integer multiples of one an interferometer that is simple to use, overcomes past 55 another, the relative amount of intensity for each wavelength of light will have a different proportion on each side of the fringe node that arises from each wavelength of light. In addition, not all of wavelengths of light simultaneously pass through the intensity node at the same time. The fringes for 60 each wavelength of light are thus formed by the light which is returned from the surface and then mixed with light of the same wavelength from the coherent laser which produced the particular wavelength.

> In accordance with still another aspect of the present 65 invention, there is provided an interferometer that includes the use of optics to improve the detection of fringe contrast. In one preferred embodiment, monomode optics are incor

porated into the interferometer and at least partially function as low-pass spatial filters. The monomode optics allow the fringe contrast between light and dark fringes to approach their theoretical limit. One preferred monomode optic that can be used, but is not limited to, are single-mode optical  $\frac{1}{5}$ fibers.

In accordance with yet another aspect of the present invention, there is provided an interferometer that includes a diffraction grating. The diffraction grating allows multiple wavelengths to be launched from optics onto a fluid or solid surface. In one preferred embodiment, the diffraction grating is transparent. In another preferred embodiment, the diffraction grating causes light passing through the diffraction grating to be approximately co-extensive and propagate in substantially the same direction. In yet another preferred embodiment, the diffraction grating is used to launch more than one wavelength into one or more optic fiber. One such optic fiber can be a singlemode polarization preserving fiber; however, other types of optical fibers can be used. In another preferred embodiment,  $_{25}$ the diffraction grating is used to split the returned wavelength, which are made of a superposition of the incident wavelengths into their respective wavelength, The split wavelength can then be efficiently launched into individual optical fibers (i.e. single-mode polarization preserving fibers) by use of graded index (GRIN) lenses micro-lenses. will be later mixed with the returned wavelength. The wavelength of light from the initial launch fiber is directed into a GRIN lens or a microlens, which forms a collimated beam of light. The collimated beam is directed into a diffraction grating where the beam is rendered substantially collinear with the different wavelengths of light from the other fibers. The collimated beam from the diffraction grating is directed into a polarizing cube beam splitter. The beam splitter efficiently reflects the income wavelengths of light. The reflected lights is passed through a quarter-wave  $_{10}$ retarder which produces a circular polarization of the light. The light is then focused through one or more lenses on to the surface of either a liquid or solid. The quarter-wave plate does not perfectly circularize all the wavelengths of the light, but is sufficient for the polarizing cube beam splitter to  $15$ function as an acceptably effective optical diode. The light that is reflected by the solid or liquid is circularly polarized in the opposite direction from the incident light. The direction of its linear polarization after a second passage through the quarter-wave plate is orthogonal to that of the incident  $_{20}$ light, and hence is predominately transmitted through the polarizing beam splitter, thereby taking a different path from the incident beam. The light then passes through a GLAN prism into a diffraction grating which is substantially identical to the diffraction grating used on the input beam. The GLAN prism improves the polarization ratio of all the wavelengths of the light. The improved polarization ratio allows for significantly accurate alignment of the polarization direction with the polarization-maintaining axis of each fiber, thereby reducing or preventing small movements or  $30$ temperature fluctuations of the fibers from causing intensity fluctuations of the transmitted single-mode light. The light in each fiber is coherently mixed in each fiber coupler with the light which was earlier split off. The combined light results in interferometric beating. The beating is analyzed by coherently homodyning the optical modulation on the reflected beam down to a frequency that can be detected electronically by avalanche photo-diode detectors, pin diodes, and/or photo-multiplier tubes. The relative position of the surface with respect to the interferometer causes the single fringe  $_{40}$ visible by each detector to register and the intensity ranges from light to dark. 3s

The improved interferometer has several advantages over prior interferometers. The improved interferometer can make absolute displacement measurements when using two 4s or more wavelengths of light. The improved interferometer does not require expensive acousto-optic modulators to determine when the direction of displacement has changed as the moving surface is passing through an interference node. The direction of motion can be determined by taking so the ratio of the intensities of the fringes of the different wavelengths of light used. The improved interferometer preferably includes single-mode fiber optics which act as low-pass spatial filters, and which allows the fringe contrast between light and dark fringes to approach its theoretical 55 limit. The improved interferometer is designed to launch more than one wavelength of light from the fibers onto a fluid or solid surface by using a diffraction grating. This technique can also be used to launch more than one wavelength of light into a single-mode polarization preserving fiber. The diffraction grating can be used to split the returned light (which is a superposition of the incident wavelengths) into their respective wavelengths of light and then efficiently launch these wavelengths of light into individual singlemode polarization preserving fibers by use of graded index (GRIN) lenses or micro-lenses. The improved interferometer also preferably includes a polarizer positioned in the

return light path before the optical fibers to ensure that the polarization of the light entering the fibers is aligned to the polarization axis of the receiving fibers at a ratio of at least about 100:1, thereby ensuring that movements of the fibers minimize or do not cause fluctuations in the intensity of the signal along the axis of interest. **As** can be appreciated, the polarizers can be used with a single wavelength for relative displacement interferometry to improve the accuracy of the measured signals.

The principal object of the present invention is to provide a method and apparatus that can accurately measure contoured surfaces.

It is another object of the present invention to provide an interferometer that can measure relative surface displacements over a wide range.

It is still another object of the present invention to provide an interferometer that can measure contoured surfaces that include steps and/or discontinuities.

It is yet another object of the present invention to provide an interferometer that reduces undesired intensity fluxua-*'O* tions.

It is still yet another object of the present invention to provide that reduces the effects of fringe contrast problems.

It is another object of the present invention to provide a multi-wavelength interferometer to measure contoured sur-<br>
<sup>25</sup> faces.

It is yet another object of the present invention to provide an interferometer which is absent expensive acousto-optic modulators.

It is still another object of the present invention to provide *30* an interferometer that includes fiber optics to detect the reflected beams of light.

It is still yet another object of the present invention to provide an interferometer that includes polarizers to increase measurement accuracies.

It is another object of the present invention to provide an interferometer that includes a grating arrangement to permit multiple wavelength beam combination and separation.

It is still another object of the present invention to provide an interferometer that incorporates cross and/or triple correlation to process data to measure contoured surfaces.

It is still yet another object of the present invention to provide an interferometer having polarization preserving optical fibers to improve the performance of the interferometer.

It is another object of the present invention to provide an interferometer that monitors and/or compensates for the fiber length of the optics used in the interferometer.

It is yet another object of the present invention to provide an interferometer that can separate two or more wavelengths that are very close together.

It is yet another object of the present invention to provide an interferometer that can measure small changes in the fiber length.

It is yet another object of the present invention to provide an interferometer that can increase the phase sensitivity of the interferometer.

It is still yet another object of the present invention to provide an interferometer that reduces detector dead time  $60$  effects.

It is still yet another object of the present invention to provide an interferometer that minimizes sources of noise not intrinsic to the scattered light.

It is still yet another object of the present invention to provide an interferometer that accurately measures contoured surfaces, is simple to operate and is economical to manufacture.

#### BRIEF DESCRIPTION OF THE DRAWINGS

Reference may now be made to the drawings, which illustrate various embodiments that the invention may take in physical form and in certain parts and arrangements of parts wherein;

FIG. **1** is a schematic representation of the three-color interferometer for displacement measurement and contouring of solid surfaces in accordance with the present invention;

#### DETAILED DESCRIPTION OF THE PREFERRED EMBODIMENT

The light from each of the three lasers **10, 20, 30** is launched respectively into three optic fibers **40,50, 60.** The optic fibers preferably include single-mode polarization preserving fibers of substantially identical type. Several types of fibers which can be used include step- or graded index core, stress birefringence, "bow-tie", or some other similar construction that achieves the required optic properties. **As**  shown in FIG. **1,** each of optic fibers **40,** *50,* **60** are Passed through wave couplers **70, 80, 90.** The wave couplers are designed to extract a portion of the transmitted laser light energy that is passing through optic fibers 40, 50, 60. Preferably, the wave couplers are coherent evanescent wave couplers and extract only a small amount of the laser light energy being transmitted in the optic fibers. and spatially coherent, for interaction with the surface of object B to be measured. **As** shown in FIG. **1,** the light beams are focused onto the surface of object B. Preferably, lens **220**  is positioned about 100 mm from the surface of object B; however, other distances can be used. Object B is a solid or semi-solid object as shown in FIG. **1,** and a liquid as shown in [FIG.](#page-2-0) **2. As** illustrated in FIG. **2,** liquid B is maintained in a container C. Referring again to FIG. **1,** the focused light beams contact the surface of object B and a portion of the light beams is reflected back through lens **220.** Lens **220**  preferably reconfigures the reflected or scattered light **230, 240, 250** to have geometrical properties that are analogous to the properties of light beams **170, 180, 190.** Due to the essential reciprocality of the Van Cittert-Zemike relationship, the collection aperture will include typically only one 'speckle' and thus retain high contrast modulation of the collected light. The wave-front conditioning device could include a single run of optical-fiber having similar properties as the optical-fibers in optic fibers **40,50,60.** This type of wave-front conditioning device is particularly useful if the probed sample is inaccessible or in regions of a high magnetic field; (i.e. where electronic component performance would be impaired). **As** can be appreciated, this configuration may cause differential dispersion between the three wavelengths, and thus may require compensation.

Referring again to FIG. **1,** the collected reflected light **230, 240, 250** passes through lens **220** and through optical retarder **210.** The optical retarder restores the linearity of polarization of reflected light **230, 240, 250.** The restored linearity of the reflected light enables the reflected light to pass through the polarization sensitive beamsplitter **200**  without being reflected by beamsplitter **200.** 

The reflected light **230,240,250** upon leaving beamsplitter **200** passes through GLAN prism **225.** GLAN prism **225**  improves the polarization ratio of the reflected light to  $_{35}$ permit sufficiently accurate alignment of the polarization direction with the polarization-maintaining axis of each optic fiber to prevent small movements or temperature fluctuations of the optic fibers from causing intensity fluctuations of the transmitted single-mode. Preferably the GLAN prism is a modified GLAN Thompson polarizer which increases the polarization ratio of the fiber input and/or output.

The reflected light which passes through the GLAN prism passes into a diffraction grating **260.** The diffraction grating is selected to be substantially the same or identical to diffraction grating **160.** The diffraction grating is designed to deflect the reflected light into lenses **270, 280, 290.** The lenses are preferably GRIN lenses having substantially the same properties as GRIN lenses **100,110,120.** The reflected light passes through the GRIN lenses into optic cables **300, 310, 320.** The optic fibers preferably have substantially the same properties as optic fibers **40, 50, 60.** The single-mode properties of the optic fibers permit only a zero-order transverse mode to propagate through the fiber, thus forcing 55 the satisfaction of the van Cittert-Zemike relationship. The permitting of only a zero-order transverse mode to propagate through the fiber maximizes the contrast of coherent interference.

Optic fibers **300, 310, 320** direct the reflected light to wave couplers **90,80,70,** respectively. Most of the reflected light that is transmitted through optic cables **300, 310, 320**  is coherently mixed with the portion of light that was extracted from optic fibers **40,50, 60.** Although the amount of light that is extracted from optic fibers **40, 50, 60** is 65 and their separations. typically only a small amount, this small amount is nevertheless much larger than the amount of transmitted reflected

light. **A** typical ratio for good homodyne amplification is about **100** to **1000,** although ratios outside this range are acceptable. After the reflected light is passed through the wave couplers, the light is directed by optic fibers **300**, **310**, 5 **320** to detectors **330, 340, 350,** respectively. The detectors preferably include avalanche photo diodes; however this type of detector is not required since individual quantum detection is not essential in a system whose detected intensity is amplified by homodyne gain. The "shot noise", which is actually the inevitable quantization of the scattered optical field, cannot be substantially improved, even under the semi-classical approximation. However, the detection level has now been raised so that "shot noise" is the only significant source of noise, provided that the laser "noise" is sufficiently low and the following electronics are carefully designed and constructed.

By comparing the relative phases of the three wavelengths of laser light, the optical path length may be determined within the lowest common multiple of the three wavelengths. The exact and absolute position may easily be *<sup>20</sup>*determined against a calibrated reference that is immune to temporary loss of signal, for whatever reason. Preferably, the received signals are processed in circuit **355,** such as a computer, by cross and/or triple correlation to optimize signal processing efficiency, speed, sensitivity and immunity 25 to noise.

In general, the optical fibers are installed to have a common run so that all changes in length or properties are substantially the same for all fibers. In cases where it is impractical to maintain the same fiber length and/or same *3o* optic properties, the fiber lengths can be adjusted; using for example a piezoelectric mandrel around which each fiber is wrapped as part of its run.

Referring now to FIG. **3,** an arrangement for creating an error signal for an active control system is disclosed. **As**  shown in FIG. 3, the error signal is obtained by using a fourth laser **360.** Laser **360** preferably generates a wavelength of light that is different from the wavelengths of light from lasers **10,20,30.** Laser **360** directs light into an optic fiber **370.** The optic fiber is designed so that both fiber ends 40 include a reflective coating **380. A** wave coupler **390** and light detector **400** are also included in the system. The wave coupler is preferably similar to wave couplers **70,80,90** and detector **400** is preferably similar to detectors **330,340,350.**  The error signal system preferably is temporally coherent to the extent necessary to stabilize the fiber length, and also should be within a factor of two of the wavelengths of light from the laser for which the fiber is single mode. The stabilization can be held within a very small fraction of a fringe, but can become ambiguous under length changes of so more than one half wavelength of light of the fourth laser. **As**  can be appreciated, other error signal system arrangements can be used.

The maximum dynamic range covered by using two adjacent emission lines of the order of tens of GHz apart of a laser diode is of the order of a few centimeters or tens of centimeters. **A** third laser wavelength, somewhat further separated, permits a subdivision of the full dynamic range into small segments. For example, a conservative estimate of the measurement accuracy of phase is about 1% (more reasonable  $0.1\%$  is achievable), permitting the division of the few centimeters of dynamic range into either about one micron, in the first case, or about 10 nm in the second case. **A** dynamic range of a million is thus readily possible over a range that is determined by the choice of laser wavelengths

The invention described herein provides a hardware design which will make it possible to make absolute dis-

placement measurements in the sub-nanometer to meter range. It may be applicable to coordinate measuring machines, especially where physical contact with the surface is undesirable. This technique is also applicable where the surface in question is inaccessible, soft, chemically reactive or has an extremely high or low temperature. Because of the extreme dynamic range and resolution of the measurements by the interferometer, a simple and robust implementation is also directly applicable from civil engineering to nanotechnology.

The invention has been described with reference to a preferred embodiment and alternatives thereof. It is believed that many modifications and alterations to the embodiments disclosed will readily suggest itself to the those skilled in the art upon reading and understanding the detailed description of the invention. It is intended to include all such modifications and alterations insofar as they come within the scope of the present invention.

We claim:

**1.** *An* optical device for measuring a surface characteristic of an object comprising:

- a. a light beam source that produces light;
- b. an optic fiber to transport said light;
- c. a wave coupler to extract a portion of said light from said optic fiber;
- d. a polarizing beamsplitter to deflect said light emanating  $25$  ment and contouring of an object surface comprising: from said optic fiber to said object surface and to allow light reflected from said object to pass through said beamsplitter in a substantially unaltered manner;
- e. an optical retarder creating circular polarization on said emanating light; and
- f. a secondary light beam source producing a wavelength of light that is transmitted in a secondary optic fiber to produce an error signal to compensate for the length of said optic fiber and said return optic fiber.

**2.** *An* optical device as defined in claim **1,** wherein said 35 light beam source includes a plurality of lasers, each of said lasers producing a light having a separate and distinct wavelength.

**3.** *An* optical device, as defined in claim **2,** wherein said light beam source includes a first, second and third laser, 40 said first and second lasers producing light having closely spaced wavelengths, said third laser producing light having a wavelength widely spaced from said wavelengths of light from said first and second lasers, said wavelengths of light from said three lasers being non-integer multiples of one 4s another.

**4.** *An* optical device as defined in claim **1,** wherein said optic fiber being a monomode polarization preserving optic fiber.

5. An optical device as defined in claim 1, wherein said 50 optical retarder being a quarter wave optical retarder.

**6.** *An* optical device as defined in claim **1,** including a GRIN lens to at least partially culminate said emanated light.

**7.** *An* optical device as defined in claim **6,** wherein said GRIN lens is connected to an end of said optic fiber.

**8.** *An* optical device as defined in claim **1,** including a diffraction grating to at least partially align said emanated light onto said beamsplitter.

**9.** *An* optical device as defined in claim **1** including a lens positioned between said optical retarder and said object to focus said emanating light to a narrow point on said object.

**10.** *An* optical device as defined in claim **1,** including a GLAN prism to improve the polarization of said reflected light.

**11.** An optical device as defined in claim **1,** including a 65 fiber. return optic fiber to receive reflected light and to transport said reflected light to a detector.

**12.** *An* optical device as defined in claim **11,** including GRIN lens positioned at least closely adjacent to said return optic fiber to at least partially culminate said reflected light.

**13.** *An* optical device as defined in claim **11,** including a diffraction grating to at least partially align said reflected light onto said return optic fiber.

**14.** *An* optical device as defined in claim **11,** wherein said wave coupler combines said extracted light with said reflected light in said return optic fiber.

**15.** *An* optical device as defined in claim **11,** wherein said detector includes at least one light detector selected from the group consisting of an avalanches photo diode, a pin diode, a photo-multiplier tube.

**16.** *An* optical device as defined in claim **11,** wherein said is detector including a plurality of light detectors.

**17.** *An* optical device as defined in claim **11,** including a correlator to cross or triple correlate signals received from said detector.

**18.** *An* optical device as defined in claim **11,** including *20* optic stretchers to increase the phase sensitivity of said return optic fiber.

**19.** *An* optical device as defined in claim **1,** including a Fabry-Perot to separate closely spaced wavelengths.

**20.** *An* optical device for measuring absolute displace-

- a. Alight beam source including three lasers, each of said lasers producing separate and distinct wavelengths of light, said first and second lasers producing closely spaced wavelengths of light, said third laser producing a wavelength of light widely spaced from said light wavelengths of said first and second lasers, said light wavelengths of said three lasers being non-integer multiples of one another;
- b. three optic fibers, said first, second and third optic fibers transporting light from said first, second and third lasers, respectively;
- c. three wave couplers to extract a portion of said light from said first, second and third optic fibers, respectively;
- d. a diffraction grating to receive light emanating from said three optic fibers, said diffraction grating causing said three wavelengths of light to propagate in substantially the same direction after passing through said diffraction grating;
- e. a polarizing beamsplitter to deflect said light passing through said diffraction grating toward said object surface and to allow light reflected from said object to pass through said beamsplitter in a substantially unaltered manner;
- f. an optical retarder to circularly polarize said light prior to contacting said object;
- g. a GLAN prism to polarize light reflected from said object surface to improve the polarization ration of said ss reflected light;
	- h. three return optic fibers, said first, second and third optic fibers receiving and transporting said first, second and third reflected wavelengths of light, respectively;
	- i. three detectors to detect said reflected light and said extracted light; and
	- j. a correlator to correlate data received from said three detectors.

**21.** *An* optical device as defined in claim **20,** wherein said optic fiber being a monomode polarization preserving optic

**22.** *An* optical device as defined in claim **20,** wherein said optical retarder being a quarter wave optical retarder.

**23.** *An* optical device as defined in claim **20,** including a GRIN lens to at least partially culminate said emanated light.

**24.** *An* optical device as defined in claim **20** including a lens positioned between said optical retarder and said object to focus said emanating light to a narrow point on said 5 object.

**25.** *An* optical device as defined in claim **20,** including GRIN lens positioned at least closely adjacent to said return optic fiber to at least partially culminate said reflected light.

**26.** An optical device as defined in claim **20**, including a 10 diffraction grating to at least partially align-said reflected light onto said return optic fiber.

**27.** *An* optical device as defined in claim **20,** wherein said wave coupler combines said extracted light with said reflected light in said return optic fiber.

**28.** *An* optical device as defined in claim **20,** including a correlator to cross or triple correlate signals received from said detector.

**29.** *An* optical device as defined in claim **20,** including optic stretchers to increase the phase sensitivity of said 2o return optic fiber.

**30.** *An* optical device as defined in claim **20,** including a Fabry-Perot to separate closely spaced wavelengths.

**31.** *An* optical device as defined in claim **20,** including a secondary light beam source producing a wavelength of 25 light that is transmitted in a secondary optic fiber to produce an error signal to compensate for the length of said optic fiber and said return optic fiber.

**32. A** method of providing absolute displacement measurements of the surface of an object comprising the steps 30 **Of;** 

- a. providing at least a first and second laser, each of said lasers producing a light having a separate and distinct wavelength;
- b. circularly polarizing said light from said lasers;
- c. providing an optical device which affects light reflected from said object different from non-reflected light;
- d. combining said reflected light with non-reflected light to produce interferometric beating;
- e. analyzing said interferometric beating by coherent homodyning; and
- f. using a secondary laser and an secondary optical fiber to provide error compensation.

**33.** The method as defined in claim **32,** including three lasers, said first and second lasers producing light having closely spaced wavelengths, said third laser producing a light having a wavelength widely spaced from said lights from said first and second lasers.

**34.** The method as defined in claim **32,** wherein said optical device is a polarizing beamsplitter.

**35.** The method as defined in claim **32,** wherein said lights are circularly polarized by a quarter-wave optical retarder.

**36.** The method as defined in claim **32,** including singlemode polarization maintaining optical fibers.

**37.** The method as defined in claim **32,** including a diffraction grating to cause said light from said three lasers to propagate in substantially the same direction.

**38.** The method as defined in claim **32,** including an optical device to improve the polarization ration of said reflected light.

**39.** The method as defined in claim **38,** wherein said optical device is a GLAN prism.

**40.** The method as defined in claim **32,** wherein said step of combining reflected and nonreflected light includes a light wave coupler.

**41.** The method as defined in claim **32,** wherein said step of analyzing includes cross or triple correlating said interferometric beating that is detected by a plurality of detectors.
